Mr. HUSSEY of Augusta: Mr. Speaker, I rise to a point of information. Three resolves that I tabled this morning, Senate Papers 260, 265 and 266 was introduced in the Senate.

The SPEAKER: Two of them bear endorsement "From the Senate, February 2nd, 1933, referred to the committee on Pensions."

Mr. HUSSEY: And I believe that was two days after the lid was on. The SPEAKER: The gentleman

is apparently correct. Mr. HUSSEY: May I at this point state why I tabled these resolves?

The SPEAKER: I think it would be entirely out of order at this time. Are there not some other matters under Orders of the Day that can be taken from the table. Tomorrow all these unassigned matters come off automatically, but we apparently are going to have a busy session tomorrow, with some debate, and a good many unassigned matters to come off; so I hope some of these may be taken off this morning. On motion by Mr. Farris of Augusta, it was voted to take from the table the 26th unassigned matter, Joint Order relative to investigation of poultry department of Highmoor Farm, H. P. 1020, L. D. 374, tabled February 2 by that gentleman, pending passage; and on further motion by the same gentleman the Joint Order was referred to the committee on Agriculture.

On motion by Mr. Hobbs of Hope, it was voted to take from the table the 15th unassigned matter, resolve in faver of construction of Georges Valley Pike, H. P. 945, L. D. 282, tabled by that gentleman February 1, pending reference to a committee; and on further motion by the same gentleman the resolve was referred to the committee on Ways and Bridges.

On motion by Mr. Bussey of Dixmont, it was voted to take from the table the third unassigned matter, resolve in favor of E. G. Hodgkins of Carmel, H. P. 364, L. D. 197, tabled by that gentleman January 31, pending reference to a committee; and on further motion by the same gentleman the resolve was referred to the committee on Claims.

On motion by Mr. Farris of Augusta, it was voted to take from the table the 30th unassigned matter, bill an act relating to commitments in bastardy cases, H. P. 876, L. D. 377, tabled by that gentleman February 2, pending reference to a committee; and on further motion by the same gentleman the bill was referred to the committee on Judiciary.

On motion by Mr. Farris of Augusta, it was voted to take from the table the 16th unassigned matter, bill on act relating to health certificates for teachers and janitors S. P. 207, L. D. 295, tabled by that gentleman February 2, pending reference in concurrence; and on further motion by the same gentleman the bill was referred to the committee on Education in concurrence.

On motion by Mr. Farris of Augusta it was voted to take from the table the 17th unassigned matter, bill an act providing for the establishment of a State Experimental Fur Farm, S. P. 145, L. D. 396, tabled by that gentleman February 2, pending reference in concurrence;

and on further motion by the same gentleman the bill was referred to the committee on Inland Fisheries and Game in concurrence.

On motion by Mr. Farris of Augusta, it was voted to take from the table the 18th unassigned matter, bill an act relating to inland fish and game wardens; powers, duties and service of processes, S. D. 597, tabled by that gentleman February 2, pending reference in concurrence; and on further motion by the same gentleman the bill was referred to the committee on Inland Fisheries and Game in concurrence.

Portland, Maine, February 2, 1933.

To Honorable Louis J. Brann, Governor and the Senate and House of Representatives of the Eighty-Sixth Legislature of the State of Maine:

On March 3, 1931 I conveyed by Deed of Gift to the State of Maine an undivided three-eighths (3-8) interest in a tract of land located in Township three (3) Range nine (9) W.E.L.S. Piscataquis County (Mt. Katahdin) which, had the township been divided according to the fractional interests then outstanding, would have amounted to an area of six (6) square miles and this gift and conveyance was accepted, subject to the conditions therein imposed, by Act of the Legislature approved by the Governor on March 4, 1931 (Private and Special Laws of 1931, Chapter 23). Subsequent to the conveyance and to the passage of the Act above

Subsequent to the conveyance and to the passage of the Act above mentioned a division of the Township was effected under which the former undivided interests were consolidated into separate and distinct ownerships, and this enabled me to complete and enlarge my Gift to the State. On October 7, 1931 I thereupon completed the former Gift and at the same time conveyed to the State an additional area slightly in excess of three (3) square miles which additional area when added to that first conveyed gave the State full title and ownership to an area of nine (9) square miles in said Township. This second conveyance was accepted by the State on October 7, 1931 by Hon. Neil L. Violette, Forest Commissioner, approval being given thereto by Governor William T. Gardiner and the Executive Council and by Hon. Clement F. Robinson, Attorney General, all of them acting under authority conferred upon them by Sections fifteen (15) and sixteen (16) of Chapter eleven (11) of the Revised Statutes of 1930. In order that the total area of

In order that the total area of nine (9) square miles or to be more exact about 5,960 acres, conveyed to the State by the two (2) Deeds above referred to shall finally be accepted by the Senate and House of Representatives directly representing the People of the State and shall be approved by the Governor, I have prepared and submit herewith an Act of the Legislature which I request your Honorable bodies to enact into law and your Excellency to approve. The description of the area and the conditions of the Gift are the same as in the two original conveyances. The passage of this Act makes the acceptance of the two Gifts above mentioned somewhat more formal and complete and it is this that I seek to accomplish.

On motion by Mr. Friend of Skowhegan, it was voted to take from the table the 20th unassigned matter, bill an act to incorporate Sandy River Log Driving Company, S. P. 219, tabled by that gentleman February 2, pending reference in concurrence; and on further motion by the same gentleman the bill was referred to the committee on Judiciary in concurrence. On motion by Mr. Quine of Bangor, it was voted to take from the table the second unassigned matter, bill an act relating to the charter of the city of Bangor, H. P. 218, L. D. 125, tabled by that gentleman January 26th, pending reference to a committee; and on further motion by the same gentleman unanimous consent was given him to withdraw the bill from further consideration.
