The Chair lays before the House as the second matter of unfinished business bill an act to grant a new charter to the city of Bangor, H. P. 860, L. D. 302, tabled on February 1st by the gentleman from Bangor, Mr. Piper, pending reference to a committee; and the

Chair recognizes that gentleman.
Mr. PIPER: Mr. Speaker, I move
that the bill be referred to the

committee on Judiciary.

Miss MARTIN of Bangor: Mr. Speaker, I hope that the motion of the gentleman from Bangor, Mr. Piper, will not prevail. He is asking to have this bill sent to the Judiciary committee because, as he told me, he wanted an impartial viewpoint passed upon that subject, and he felt that I did not have sufficient influence with the rest of the committee so that an impartial hearing would be possible. Under our system here in the House we do not regard our committees as juries. We regard them as sources of information, otherwise we would not be sending our lobster bills to the Sea and Shore Fisheries. To follow that system to a conclusion, we may as well send all our agricultural bills to the Sea and Shore Fisheries or the Pownal State School for instance.

This is a matter of vital interest to Bangor. On this Legal Affairs committee, two of us are from Bangor. Not only has this committee considered charters before but it has considered this one before. Since it is a matter concerning Bangor, I feel that I know conditions in Bangor as well as anyone in the House, I trust this motion of the gentleman from Bangor, Mr. Piper, to refer this bill to the Judiciary committee will not prevail.

ciary committee will not prevail.

Miss LAUGHLIN of Portland:
Mr. Speaker, in view of the very
large number of bills going to the
Judiciary committee, and in view of
the fact that all charter bills so
far have gone to the Legal Affairs
committee, which now ought to be
expert on charter matters, I hope
that this bill will not be sent to
the committee on Judiciary and
that the motion of the gentleman
from Bangor, Mr. Piper, will not
prevail.

Mr. PIPER: Mr. Speaker, I had hoped that I would not have to refer to any personal conversations here, and unless I thought I had sufficient cause I would not make a motion of this kind. But the proponents of this charter desire to be given a fair hearing in this Legislature

So far as the conversation which has been carried on between me and the lady member from Bangor (Miss Martin) is concerned, she informed me first that she was elected by the people who opposed this charter and that she was going to do everything she could to defeat it in this Legislature. The proponents of this charter have no declared enemies on the Judiciary committee. They do not want this matter stranded in the committee if it is possible to prevent it. The proponents of this measure are just wishing for fair play, that is all. I hope that you will give the citizens of Bangor—a great many fine reputable citizens who desire a chance to be heard—a chance to be heard—a chance to be heard—before unprejudiced ears. I am simply asking that this bill be referred to a committee that will give it a fair hearing, and a fair report, that is all.

Mr. QUINE of Bangor: Mr. Speaker, as a citizen of Bangor, a

Representative and member of the Legal Affairs committee, I respectfully ask that this bill be referred to the Judiciary committee. This is an important matter to the people of Bangor and the only thing they want is a fair and impartial hearing which we feel we cannot get before the Legal Affairs committee. I respectfully ask you members of this Legislature to give the people of Bangor a fair hearing on this bill. It is a matter of importance to the people of Bangor.

Mr. O'CONNOR of Bangor: Mr. Speaker, I believe, with my colleague from Bangor, Mr. Piper, that this bill should go to the Judiciary committee.

Mr. SARGENT of Brewer: Mr. Speaker, I am a member of the Legal Affairs committee and I resent the remark that this charter, if it went to the Legal Affairs committee, would not be given an impartial hearing. For myself I am open minded in the matter, and I think our committee will give it just as impartial a hearing as would the committee on Judiciary. I hope the motion of the gentleman from Bangor (Mr. Piper) will not pre-

Mr. GOUDY of So. Portland: Mr. Speaker, I do not like to enter into other people's debates but I feel called upon at this time to say this to the members of the House. I served last year with the member from Bangor, Miss Martin, and with Mr. Sargent on the Legal Affairs committee. If anybody in this House thinks that this bill, or any other bill, would not receive fair treatment at their hands, I feel that they are mistaken. The member from Bangor, Miss Martin, as a member of the Legal Affairs committee, was always fair, square, upright and honest on any bill or on any question that came before the Legal Affairs committee; and I am here at this time testifying to her integrity and honesty of purpose in all matters that came before our committee and I believe this applies to all matters that will ever come before any committee that she is on (Applause)

The SPEAKER: The question is on the motion of the gentleman from Bangor, Mr. Piper, on bill an act to grant a new charter to the city of Bangor; on which bill the committee on reference of bills suggested that it be referred to the committee on Legal Affairs but

which the gentleman from Bangor, Mr. Piper, now moves to refer to the Judiciary committee. All those in favor of the motion to refer this bill to the Judiciary committee will saye aye, contrary minded, no.

A viva voce vote being doubted,

A division of the House was had.

Sixty-six voting in the affirmative and 59 in the negative, the motion of the gentleman from Bangor, Mr. Piper, that the bill be referred to the committee on Judiciary prevailed.

On motion by Mr. Hussey of Augusta it was voted to take from the table the third unassigned matter, resolve for teacher's pension for Mrs. Elsie T. McKenney, S. P. No. 266, tabled by that gentleman February 7, pending reference in concurrence; and on further motion by the same gentleman the resolve was referred to the committee on Pensions in concurrence.

On motion by Mr. Cook of Pitts-field it was voted to take from the table the fourth unassigned matter, bill an act relating to State aid to academies, H. P. 1076, tabled by that gentleman February 7, pending reference; and on further motion by the same gentleman unanimous consent was given him to withdraw this resolve, and the resolve was withdrawn.

On motion by Mr. Russ of Woodstock, it was voted to take from the table the fifth unassigned matter, bill an act relating to bounty on bears, H. P. 1027, L. D. 461, tabled by that gentleman February 7 pending reference; and on further motion by the same gentleman the bill was referred to a Joint committee composed of the two committees of Inland Fisheries and Game and Agriculture.

Mr. FARRIS of Augusta: Speaker, I move that the House re-consider its action whereby it passed an order this morning inviting the Senate to a Joint Convention next Thursday afternoon. I will say in this connection that the Budget Committee is now having hearings and is not ready for a public hearing

The SPEAKER: As the Chair understands it, the order had a passage, and its terms were complied with. Therefore, the matter is finished so far as the House is concerned. The Clerk did what the order requested him to do, that is,

conveyed a message to the Senate, and that is all the order provided for. As the Chair understands it, the House did not even vote to have a Joint Convention, but merely voted to convey a message to the Senate proposing a Joint Convention.

Mr. FARRIS: Mr. Speaker, then the effect of the order is just an invitation. Is that it?
The SPEAKER: That is the way

the Chair understands it.

Mr. FARRIS: And is dependent on the Senate accepting the invitation?

The SPEAKER: That is also correct. It is a matter of common knowledge that proposals for Joint Conventions, so far as the Clerk knows, and as he has informed me, invariably come from the Senate.

Are there any other matters under Orders of the Day which can be cleaned from the calendar?

On motion by Mr. Tompkins of Houlton, it was voted to take from the table the seventh unassigned matter, bill an act relative to the proof and determination of foreign law, H. P. 1040, L. D. 460, tabled by that gentleman February 7, pending reference; and on further motion by the same gentleman the bill was referred to the committee on Judiciary.

On motion by Mr. Tompkins of Houlton, it was voted to take from the table the eighth unassigned matter, bill an act relating to attachments of real estate, H. P. 1041, L. D. 459, tabled by that gentleman February 7 pending reference; and on further motion by the same gentleman the bill was referred to the committee on Judiciary.

On motion by Mr. Sanborn of Baldwin, it was voted to take from the table the 32nd unassigned matter, resolve to appropriate money for the purpose of preventing damage to domestic animals by bears, S. P. 261, tabled by that gentleman February 8th, pending reference in concurrence.

Mr. SANBORN of Baldwin: Mr. Speaker, I yield to the gentleman from Weld, Mr. Sanborn.

The SPEAKER: The Chair will state that an error was made yesterday and this matter was sup-posed to have been tabled by the gentleman from Weld, Mr. Sanborn.

On motion by Mr. Sanborn of Weld this resolve was referred to a joint committee composed of the nembers of the two committees on Inland Fisheries and Game and Agriculture.

On motion by Mr. Carleton of Portland, it was voted to take from the table the tenth unassigned mat-Joint Order relative to salaries, University of Maine, S. P. 295, tabled by that gentleman February 3th, pending passage in concurrence; and on further motion by the same gentleman the order was indefinitely postponed in non-concurrence.

On motion by Mr. Goudy of So. Portland, it was voted to take from the table the 33rd unassigned matter, bill an act relating to the purchase and sale of lobsters, H. P. 1155, tabled by that gentleman, February 8th, pending reference; and on further motion by the same gentleman the bill was referred to the committee on Sea and Shore Fisheries.

On motion by Mr. Rounds of Portland, it was voted to take from the table the 27th unassigned matter, bill an act relating to absentee voters, H. P. 1078, L. D. 435, tabled by that gentleman February 8th, pending first reading.

Mr. ROUNDS: Mr. Speaker, I yield to the member from Portland,

Miss Laughlin.

Miss LAUGHLIN: Mr. Speaker, in view of the fact that there are three bills referring to the same section which are being considered, and if any one of them should be reported favorably and meet with the favor of the Legislature, it seems to me that they should all be considered before any are passed upon. I, therefore, move that this bill be retabled pending first reading.

The motion prevailed.
