HOUSE

Friday, February 10, 1933.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Haggett of Augusta.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

At this point a message was received from the Senate, through its Secretary, as follows:

Mr. Speaker: I have the honor, Sir, to bear a message from the Senate addressed to this honorable body relative to the recent proposition of the House as to a joint convention for the purpose of holding a public hearing on the report of the Committee on State Budget.

The message is as follows:

"Recognizing fully the desirability of courtesy between the two branches of the Legislature, the Senate regrets that it cannot concur in the proposal made for a joint convention.

It is the considered opinion of the Senate that progress can best be made by following orderly procedure and having all legislative hearings conducted before joint committees. A precedent abandoning our established procedure of many years' standing would be not only undesirable but dangerous.

The individual items contained in the Budget have been properly introduced and are now pending before appropriate committees. Individual citizens desiring to be heard will be given ample opportunity to appear before such committees. The Governor enjoys the privilege of addressing the Legislature in joint convention on matters of pending legislation. The Senate feels that this privilege should be preserved to the Governor alone."

The SPEAKER: The House hears the message.

Orders of the Day

On motion by Mr. Farris of Augusta, it was voted to take from the table the second unassigned matter bill an act permitting the Louis Lipsitz Estate to sue the State for recovery of succession tax assessed and paid under law held by United States Supreme Court to be unconstitutional, H. P. 842, L. D. 419, which came from the Senate referred to the 87th Legislature in non-concurrence, and which was tabled by that gentleman February 8th, pending further consideration.

Mr. FARRIS: This is one of those bills for the return of Inheritance taxes paid under our State Inheritance Tax laws which was declared unconstitutional by the United States Supreme Court. Several similar matters came in here and were referred to the next Legislature. This resolve asks the right to sue the State to recover its succession tax. I now move that we concur with the Senate in referring this to the Eighty-seventh Legislature.

The motion prevailed, and the bill was referred to the Eighty-seventh Legislature in concurrence.

On motion by Mr. Cook of Pittsfield, it was voted to take from the table the third unassigned matter, bill an act relating to the Eastern State Normal School at Castine, H. from the Senate referred to the committee on Claims, and which was tabled in the House on February 8th by the gentleman from Augusta, Mr. Hussey, pending reference in concurrence; and on further motion by the same gentleman the resolve was referred to the committee on Claims in concurrence.

On motion by Mr. Hussey of Augusta, it was voted to take from the table the 21st unassigned matter, resolve in favor of the town of Kennebunk, S. P. 270, which came from the Senate referred to the committee on Claims, and which in the House was tabled on February 8th by the gentleman from Augusta, Mr. Hussey, pending reference in concurrence; and on further motion by the same gentleman the resolve was referred to the committee on Claims in concurrence.

On motion by Mr. Littlefield of Alfred, it was voted to take from the table the tenth unassigned matter, bill an act relating to towns and town officers, H. P. 1135, tabled by that gentleman February 8th, pending reference; and on further motion by the same gentleman, the bill was referred to the committee on Legal Affairs and 500 copies ordered printed.

On motion by Mr. Littlefield of Alfred, it was voted to take from the table the eleventh unassigned matter, bill an act concerning the

licensing of motor vehicle junk yards, H. P. 1136, tabled by that gentleman February 8th, pending reference; and on further motion by the same gentleman the bill was referred to the committee on Maine Publicity and 500 copies ordered printed.

On motion by Mr. Crowell of Weston, it was voted to take from the table the 14th unassigned matter, bill an act relating to a tax on malt, H. P. 1163, tabled by that gentleman February 8th, pending reference; and on further motion by the same gentleman the bill was referred to the committee on Taxation and 500 copies ordered printed.

On motion by Mr. Smith of Masardis, it was voted to take from the table the 22nd unassigned matter, bill an act to create a lien on potatoes for storage charges, S. P. 285, L. D. 462, which came from the Senate referred to the committee on Judiciary, and which was tabled in the House on February 9th by the gentleman from Masardis, Mr. Smith, pending reference in concurrence; and on further motion by the same gentleman the bill was referred to the committee on Judiciary in concurrence.
