Mr. FERNALD of Winterport: Mr. Speaker, I offer House Amendment A and move its adoption, as follows:

House Amendment A to L. D. 7, H. P. 19.

Legislative Document 7, H. P. 19 is hereby amended by adding at the end thereof the following words: "Provided, however, that this act shall not take effect unless ratified by the residents of the town of Islesboro in a special town meeting called for that purpose, which meeting shall take place on or before September 1, 1933." Mr. FERNALD: Mr. Speaker, be-

Mr. FERNALD: Mr. Speaker, before we vote on this amendment I would like to say two or three things very briefly.

First, this is a proposition that applies solely and only to Islesboro. It is a matter that very few of us are competent to pass on, it is a matter affecting the town of Islesboro only.

Second, at the last town meeting held in Islesboro, the largest town meeting ever held in the town, the people were opposed to this measure. This is not an amendment to kill the bill but is an amendment to let the people themselves once and for all decide whether or not they, themselves, want automobiles. I hope the amendment prevails.

Mr. WENTWORTH of Kennebunk: Mr. Speaker and members of the House: Inasmuch as the gentleman from Winterport (Mr. Fernald) did not express himself one way or the other on this matter before the committee, it would seem that he must be doing it from the standpoint of publicity. I would imagine that to become Sen-Ι ate President in 1935 and Governor in 1937, he would need considerable publicity, but it should not be to the detriment of the people of Islesboro. Your committee is not in favor of this amendment as it desires to give Islesboro a clean slate to start with, and I hope the

amendment will not prevail. Mr. BARTLETT of Eliot: Mr. Speaker, as a member of the committee on Towns I would like to say that at the hearing on the Islesboro matter the gentleman from Winterport (Mr. Fernald) appeared before the committee and said that he presented the bill but that he wished to be neutral in the matter and not take any action one way or the other. After the hearing we went into executive session and discussed the bill voting unanimous-ly in favor of it. Now I would like to ask this House why, if we are not going to accept the unanimous report of the committee, should we go to the expense of referring it to a committee and advertising a hearing on it. I hope the amend-ment does not prevail. Mr. THOMPSON of Belfast: Mr. Speaker, as one of the few members who wided with the gentlement from

who voted with the gentleman from Winterport Mr. Fernald, last Fri-day, I sincerely hope that this amendment does not prevail.

amendment does not prevail. Mr. FERNALD: Mr. Speaker, evidently I did not make myself clear the other day when I spoke on this matter. I will again speak and try to make myself clear. I told the committee at the hearing and I will tell them again what my position has been and was at that position has been and was at that time. It was that I was opposed to automobiles on Islesboro, but if the proponents of the bill could show me otherwise I was willing to be shown.

As far as the political side of this question is concerned, it does not make a particle of difference to me. I got thirty-three votes down there two years ago and I probably will not get 33 the next time. Nevertheless, let me say to some of the Democrats who are making such a fuss and furor trying to put me in a hole on this proposition—let me point out that Governor Brann in September got 147 votes down there and Burleigh Martin got 77. I don't care very much what you do with the bill, but I believe that the town of Islesboro should have a right to

determine its own proposition. If it were a question for the United States Congress to determine whether or not it would give the Philippines their independence, they would let them have a show, and I assure you that the people of Islesboro are better citizens than the natives of the Philippines. This proposition is just a proposition for the people of Islesboro to determine. If you want to stand for local government and a democratic government, the only way to do is to adopt the amendment and let the people vote on it. If they do want it that will be perfectly all right with me and if they do not want it that will also be all right with me. It is up to them and I am willing for them

Mr. SARGENT of Brewer: Mr. Speaker, I would like to have that amendment read again. I did not understand whether it sold quite understand whether it said "voters" or "residents." The SPEAKER: The Clerk will

read the amendment.

House Amendment A again read. Miss LAUGHLIN of Portland: Mr. Speaker, I really took no part in this Islesboro matter, but as I understand it all that this bill does is to repeal the law which forbade automobiles on the town of Isles-boro. If we leave it just as it stands, it means that the State is entirely out of the affair, and Islesboro does as it pleases. So far as the amendment goes I can see no point to it because the whole effect of repealing the law was that the State had nothing to say about it. (Applause)

The SPEAKER: The question is on the adoption of House Amendment A-

At this point Mr. Fernald was granted permission to speak for the third time.

Mr. FERNALD: Mr. Speaker, in the first place in regard to what Mr. Sargent has said, we are not trying to put anything over. What I want is for the legal residents of Islesboro, the people who vote there and the people who live there to say

what they want. I do not understand the point at all of the lady member from Portland (Miss Laughlin). If my amendment is accepted, it will mean that if the people in Islesboro do not want automobiles and so vote, this bill will have no effect. In other words, the exemption from the law that they came over here in 1913

and asked for will still hold. Now that ought to be clear enough; if it is not I will repeat it.

Mr. SARGENT: Mr. Speaker, several years ago there was an amendment put on a bill with reference to the town of Marlboro taxpayers. Somebody went there and bought a tract of land, and the court later said that those people being taxpayers had a right to vote. Now it seems to me that under this amendment anybody residing in the town of Islesboro would have a right to vote there whether they were legal voters, minors, or non-residents. They might be summer residents or winter residents so far as I can see.

winter residents so far as I can see. (At this point Mr. Fernald was granted permission to speak for the fourth time.)

Mr. FERNALD: Mr. Speaker, to answer the gentleman (Mr. Sargent) I am perfectly willing that the amendment shall apply only to legal voters of Islesboro as of April 1, 1932. Nobody is going down to Islesboro and buy a lot of land for the purpose of voting there. All we are trying to do is to let the people themselves decide it. There is no dog in the manger here at all.

The question was called for.

The SPEAKER: The pending question is on the motion of the gentleman from Winterport, Mr. Fernald, that House Amendment A to L. D. 7, H. P. 19, be adopted. Is the situation clear? All those in favor of the adoption of the amendment will say aye; contrary minded no.

A viva voce vote being taken, the amendment failed of adoption.

On motion by Mr. Carleton of Portland, it was voted to take from the table the tenth unassigned matter order relative to printing for the use of the House two thousand additional copies of the list of salaries of State officers and employees as of December 31, 1932, compiled by the Department of Audit, tabled by that gentleman February 17, pending passage.

17, pending passage. Mr. CARLETON: Mr. Speaker, I move that this order be indefinitely postponed.

Mr. CARSWELL of Gorham: Mr. Speaker I trust the motion of the gentleman from Portand (Mr. Carleton) will not prevail. This is a very important pamphlet. It deals with the salaries of all State officials. The gentleman has told us that there were two thousand copies of this pamphlet printed. When those are distributed over the State, it is very readily to be seen that very few citizens receive them. This is indeed an important item. The citizens of the State of Maine are interested in the amount of salaries that its public servants are receiving, and if it is generally known that these pamphlets are published, I feel certain that there will be a larger demand for them. There has not been a request for printing denied in this body at this session and this is the only request that has been made for, the benefit of the people. I believe there is need that these pamphlets should be printed and distributed, and I sincerely trust that the motion of the gentleman from Portland (Mr. Carleton) will not prevail. (Applause)

Mr CARLETON: Mr. Speaker. I believe that before this could be set up again and printed a new list will be in your hands that will be more up-to-date than this one. That is the reason I tabled this order. If you have a new set-up on salaries and this old salary list goes out, it will not be up-to-date and will not be what the salaries will be for the next two years. I have no objection to the printing but it is nonsensical to print this old salary list come out.

Mr. ROUNDS of Portland: Mr. Speaker, and ladies and gentlemen of this House: I rise to defend the Cumberland county salary list. We have already had two meetings and we asked to have them come for the third one and they never came. Now we have given them the fourth time to come. If you will bear with me and follow my lead, I will explain to you why we can cut more. than the salaries of Cumberland county in the committee on esti-mates. I have been reading over a report from the County Commissioners, and they have told me that they could count on dropping the estimated expenditures some. As I bill understand. one has gone through here relative to jurors, reducing them one dollar a day. If I am right about that, that will take \$3,000 off of our estimates. I can reduce two men's salaries of \$3700. I can reduce \$5,000 on another item and it has been agreeable to the County Commissioners as I understand it. Now why should we take it off of these salaries of poorly paid people, some of whom get I think about \$300 a year and from that up to \$4,000. We cannot, as I understand it. touch the salaries of the Judges of the Supreme Court. Am I right on that? I say we can take off more than the \$8,000 to balance the budget in Cumberland county. I am not talking about any other county, but in Cumberland

county, the largest county in the State, we can balance the budget and take off what the gentleman from Portland wishes taken off in a salary cut. If you will bear me out in this, I can do it. I have taken off of one year here \$52,000 and they came out ahead. I have cut off another year \$4,000 and they have come out ahead. Now they have got an interest account. They are going to pay a lot of bonds and the 1934 tax need not be so high as the 1933 tax if they wish it. I think it time that we stop trying to cut small salaries and look after some of these big appropriations that you will see flying over your heads inside of two or three weeks. I thank you

I thank you. The SPEAKER: The question is on the motion of the gentleman from Portland, Mr. Carleton,— Mr. CARSWELL: Mr. Speaker, in my conversation with the gentleman from Portland Mr. Corleton Satur-

from Portland, Mr. Carleton, Saturday he did not tell me that there was another pamphlet in preparation which would give the list of salaries of these people. I have no particular interest in this particular pamphlet, but I believe a list of salaries of the officials of the State should be given to the people, and as there is a demand for them I think there should be an increased number printed. If the gentleman says that a revised list of salaries of State officials is to be printed and a sufficient number distributed, that is perfectly satisfactory to me and it would be unwise perhaps to print this list and have it superseded within a week by another list. If, however, this new list is an indefi-nite one and will not appear for some time. I think this present list should be printed.

Mr. Carleton was granted permission to speak for the third time. Mr. CARLETON: Mr. Speaker, I think in a your short time this list

think in a very short time this list will be printed. The SPEAKER: The question is

The SPEAKER: The question is on the motion of the gentleman from Portland, Mr. Carleton, that the order be indefinitely postponed. All those in favor will say aye; those opposed no.

A viva voce vote being doubted, A division of the House was had.

Forty-three voting in the affirmative and 34 in the negative, the motion prevailed and the order was indefinitely postponed.
