HOUSE

Thursday, February 23, 1933.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Hughes of Augusta.

Journal of the previous session read and approved.

From the Senate: Report of the committee on Appropriations and Financial Affairs reporting ought not to pass on resolve in favor of a Memorial to the Maine Volunteers Signal Corps S P 18

teers Signal Corps, S. P. 18. Comes from the Senate read and accepted.

In the House, on motion by Mr. Rounds of Portland, tabled pending acceptance of the report in concurrence.

Papers from the Senate disposed of in concurrence.

I think where a man introduces a bill and he does not know what the committee report is until it comes out here in the House that he ought to have the privilege of tabling it. He may be able to produce other evidence and show the committee that they have made a mistake.

The SPEAKER: The question before the House is the acceptance of the report of the committee on Legal Affairs on resolve extending the charter of the Fryeburg Village Fire Corporation.

Mr. HILL of So. Portland: Mr. Speaker, I move that the House reconsider its action whereby it voted not to table this resolve.

The SPEAKER: The motion is not in order. A motion to table cannot be reconsidered. You can now move to retable, although that is a little unusual. Nothing having intervened since the last motion, the Chair will entertain another motion to lay this matter on the table.

Miss MARTIN of Bangor: Mr. Speaker, I move that we reconsider our action whereby we voted to recede and concur with the Senate in referring H. P. 860, L. D. 302, an act to grant a new charter to the city of Bangor, to the commit-tee on Legeal Affairs. Due to the fact that so much undesirable publicity was given this minor matter, and since any report which might come from the committee on Legal Affairs would be regarded as unfair, out of fairness to the committee, to me and to the Legislature, I feel that this bill should go to some other committee than Legal Affairs, and I respectfully move reconsideration.

The SPEAKER: The member from Bangor, Miss Martin, moves SPEAKER: The member that the House reconsider its action taken earlier this morning whereby it referred H. P. 860, L. D. 302, an act to grant a new charter to the city of Bangor, to the committee on Legal Affairs in concurrence. Is this the pleasure of the House.

A viva voce vote being taken, the motion to reconsider prevailed.

Mr. PIPER of Bangor: Mr. Speaker, we have had a confer-ence, and giving due respect to the lady member from Bangor (Miss Martin), I now move that this House insist and that a committee of conference be appointed as to the reference of the bill to the Judiciary committee. The SPEAKER: The gentleman

from Bangor, Mr. Piper, now moves that the House insist on its action taken on February 9th, whereby it referred this bill to the committee on Judiciary, and that the House ask for the appointment of a committee of conference on the nonconcurring action of the Senate, which referred the same bill to the Senate. committee on Legal Affairs in nonconcurrence

The motion prevailed and the Chair appointed as conferees on the part of the House Messrs. Piper of Bangor, O'Connor of Bangor and Quine of Bangor.

Mr. FARRIS of Augusta: Mr. Speaker, I move that we reconsider our action of this morning whereby we accepted a committee report on H. P. 365, resolve in favor of Leon W. Alley of Prospect Harbor. Ť wish to say that the parties to be notified in regard to that hearing were overlooked and they desire to be heard. This is for the purpose of having it referred to the committee on Claims and not for the purpose of tabling.

The motion to reconsider prevailed.

Mr. FARRIS: Mr. Speaker, I move that this resolve be recommitted to the committee on Claims.

A viva voce vote was doubted.

The SPEAKER: All those in favor of the motion of the gentleman from Augusta, Mr. Farris, that this resolve be recommitted to the committee on Claims will rise and stand in their places until counted and the monitors will make and return the count.

A division was had,

And more than half of the members present rising, the motion prevailed, and the resolve was recommitted to the committee on Claims.

On motion by Mr. Williams of Dover-Foxcroft, it was voted to take from the table the fourth unassigned matter, House Report ought not to pass of the committee on Education on bill an act relating to superintendents of schools, H. P. 821, L. D. 682, tabled by that gentleman February 22, pending acceptance of the report; and on further motion by the same gentleman the bill and accompanying report were recommitted to the committee on Education by a viva voce vote.

On motion by Mr. Williams of Dover-Foxcroft, it was voted to take from the table the fifth unassigned matter, House Report ought not to pass of the committee on Education on bill an act relating to supervisory unions of schools, H. P. 593, L. D. 239, tabled by that gentleman February 22, pending acceptance of the report; and on further motion by the same gentleman the bill and accompanying report were recommitted to the committee on Education.
