Fishermen of Eastern Maine in Stout Stand to Reduce Legal Length to 9 Inches—Claim they Cannot Compete with the Nearby States where Length is 9 Inches—Opponents Plead Present 10 1-2 inch Law Aids in Propaga-

For the benefit of those who were not present yesterday at the hearing I would like to state that this is a gross misstatement in direct contradiction to the facts. Almost every lobster fisherman who appeared here at that hearing from the eastern part of the State was opposed to reducing the length of lobsters to 9 inches and in favor of keeping the length as it is now 10 1-2.

Further down in the body of the article it reads this way "For more than four hours Thursday lobster fishermen of Eastern Maine opposed

fellow lobstermen and lobster dealers of York and Cumberland counties over a measure to lower the legal length of lobsters from 10 1-2 inches to nine." Now that part of it is possibly correct but it is ambiguous. I do not know who is responsible for this. It is an (P) comsponsible for this. It is an (A') communication and whether the Kennebec Journal or the (A') is responsible, I don't know; but I would like all the members to understand it is incorrect. I thank you.
