Tuesday, November 14, 1933. This being the day designated in the proclamation of the Governor for the meeting of the Eighty-sixth Legislature in extra session, the members of the House of Rep-resentatives assembled in their hall at four o'clock in the afternoon and were called to order by the Speaker.
Prayer was offered by the Rev.
Mr. McWhorter of Augusta.

The SPEAKER: This special session of the Legislature meets as a result of a proclamation by His Excellency, the Governor, which the Clerk will now read.

PROCLAMATION BY THE GOVERNOR

Special Legislative Session

The Merrill Trust Company of Bangor has made application for membership in the Federal Reserve System.

Membership in the Federal Reserve System guarantees the deposits to the extent permitted under the Federal Banking Act of 1933.

Insurance of deposits under the Act becomes effective on January 1,

The plan endorsed by the stock-holders on November 10 and ap-proved by the Reconstruction Finance Corporation and the Federal Reserve System calls for the grant-ing of a new charter to the Merrill Trust Company and the formation of a mortgage company to be known as the Merrill Mortgage Company.

The Reconstruction Finance Cor-

poration will invest two million dollars (\$2,000,000) in the preferred stock of the Merrill Trust Company and more than three million dollars (\$3,000,000) in the Mortgage Com-

The plan as adopted by the stockholders and approved and supported by the Reconstruction Finance Corporation and the Federal Reserve System will prevent loss to any de-positor in the Merrill Trust Com-

pany.

The plan calls for the control of the Merrill Trust Company to be in the hands of the present preferred stockholders and the Reconstruction Finance Corporation subject to the supervision of the Federal Reserve System.

The Reconstruction Finance Corporation and the Federal Reserve System will act immediately upon the granting of the charters by the

Legislature.

In order to cooperate with the stockholders of the Merrill Trust Company, the Federal Reserve System and the Reconstruction Finance Corporation, I herewith call into special session the Eighty-sixth Legislature to assemble in their respective chambers at the Capitol, in Augusta, on Tuesday, the fourteenth day of November, 1933, at four o'clock in the afternoon, to consider the granting of such charters and such general legislation as may be necessary to permit banks to become members of the Federal Reserve System.

The occasion is extraordinary. Given at the office of the Gov-ernor at Augusta and sealed with the Great Seal of the State of Maine this thirteenth day of Nowante this tillreethi day of No-vember, in the year of our Lord one thousand nine hundred and thirty-three and in the one hundred and fifty-eighth year of the Inde-pendence of the United States of America.

The Clerk thereupon called the roll of the House.

One hundred and forty members answering to their names, a quorum was declared to be present.

On motion by Mr. Farris of Augusta, it was

Ordered, that a committee of seven be appointed to wait upon His Excellency, the Governor, and inform him that a quorum of the House of Representatives is assembled in the hall of the House for the consideration of such business as may come before the House.

Thereupon the Chair appointed as such committee Representatives Farris of Augusta, Scates of Westbrook, Fernald of Winterport, Smith of Vinalhaven, Mason of Mechanic Falls, Carleton of Portland and Sprague of Oakfield.

Subsequently the committee reported, through its chairman, that it had attended to its duty.

On motion by Mr. Burns of Eagle

Lake, it was

Ordered, that a message be conveyed to the Senate that a quorum of the House of Representatives is present for the consideration of such business as may come before the House.

Thereupon the Clerk of the House was directed to convey the message to the Senate, and subsequently reported that he had performed the duty with which he was charged.

At this point a message was transmitted from the Senate, through its Secretary, informing the House that a quorum was present in their chamber and that body was ready for the consideration of such business as may come before it.

The SPEAKER: For the purposes of the record, three members who did not reply to the roll call have appeared and reported their presence to the Clerk. The gentleman from Livermore Falls, Mr. Dow, the gentleman from Friendship, Mr. Whitney, and the gentleman from Hope, Mr. Hobbs.

The SPEAKER: The Chair recognizes the gentleman from Biddeford, Mr. Duquette, for the purpose of introducing, out of order, a resolution, and the Clerk will read.

Now Be It Resolved that the State of Maine mourns the decease of Charles E. On further motion by Mr. Duquette the resolution was adopted by a rising vote.

Thereupon the resolve was received out of order, and under suspension of the rules received its two several readings and was passed to be engrossed.

A message was received from the Senate, through its Secretary, proposing a Joint Convention to be held forthwith in the hall of the House of Representatives for the purpose of extending an invitation to His Excellency, the Governor, to attend the Convention and make such communication as pleases him.

On motion by Mr. Scates of Westbrook, it was voted that the House signify to the Senate its concurrence in the proposal for a Joint Convention.

Thereupon the Clerk of the House performed that duty, subsequently reporting that he had so done, which report was accepted.

At this point the Senate came in and a Joint Convention was formed.

Subsequently Senator Page, for the Committee, reported that the committee had discharged the duty assigned it, and that the Governor was pleased to say that he would attend forthwith.

The report was accepted. Thereupon the Honorable Louis J. Brann, Governor and suite, entered the hall amid applause, the audience rising, and the Governor addressed the Convention as follows:
MR. PRESIDENT AND MEMBERS OF THE CONVENTION: It

is a great pleasure to have this opportunity of again meeting with the members of the Legislature, and I trust you all had a very happy and agreeable summer.

By Proclamation I requested the members of the Eighty-sixth Legislature to assemble today in special

session.

First. To act upon bills concerning the Merrill Trust Company of Bangor. The purposes of the bills are contained in the call.

The plan endorsed by the stock-holders on November 10 and approved by the Reconstruction Finance Corporation and the Federal Reserve System calls for the granting of a new charter to the Merrill Trust Company and the formation of a mortgage company to be known as the Merrill Mortgage Company.

The Reconstruction Finance Corporation will invest two million dollars in the preferred stock of the Merrill Trust Company and more than three million dollars in the

Mortgage Company.

The plan as adopted by the stockholders and approved and supported by the Reconstruction Finance Corporation and the Federal Reserve System will prevent loss to any depositor in the Merrill Trust Company

The plan calls for the control of the Merrill Trust Company to be in the hands of the present pre-ferred stockholders and the Reconstruction Finance Corporation subject to the supervision of the Federal Reserve System.

The Reconstruction Finance Corporation and the Federal Reserve System will act immediately upon the granting of the charters by the

Legislature.

In order to cooperate with the stockholders of the Merrill Trust Company, the Federal Reserve Company, the Federal Reserve System and the Reconstruction Finance Corporation" the action of the Legislature should be favorable and immediate.

Second. To act upon a bill amending one section of the general banking law. Its purpose is to avoid a technical objection which prevents the immediate admission to the Federal Reserve System of certain banks.

I regard it as of great importance that banking institutions desiring to become members of the Federal to become members of the Federal Reserve, thus automatically being entitled to government insurance of deposits, should not be prevented from so doing by reason of mere technical legal objections. To meet this situation promptly by the enactment of the proposed laws under the emergency provision of our der the emergency provision of our Constitution, would strengthen the newly organized banking institutions of the State.

I assume that it may be that the Legislature will consider at this session only the matters outlined in the Call. If I am correct in my understanding of the situation it will be necessary to reconvene the Legislature at some subsequent time during the present year. Discussing the matter with the distinguished President of the Senate and the equally distinguished Speaker of the House, we agreed that if it were agreeable to the other members of the Legislature that the Legislature would again be reconvened in special session on the fourth day of December, the fourth day of December being the Monday

following Thanksgiving. I mention that, that you may understand that in all human probability the subsequent call for the special session will be as of the fourth day of December of this year. And I desire, my friends, in conclusion to thank you for your attendance here at this special session of the Legislature. (Applause, the convention rising.)

The Governor and suite then retired, amid the applause of the Convention, the audience rising.

The purpose for which the Convention was assembled having been accomplished, the Convention was dissolved and the Senate retired, amid the applause of the House.
