#### Orders of the Day

On motion by Mr. Holmes of Androscoggin, the Senate voted to take from the table, Memorial to the Congress of the United States urging the passage of a bill (H. P. 644), tabled by that Senator earlier in today's session pending consideration.

Mr. HOLMES of Androscoggin: Mr. President, I will presently make a motion so that I may not be speaking at random, but what the motion will be will necessarily depend upon what enlightenment the Chair can give me. I wish to say that after having read this mem-orial through I find that the main point is this, that it proposes that this Legislature memorialize the Congress in favor of the passage of a certain bill which has been introduced into the present session of the Congress by Congressman Sam-uel B. Hill of Washington, being numbered H. R. 13999, the official title of which is as follows: "A bill, to prevent loss of revenue, to provide employment for American labor, and to maintain the indus-tries and agriculture of the United States against the effects of depreciation in foreign currencies." The rest of the proposed memorial, however, does not give any inkling of what the terms of Congressman Hill's bill is and I am therefore asking the Chair to enlighten me as to what the terms of that bill are which it is proposed to commit this Legislature in favor of. I am sorry to say that from general information I am unable to determine.

The PRESIDENT: The Chair will state with equal regret that he is unable to give the information to Senator from Androscoggin the (Senator Holmes). In a general way it is the understanding of the Chair that the bill pending in Congress, and which is supposed to be before Congress for action today, seeks to impose a differential which will increase the duties on imports coming from countries whose money is depreciated and will more nearly make the existing tariff correspond with the rates established by Congress. That may or may not be ac-curate but it is the understanding of the Chair.

Mr. HOLMES: I thank the Chair for the information. I had an idea that that was the bill on general lines and I wish to say that per-sonally I do not feel like voting to commit this Legislature to a bill on a disputed subject pending in Con-gress and that I feel that the Legislature-it is now for action in the Senate-that the Legislators ought to fully understand what they are doing before they commit the Legis-lature of Maine to a bill embodying a disputed question. (I am go-ing to make a motion, Mr. Presi-dent, in a few minutes.) For in-stance, from what I have read I understand that there are opponents to the bill who argue that the exports and imports of the country have decreased during the past year and a half, since about the time when so many countries began going off the gold standard led by Great Britain, and that that indicates that depreciation in currency has not been the cause of bad times or increasing bad times, that if depreciation of currency was a help to those countries that are off the gold basis, the imports to our country would increase. This I am not proposing as an argu-ment; I am only indicating that there are arguments against the bill. Therefore, I believe that this Legislature should be fully informed

and should give the matter consideration before committing itself.

I therefore move, Mr. President, that the memorial be referred to the Committee on Federal Relations for a public hearing.

Thereupon, on motion by Mr. Weeks of Somerset, the memorial was laid upon the table pending reference to the Committee on Federal Relations.

On motion by Mr. Weatherbee of Penobscot, the Senate voted to take from the table the several resolves relating to the estates of deceased persons (House papers numbers 346 to 359 inclusive and 368 and 544), tabled by that Senator earlier in today's session pending reference in concurrence.

Mr. WEATHERBEE of Penobscot: Now, Mr. President, these resolves aggregate in dollars and cents approximately seventy thousand dollars. These estates attempt to col-lect from the State of Maine that amount of money which was paid by them to the State of Maine under a state law which has since been declared unconstitutional by the United States Supreme Court. I was informed by the attorney who represents the several claimants that owing to the financial condi-tion of the State of Maine at this time he would be satisfied if the Committee on Claims should refer Legislature. His desire was to file the claims at this session so that it might not appear that he was not diligent in asking for reimbursements.

Now, to save the cost of publication of the notices and the trouble of a hearing I am going to move that these several resolves be referred to the Eighty-seventh Legislature in non-concurrence with the action of the House.

The motion prevailed and the several resolves were referred to the Eighty-seventh Legislature in nonconcurrence.

The PRESIDENT: Is there anything further to come before the Senate? Is there any member of the Senate who has any matter on the table which can be taken off the table and advanced at this time? The Chair wishes once more to urge speed. Last Thursday we organized the force to assist in the revisal of the statutes and succeeded, I believe, in getting all matters of private and special legislation which were pending, drafted. Those have now been introduced.

If the members of the Senate and House agree with those in the Senate and House offices the recess this week will be from Friday noon until Tuesday morning in order that the members of the Legislature may be in their seats Tuesday morning and that next week the committees may have three full afternoons for hearings. The only way that we can make progress is by getting in our bills in time for hearings and by holding our hearings. Every committee chairman is of course a member of the Senate. I wish to urge that at your meetings this afternoon you arrange for hearings on as many bills as possible next week out of the three afternoons, Tuesday afternoon, Wednesday afternoon and Thursday afternoon, that we may meet hereafter four days a week and make progress.
