SENATE

Tuesday, February 7, 1933. Senate called to order President.

Prayer by the Rev. Willis Moore of Gardiner.

Journal of Thursday, February 3d read and approved.

On motion by Mr. Viles of Kennebec the rules were suspended and that Senator presented out of order communication from the Governor submitting a communication from Ex-Governor Percival P. Baxter and accompanying papers.

The Secretary thereupon read the following communications:

I am pleased to submit herewith a communication from Ex-Governor Percival P. Baxter, distinguished citizen of Maine, with accompanying Act and Deed.

I suggest that prompt action be taken upon the Submitted Act, expressing definitely and conclusively our gratitude and appreciation.

It is the desire of Ex-Governor Baxter that the validity and public purpose of this very magnanimous gift be properly legalized, authenticated and recorded in the Laws of Maine.

No gift could be more generous, unselfish and disinterested.

This great public domain is for the enjoyment of our people for all

I desire to express to Ex-Governor Baxter the appreciation and thanks of the people of Maine.

"Portland, Maine, February 2, 1933.

To Honorable Louis J. Brann, Governor and the Senate and House of Representatives of the Eighty-Sixth Legislature of the State of Maine:

On March 3, 1931 I conveyed by Deed of Gift to the State of Maine an undivided three-eighths (%) interest in a tract of land located in Township three (3) Range nine (9) W. E. L. S. Piscataquis County (Mt. Katahdin) which, had the Township been divided according to the frential interest. fractional interests then outstand-

ing, would have amounted to an area of six (6) square miles and this gift and conveyance was accepted, subject to the conditions therein imposed, by Act of the Legislature approved by the Governor on March 4, 1931 (Private and Special Laws of 1931 Chapter 22) Special Laws of 1931, Chapter 23).

Subsequent to the conveyance and to the passage of the Act above mentioned a division of the Township was effected under which the former undivided interests were consolidated into separate and distinct ownerships, and this enabled me to complete and enlarge my Gift to the State. On October 7, 1931 I thereupon completed the mer Gift and at he same forconveyed to the State an additional area slightly in excess of three (3) square miles which additional area when added to that first conveyed gave the State full title and ownership to an area of nine (9) square miles in said Township. This second conveyance was accepted by the State on October 7, 1931 by Hon. Neil L. Violette, Forest Commissioner, approval being given thereto by Governor William T. Gardiner and the Executive Council and by Hon. Clement F. Robinson, Attorney General, all of them acting under authority conferred upon them Sections fifteen (15) and sixteen (16) of Chapter eleven (11) of the Revised Statutes of 1930.

In order that the total area of nine (9) square miles or to be more exact about 5,960 acres, conveyed to the State by the two (2) Deeds above referred to shall finally be accepted by the Senate and House of Representatives directly representing the People of the State and shall be approved by the Governor, I have prepared and submit herewith an Act of the Legislature which I request your Honorable bodies to enact into law and your Excellency to approve. The description of the area and the conditions of the Gift are the same as in the two original conveyances. The passage of this Act makes the acceptance of the two Gifts above mentioned somewhat more formal and complete and it is this that I seek to accomplish.

Mr. WEEKS of Somerset: President, I wish to register my objection to receiving this special legislation at this time. An order was presented, it was passed, it was published in the papers and if we continue to receive special legislation throughout this session we will be here for the rest of the year or more. I do not wish to oppose the

reception of any legislation which would obviously be of great benefit to the people of the State of Maine, but I cannot see why a special pension resolve or a special road resolve could not have been placed in the hands of this Legislature previous to the closing of the doors. I hope that my objection will be sustained by the Senate.

The PRESIDENT: The Chair will rule that under the order adopted. the objection of any member is sufficient to automatically cause the reference of private and special legislation at this time, or public legislation after this date, to the 87th Legislature. This resolve is therefore so referred in non-concurrence.

The PRESIDENT: The Senator from Hancock, Senator Blaisdell, addresses through the Chair a question to the Senator from Somerset, Senator Weeks, which the Senator from Somerset (Senator may answer if he so desires.

Mr. BLAISDELL: Mr. President,

I might say, of course, Senator from Somerset, that the Senator Weeks, at this time has not the in-formation which I have involving the particular instance and I question whether or not he could give an intelligent answer at this time. My question is, whether or not the

Senator from Somerset (Senator Weeks) feels that his reason would apply to important legislation affecting a county, where the error has been discovered within the past

The PRESIDENT: The Senator from Somerset, Senator Weeks, may answer if he wishes but the Chair will remark in passing that if his hearing does not deceive him the Senator from Somerset, Senator Weeks, has answered the question before it was asked. Mr. WEEKS: Mr. President, I stand upon what I have already

stated.

Those papers will not come back from the House today and the legislation will not be enacted until We are now proceeding tomorrow. under Orders of the Day.

Mr. WEATHERBEE of Penobscot: Now, Mr. President, several days ago there were presented eight or ten resolves to reimburse estates which had paid the same kind of tax as referred to in this bill, which resolves aggregated about seventy thousand dollars. They were re-ferred to the next Legislature. I believe that all these matters should be treated similarly and I move that this bill be referred to the next Legislature.

I will therefore yield to the Senator who introduced the resolve, the Senator from Waldo, Senator Cooper, with the expressed wish that I hope he may see fit to withdraw this resolve.

The PRESIDENT: Is there any further business to come before the Senate? If not, before the Secretary reads the notices, the Chair wishes to say once again that the

Revisor of Statutes has advised the officers of the Senate and House that unless there is a further influx of requests for drafting legis-lation he is able to have everything now in his hands drafted and in the hands of the Secretary of the Senate or the Clerk of the House by four o'clock this afternoon which. under our joint order adopted the first day of the session, is the closing date for public legislation. Again unless the members of the Legislature rule otherwise, the presiding officers and Secretary of the Senate and Clerk of the House are prepared to consider that any bill in the hands of the Revisor of Statutes at four o'clock is in the hands of the Secretary of the Senate or the Clerk of the House. May the Chair urge once again that if the members of the Senate have any legislation which they wish to introduce they either prepare and present it themselves or get it into the hands of the Revisor of Statutes before four o'clock this afternoon, when his office will close.

On motion by Mr. Angell of York, Adjourned, until tomorrow morning at ten o'clock.
