SENATE

Friday, February 17, 1933. Senate called to order by the President.

Prayer by the Rev. L. D. Porter of Gardiner

Journal of yesterday read and approved.

Mr. Kitchen of Aroostook, out of order and under suspension of the rules presented the following order

Out of order and under suspen-sion of the rules the President laid before the Senate, Report of the Committee on Legal Affairs "Ought to Pass" on bill, An Act to amend the charter of the Northport Wes-leyan Grove Camp Meeting Asso-ciation (H. P. 158, L. D. 635). The PRESIDENT: The Chair

will state that in the Senate this morning the report on this bill was accepted and the bill given its first reading in concurrence. It now de-velops that the bill as it came from the House was passed to be en-grossed as amended by House grossed as amended by House Amendment "A". Is it the pleasure of the Senate that we reconsider our action of this morning whereby this bill was given its first reading?

Thereupon, the Senate voted to reconsider its action taken earlier in today's session whereby this bill was given its first reading, House Amendment "A" was read and adopted in concurrence, the bill was given its first reading as amended in concurrence and next Tuesday afternoon at five o'clock assigned for second reading.

On motion by Mr. Kitchen of Aroostook, the Senate voted to take from the table, An Act permitting small town polls to close at five o'clock in primary elections (H. P. 612, L. D. 180), tabled by that Senator earlier in today's session pending second reading.

Mr. KITCHEN of Aroostook: Mr. President and Senators, I tabled this bill this morning because of the fact that the election laws of the State of Maine are all uniform at the present time. Not knowing what the bill provided and also assuming that the Committee on Ju-diciary had given it serious con-sideration and passed their approv-al upon it and also learning that the bill provides that towns of 300 inhabitants or less may close their polls at five o'clock in the after-noon, I think I can see where it might be of advantage to the small towns and for that reason I move that the bill be given its second reading.

Thereupon, the bill was given its second reading and passed to be engrossed.

The PRESIDENT: Our calendar is in very good shape for this sea-son of the year, the Senate hav-ing carried over from yesterday only seven items on the table and only a few having been tabled today. If, however, any of these tabled matters can now be taken from the table and sent along their course it will be a step in the di-rection of progress. If there is nothing further to be taken from the table at this time way the the table at this time may the Chair express the hope that next week we will try to make plans to clean the calendar and refer all matters possible to a committee, that our committees may be en-couraged to act on these matters and send in their reports promptly.
