Mr. KITCHEN of Aroostook: Mr. President, I would like to inquire of the Chair whether it is necessary to specify the number of copies to be printed of bills laid upon the table for printing under the joint rules.

I am sorry that I neglected to do this at the proper time.

The PRESIDENT: The Senator from Aroostook, Senator Kitchen, moves that, notwithstanding the number fixed by the joint rules, the new draft of Legislative Document 10, which comes in as a report from the Committee on Ways and Bridges this morning, fifteen hundred copies of the new draft be printed.

The motion prevailed.

On motion by Mr. Jackson of Cumberland, the Senate voted to take from the table, An Act granting preference to Maine Bidders (H. P. 153) (L. D. 85), tabled by that Senator on February 16th, pending first reading; and on further motion by the same Senator the bill was given its first reading and tomorrow assigned for second reading.

On motion by Mr. Viles of Kennebec, the Senate voted to take from the table, House Report from the Committee on Banks and Banking, "Ought to Pass" on "An Act to

Provide a Penalty for Circulating False Reports. Concerning Banks, Loan and Building Associations and Insurance Companies," (H. P. 1025) (L.
