I think the President, Senator Murchie, will bear me out and the Secretary, Mr. Brown, will remember that Senator Page wished me to take this from the table at this time.

The PRESIDENT: The Chair will state that yesterday the Senator from Somerset, Senator Page, when he found that he had to leave Augusta and could not be present today, requested the Chair and the Secretary to see that this matter was taken from the table and turned over to the Senator from Waldo, Senator Cooper, for whom the Senator from Somerset, Senator Page, tabled it.

On motion by Mr. Holmes of Androscoggin, the Senate voted to take from the table, Senate Report from the Committee on Judiciary, "Ought to Pass" on An Act to Repeal the Organization of the Plantation of Chesuncook, (S. P. 108), tabled by that Senator on February 28th pending acceptance of the report;

and on further motion by the same Senator, the report of the commit-tee "ought to pass" was accepted; and the bill was laid upon the table for printing under the joint rules.

Mr. HOLMES of Androscoggin: Mr. President, I rise to make an in-quiry. The 17th unassigned matter on our calendar, Resolve relating to fishing in Whitney Brook, Legislative Document 34, appears on the calendar as having been tabled by me. I should like to ask the Chair to ascertain from the Secretary whether or not that is a misprint, a mistake.

The PRESIDENT: It is the recollection of the Chair that an order was prepared to be presented by the Senator from Androscoggin, Senator Holmes, which was later changed, because of the absence of the Senfrom Androscoggin, Senator ator Holmes, to the Senator from Androscoggin, Senator Winn. It now improperly appears on the calendar in the name of the Senator from Androscoggin, Senator Holmes.

This is an enactor which was recalled from the office of the Governor at the request of the Secretary to the Governor. Mr. HOLMES: I understand and

thank the Chair.

The **PRESIDENT**: Since this matter appears on the calendar in the name of the Senator from Androscoggin, Senator Holmes, will that Senator be willing to move reconsideration so that this resolve may be again finally passed and presented to the Governor?

Thereupon, on motion by Mr. Holmes of Androscoggin, the rules were suspended and the Senate voted to reconsider its former action whereby this resolve was finally passed.

The PRESIDENT: The Chair will state that this resolve was omitted from those signed by the Governor before he departed for Washington and the Secretary to the Governor advised that the Governor intended to sign the resolve. It was recalled from the Governor's office in order that it might not become a law without his signature.

Thereupon, on further motion by Mr. Holmes of Androscoggin, the resolve was again finally passed.

On motion by Mr. Viles of Ken-nebec, the Senate voted to take from the table, Resolve appropriating money to pay the claim of Madawaska Company of Van Buren against the State of Maine (S. P. 205, L.
