HOUSE

Tuesday, February 19, 1935. The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Mc-Whorter of Augusta.

Journal of the previous session read and approved.

The SPEAKER: The Chair will call the attention of the members to a corrected reprint of L. D. 339, on your desks this morning. This document is substituted for the original print, L. D. 339, in your document book.

From the Senate: Bill an act relating to the practice of chiropractic, S. P. 394, L. D. 417, which was referred to the committee on Public Health in non-concurrence in the House on February 13th.

In the House:

Mr. BUBAR of Blaine: Mr. Speaker, this is a bill that requires a legal opinion, and, as a member of the committee on Public Health, I move that we recede from our former position and concur with the Senate.

Unanimous consent was given the gentleman from Pittsfield, Mr. given Cook, to introduce out of order, and under suspension of the rules a bill.

Mr. COOK: Mr. Speaker and members of the House: This is a $_{\mathrm{the}}$ bill relating to Pittsfield Municipal Court. This bill was drawn at the suggestion of our County Attorney and Sheriff of Somerset County to take care of an unusual situation that arose in an unusual situation that arose in Pittsfield the past week. Under the statute of 1901, the Pittsfield Municipal Court was given ex-clusive jurisdiction in all cases. Later this law was amended to except misdemeanors, but at pres-ent the court has exclusive juris-diction in matters of felony. As a result of the death last week of Judge Haley, we are faced with a peculiar situation in Pittsfield of peculiar situation in Pittsfield of having no jurisdiction in cases of felony. At the present moment, a person committing a felony in Pittsfield cannot be held. This situation arose last week and the person, after he had confessed to a breaking and entering—the sheriff was forced to release him. As a result, we are asking unanimous

consent to introduce this bill which will remedy the situation and give the people of Pittsfield proper pro-tection while we are without a judge. I should like to ask that the bill be given its several readings at this time, without reference to a committee.

The SPEAKER: The gentleman from Pittsfield, Mr. Cook, now moves that the rules be suspended and the bill given its three several readings at this time.

The motion prevailed, and H. P. 1442, bill an act relating to the Pittsfield Municipal Court had its three several readings, under sus-pension of the rules, without refer-ence to any committee, and was passed to be engrossed.

Orders of the Day

On motion by Mr. Hill of South Portland, it was voted to take from the table the tenth unassigned matter, Memorial to Congress requesting passage of Frazier-Lemke Re-finance Bill, H. P. 1416, tabled by that gentleman February 15th, pending adoption.

Mr. HILL: Mr. Speaker, may I sk that the Memorial be again ask read by the Clerk?

(Memorial read by the Clerk)

Mr. HILL: Mr. Speaker, I move that the Memorial be indefinitely postponed.

This Memorial is not a proposal that originated with the gentleman from Brunswick (Mr. Lebel). If it were, I might be more reluctant to oppose it; but it is a proposal that has been sent here from Washington,-as I understand it sent here by the proponents of this Frazier-Lemke bill, drafted in Washington, sent to this Legislature with the idea that, if it is passed here, it may be said in Washington that the State of Maine, together with twenty-two other states referred to in the Memorial, has endorsed the passage of this Frazier-Lemke bill.

Now we are gathered here, the Legislature, for the purpose of transacting business which pertains to and concerns the State of Maine. This question raised by this Memo-This question faised by this metho-rial is purely a national question. We elect our Representatives to Congress and our United States Senators to go to Washington and consider methods of patients of consider matters of national con-They have the opportunity cern. to inform themselves upon the merits of such legislation as this. Com-mittee hearings are held in Washington and our Representatives may attend and hear all the arguments pro and con on these important measures. 1 am content, for one, to leave such a matter as this to the good judgment of our United States Senators and Representatives in Congress. I do not feel, per-sonally, that I am sufficiently informed upon the merits of this Frazier-Lemke bill to be ready to go on record as voting that it ought to pass without further delay, as the Memorial says; and I believe there is a very considerable number of the members of this House who would likewise feel that we ought not to go on record officially as urg-

ing the passage of this bill without knowing more than we now know about it. For these reasons I hope that the House will indefinitely

postpone the Memorial. Mr. LEBEL of Brunswick: Mr. Speaker and members of the House: It is not a pleasure for me to stand up here and attempt to "buck up" against my friend from South Port-land (Mr. Hill). I know he has a much larger following than I have; but I do feel that I would be a coward if I did not back up that resolution. The gentleman from South Portland has told us that it would not be good for Maine to get in line with the other states in con-In line with the other states in con-sidering this national measure, but I notice that he has told you very little about the bill itself. Undoubt-edly not all of you have had copies of this bill and for that reason I brought it down here. The pur-pose of the act, as stated in it, is to place agriculture on a basis of equality with other industries by equality with other industries by the establishment of an adequate credit system for the refinancing of farm indebtedness at low rates of interest. It appropriates \$100,-000.00 to be raised by the issuance of farm land bonds bearing interest at the rate of one and one-half per cent through the Farm Credit Administration. It creates a Board of Agriculture, composed of one member from each state, elected by delegates chosen by the farmers of the different states themselves. The delegates would meet at their respective State capitols and elect a member from among themselves to represent the State on the Board. Now those forty-eight members from the different states will get together in Washington, organize and elect from among themselves an executive committee of three to administer this act. The other forty-five members of the Board will remain will remain in touch with their ex-ecutive committee and advise them as to the way the act works in the different states.

The benefits of this act would also apply to farmers who have lost their farms, not only recently but way back to 1921, provided they de-sire to buy them back or purchase other farms.

The members of the Board will receive a per diem of \$15.00 for the time actually spent in administer-

ing this act. Now, Mr. Speaker, and members of the House, we hear a lot about

helping the farmers. I am not a farmer, but I was brought up on a farm and my parents still own and operate a farm; so I know what they are up against. There are a lot of farmers in the House and Senate and here is an opportunity to do something for the farmers. This bill is sound, I have read it, and I think it is a good proposition. I have nothing personal to be gained in this matter, and if you want to turn the farmers down, go ahead. Here is something we can do for the farmers without the State spending a single penny. I thank you.

On motion by Mr. Thompson of Belfast, a viva voce vote being taken, the matter was retabled and specially assigned for Thursday morning, Feb. 21.

On motion by Mr. Davis of Newfield, it was voted to take from the table the second unassigned matter, bill an act relative to powers and duties of Inland Fish and Game wardens, H. P. 1259, L. D. 490, tabled by that gentleman February 12, pending reference; and on further motion by the same gentleman, the bill was referred to the committee on Inland Fisheries and Game.

On motion by Mr. Smith of Bangor, it was voted to take from the table the sixth unassigned matter, bill an act relative to the granting of licenses for certain businesses and purposes by the city of Bangor, H. P. 451, L. D. 127, tabled by that gentleman, February 14th, pending third reading; and on further motion by the same gentleman the bill had its third reading and was passed to be engrossed.

Passed to Be Enacted

(Emergency Measure)

The SPEAKER: This being an emergency measure, it is necessary that it have the affirmative vote of two-thirds the entire membership of the House. All those in favor of the passage of this bill to be enacted will rise and stand in their places until counted, and the monitors will make and return the count.

One hundred and forty-four voting in the affirmative, and none in the negative, the bill was passed to be enacted.
