On motion by Mr. Willey of Fal-mouth, it was voted to take from the table the fourth unassigned matter, bill an act to tax games of skill, H. P. 1415, L. D. 633, tabled by that gentleman on February 20 pending third reading.

The same gentleman House Amendment A and moved its

adoption, as follows:

House Amendment A to H. P. 1415, L. D. 633, bill an act to tax games of skill.

Amend said bill by striking out the following words after the word "be" in next to the last line of Section 8: "added to and shall constiand inserting in place thereof the following: 'shall be credited to the old age pension fund and used for the purpose of carrying out the provisions of chapter 267 of the public laws of 1933.

Mr. WILLEY: Mr. Speaker, this measure came into this House with the unanimous ought to pass report from the committee on Taxation. This measure, without the adoption of this amendment, provides for a ten dollar tax on each and every so-called game of skill within this State. It was developed at the hearing that there now exists in play in this State over ten thousand of these machines, and that tax, to-orthor with a twenty-five dollar tay. gether with a twenty-five dollar tax

on every distributor of these so-called games of skill, would yield to the State annually approximately \$115,000.

We have been born into a world in which for more than one hundred years the inhabitants have passed their lives guided largely by habit and tradition. During each generation a few individuals have been inclined to break away from the established standards of thought and action, and it is with these few that we associate the forward movements in Humanity's struggle with the conditions of life. We are impelled by circumstances to recognize a great change in our economic condition. We are compelled to recognize the bold fact that we must do something for our aged. Our resources are limited, and thus limited must be our action, but we can at least show our good intention by setting up this revenue received from property heretofore tax free as the beginning of an old age pension fund; and I again urge the adoption of this amendment.

On motion by Mr. Mason of Mechanic Falls, the bill and amendment were tabled pending adoption of House Amendment A.

On motion by Mr. Richardson of South Portland, it was voted to take from the table the fourteenth unassigned matter, bill an act to make Walid the doings of the Harrison Water Company and to define and confirm its powers, H. P. 606, L. D. 178, tabled by that gentleman February 27th, pending third reading; and on further motion by the same gentleman the bill had its third reading and was passed to be engrossed.

On motion by Mr. Flanders of Auburn, it was voted to take from the table the first unassigned matter, House report ought not to pass of the committee on Legal Affairs on bill an act creating a Public Bequest Commission, H. P. 104, L. D. by tabled that gentleman February 13th, pending acceptance of the report; and on further motion by the same gentleman the bill was recommitted to the committee on Legal Affairs for further consideration.

On motion by Mr. Leonard of Hampden, it was voted to take from the table the fifth unassigned matter, final report of the committee on Federal Relations, tabled by that gentleman February 22 pending acceptance.

Mr. LEONARD: Mr. Speaker, in explanation I would state that we only had one bill before this committee and we thought there would be no more; so we rendered a final report, the effect of which would be to dissolve the committee. informs me Speaker now there may be other bills to come before us, and I therefore move that this report be recommitted to the committee for further consideration.

The motion prevailed and the report was recommitted to the committee on Federal Relations in nonconcurrence.
