HOUSE

Tuesday, March 12, 1935.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. H. W. Brown of Gardiner.

(Mr. Hill of South Portland assumed the Chair as Speaker pro tem, amid the applause of the House.)

Mr. Lebel of Brunswick, presented the following order and moved its passage:

Whereas, it is the duty and intention of the Legislature to keep the expenditure of the State within its income, and

Whereas, it appears that some \$40,000.00 a year might be saved by the setting up of an adequate system of self-insurance for the State. and

Whereas, several states now hav-ing such systems report satisfactory operation and substantial savings, now therefore, be it

Ordered, the Senate concurring, that

A non-salaried interim commission is hereby created to be known as the State Insurance Fund Commission, composed of five members, one from the Senate, appointed by the President, and two from the House, appointed by the Speaker. The other two members of the commission shall be the State Insurance Commissioner and the Revisor of Statutes.

The duty of the commission shall be to study the possibilities and soundness of setting up a state in-surance reserve fund against which State property could be insured, as The commisan economy measure. sion shall include in the scope of its survey the various self-insurance plans of other states and shall collect data on the financial possibili-It shall investigate the availties. ability of an adequate loan from the Federal Government or some private agency for the purpose of setting up the reserve fund. If, upon completion of its survey,

the commission finds the self-in-

surance plan to be practical and sound, it shall, with the advice and assistance of the Attorney General, prepare any acts as in its opinion will create an adequate State reserve insurance fund for the protection of the State and provide as well for the protection of said fund from being diverted to any use other than that for which it is created. The commission shall also prepare comparative figures based on previous expenditures by the State for insurance of State property, showing an estimate of how long it would take to liquidate the necessary loan out of the yearly savings realized under the self-insurance plan.

The commission shall prepare its report in printed form for the members of the Eighty-eighth Legislature and transmit same to them not later than the second week in the session of 1937. The commission session of 1937. The commission shall serve without pay, except that the three appointed members shall receive a per diem of \$5.00 for time spent and their necessary expenses incurred in the discharge of their duties, same to be charged, together with all other necessary expenses of the commission, to legislative expense.

All departments of the State havsome relation to the subject ing studied under the provisions of this order are hereby directed to cooperate with the commission herein created at all times and all available existing State facilities such as office space and supplies, secretarial help et cetera shall be employed as far as possible so as to keep the expenses of the commission at a minimum. House Amendment A to S. P. 458, L. D. 657, entitled "An Act Relating to Temporary Loans by County Commissioners.'

Amend said bill by striking out all after the enacting clause, and inserting in place thereof, the following:

R. S., c. 92\$21, Amended. Section 21 of chapter 92 of the revised statutes, as amended, is hereby further amended to read as follows:

'Sec. 21. County Commissioners May Provide for Temporary Loans. The county commissioners of Cumberland and Kennebec counties may, without obtaining the consent of their respective counties, raise, by temperary loan to be paid within 1 year from the time when the same is contracted out of money raised during the current year by taxes, sums not exceeding \$175,000 and \$50.000 respectfully in any year for use of their respective counties and cause notes or obligations of their respective counties with cou-pons for lawful interest to be issued for payment thereof as aforesaid. The county commissioners of each and every other county may with-out obtaining the consent of their county raise by temporary loans to be paid within 1 year from the time when the same is contracted out of money raised during the current year by taxes not exceeding 1-5 of 1 per cent of the assessed valuation of their respective counties

House Amendment A was adopted, and the bill as amended was passed to be engrossed.

On motion by Mr. Higgins of Ellsworth, it was voted to take from the table the twenty-eighth unassigned matter, bill An act for use of temporary number plates, S. P. 139, L. D. 55, tabled by that gen-tleman on March 8th pending as-signment for third reading, and the same gentleman offered House Amendment A, and moved adoption, as follows: its

House Amendment A to Senate

Paper 139, Legislative Document 55. Amend Senate Paper 139 by striking out section three thereof and inserting in place thereof the following:

 \mathbf{Cost} "Section 3. of number plates. The secretary of state may issue temporary plates to bona fide dealers who request them under such rules and regulations as he shall deem necessary and shall receive for them fifty cents per pair."

Thereupon, House Amendment A and the bill as amended was assigned for third reading tomorrow morning.

On motion by Mr. Tupper of Calais, it was voted to take from the table the third unassigned matter, joint_order_relative_to closed banks, H. P. 1607. tabled by on March 6th that gentleman pending passage. Mr. TUPPER

of Calais: Mr. Speaker, since the Federal Govern-ment is liquidating our closed Na-tional banks, and our State banks are being liquidated by court pro-cedure, I think this House would be out of order in passing an order investigating that procedure. Therefore I move the indefinite postponement of the order.

The motion prevailed.

Mr. CONNOLLY of Portland: Mr. Speaker, I presented the order-The SPEAKER: For what pur-

pose does the gentleman rise? Mr. CONNOLLY: I rise to ask for

a standing vote, Mr. Speaker. 'The SPEAKER: Do you doubt

the vote?

Mr. CONNOLLY: Yes, sir. The SPEAKER: The gentleman from Portland. Mr. Connolly, doubts the vote. All those in favor of the motion to indefinitely postpone the order will rise and stand until $counted,\ and\ the\ monitors\ will make and return the count.$

A division of the House was had Eighty-three voting in the affirmative and one in the negative, the motion to indefinitely postpone prevailed.

On motion by Mr. Drisko of Jonesboro, it was voted to take from the table the tenth unassigned matter, bill an act for placing the word "Vacationland" on all number plates on motor vehicles, H. P. 106. L. D. 675, tabled by that gentleman on March 6th, pending third reading; and on further motion by the same gentleman the bill was given its third reading and passed to be engrossed.

On motion by Mr. Carswell of Gorham, it was voted to take from the table the fourteenth unassigned matter, House report ought not to pass of the committee on Claims on resolve in favor of William H. Rowe, of Buxton, H. P. 1106, tabled by that gentleman on March 6th pending acceptance; and on further motion by the same gentleman the report of the committee was accepted.

On motion by Mr. Hill of South Portland, it was voted to take from the table the twenty-sixth unassigned matter, bill an act relating to the counting and sealing of ballots, H. P. 1181, L. D. 387, tabled by that gentleman on March 7th pending passage to be enacted.

Mr. HILL of South Portland: Mr. Speaker, for the purpose of enabling me to offer an amendment to correct a technical error that has been discovered in the form of the bill, I move that the House suspend the rules and reconsider its former action whereby the bill was passed to be engrossed.

The motion prevailed, and the

same gentleman offered House Amendment A as follows, and moved its adoption:

House Amendment A to House Paper 1181, Legislative Document 387, bill an act relating to the counting and sealing of ballots. Amend said bill by striking out

Amend said bill by striking out in the eleventh line of the second paragraph thereof the words "affix to said package," and inserting in place thereof the word 'file."

Further amend said bill by striking out wherever they occur therein the words "sworn statements," and inserting in place thereof the word 'certificates.'

Thereupon, House Amendment A was adopted and the bill as amended was passed to be engrossed.

On motion by Mr. Mace of Augusta, it was voted to take from the table the fifteenth unassigned matter. House report ought not to pass of the committee on Judiciary on bill an act relative to the size of mirrors on motor vehicles. H. P. 1174, L. D. 380, tabled by that gentleman on March 7th pending acceptance; and on further motion by the same gentleman the report of the committee was accepted.

On motion by Mr. Stilphen of Dresden, it was voted to take from the table the sixteenth unassigned matter, House report ought not to pass of the committee on Judiciary on bill an act relating to penalty for second offenders on drunken driving, H. P. 336, L. D. 106, tabled by that gentleman on March 7th pending acceptance; and on further motion by the same gentleman the report of the committee was accepted.

On motion by Mr. Thompson of Belfast,

Adjourned until ten o'clock tomorrow morning.
