Mr. LEONARD: Mr. Speaker and members of the House: I tabled this bill so that it could receive a little more consideration and discussion. It simply provides that this Commission can spend the small yearly amount allowed them. At present they cannot spend one cent for office supplies, even, without the consent of the Governor and Council. No Governor and Council of this State were ever confronted with so many vital things both inside and outside this State, and smaller matters are apt to be pushed aside.

The increase of wages for an employee in any department is a very rare occurrence. The heads of de-partments want to be fair. In hiring new help, they pay more than they should because they know these clerks will never receive more, no matter how efficient they may be-There is no incentive for come. clerks to take a great interest in their work. Should one excel under these conditions, they step out into a new position and another one has to be trained on a middle-of-theroad salary.

Other departments spending large sums now have this right, and recently the Liquor Commission was given this authority. This Utilities Commission, the court of the peo-ple, could and should be trusted above all other departments with this privilege.

Mr. Speaker, I move that the bill be substituted for the report, and

that it have a passage.

The SPEAKER: The gentleman from Hampden, Mr. Leonard, moves that the bill be substituted for the ought not to pass report.

Mr. HATHORN of Bangor: Mr. HATHORN of Bangor: Mr. Speaker, do I understand that the gentleman moves the acceptance of the report?

The SPEAKER: The gentleman does not; he moves that the bill be substituted for the report, which

is ought not to pass.

Mr. HATHORN: Mr. Speaker, I signed the ought not to pass report of the committee on the bill. I will say that when the committee heard this bill there was just one proponent of the bill, and there was no opponent at all. After the hearing on the bill, and checking up on it, we found that the Utilities Commission, to our satisfaction, did not want the bill passed. They are not interested in having the bill passed. They say they are not having any difficulty in handling the Commission as is. The Commission thought that the bill should not pass, and it came out of the committee with a unanimous report ought not to pass. I make the motion that the report of the
