measure; NOW THEREFORE BE IT OR-DERED that the Justices of the Supreme Judicial Court are hereby respectfully requested to give to the House, according to the provisions of the Constitution on this behalf, their opinion on the following question, to wit:

legislation proposed measure to raise revenue within the meaning of Section 9 of Article IV of the Constitution, which required that revenue bills shall originate in the House of Representatives?

In explanation I would like to say that this is a local proposition having reference to Chandler river and its dredging, and I am presenting it at the request of our Congressman, Honorable Ralph O. Brewster. I wish to have this Memorial put through.

Memorial to the Honorable Sen-ate and House of Representatives of the United States of America in Congress assembled.

We, your Memorialists, the Senate and House of Representatives of the State of Maine in the 87th Legislative session assembled, most respectfully present and petryour honorable body as follows: petition

WHEREAS, the deposit of sawdust from mills with alluvial deposits has made it impossible for large barges to navigate the Chandler river, and

WHEREAS, it is not possible to economically transport the products of the district unless the products are moved in large quantities; now

therefore, be it RESOLVED: that we, your Memorialists, the Senate and House of Representatives of the State of Maine in Legislature assembled, do hereby respectfully petition and urge that necessary action shall be taken by the Congress, so that Chandler river in the State of Maine will be dredged so that the channel will be clear from obstruction as far as it is navigable, and be it further

RESOLVED: that a copy of this Memorial, duly authenticated by the Memoriar, duly authenticated by the Secretary of State, be immediately transmitted by the Secretary of State to the proper officers and committees of the United States Senate and House of Representatives, and to each of the Representatives and Senators representatives the State of Meine in the United States ing the State of Maine in the United States Congress. I notice this House has very economical tendencies, which is to be admired. We must save money on our wooden mallets, and I have something with me to replace that mallet, and I will guarantee that it will not break. It can be used not only for the purpose of pounding the table, but it can be used also to quiet some of the unruly

ones, including myself.

I hope the Speaker will accept this little mallet; it is big enough and strong enough, and made out of rubber, and accept it without controversy. (Applause)

Mr. DRISKO: Mr. Speaker, as this matter has been taken care of under another bill, I move that we accept the report of the committee.

Thereupon, the report of the committee was accepted.

The Chair lays before the House the second matter tabled and today assigned, bill an act relating to applications for licenses, H. P. 443, L. D. 121, tabled on March 29 by the gentleman from York, Mr. Young, pending first reading; and the Chair recognizes that gentleman.

On motion by Mr. Young the bill was given its first two readings and the same gentleman offered House Amendment A and moved its adoption, as follows:

House Amendment A to H. P. 443, L. D. 121, entitled an act relating to applications for licenses. Amend said bill by striking out all after the enacting clause, and substituting the following in place thereof:

"R. S., c. 29, additional. Chapter 29 of the revised statutes is hereby amended by adding thereto a new section to be known as Section 33-A, and to read as follows:

'Sec. 33-A. Operators licenses issued, only when poll tax has been paid. No person required by law to pay a poll tax in this State shall be granted an operators license unless his poll tax for the previous year has been paid.

To facilitate the administration of this act, the secretary of state shall cause to be placed on the application blank for an operators license the following question: "Have you paid your poll tax for the previous year?""

Thereupon, House Amendment A was adopted.

Mr. YOUNG: Mr. Speaker, as I wish every member of this House to have an opportunity to study this amendment, I now move that the bill and amendment be tabled and that 500 copies of the amendment be printed.

The SPEAKER: Will the gentleman kindly withdraw his motion to table in order that this bill may have its third reading on Monday, and his motion that the amendment be printed can be made as a separate motion.

Thereupon, Mr. Young withdrew his motion and Monday afternoon at four o'clock was assigned as the time for the third reading of the bill; and on further motion by the same gentleman five hundred copies of the amendment were ordered printed.
