The SPEAKER: The Chair recognizes the gentleman from Milo, Mr. Peakes.

Mr. PEAKES: Mr. Speaker, it is my pleasure and privilege to announce that the gentleman from Dover-Foxcroft, Mr. Snow, is present in the House; and I move that he be conducted to the Governor to take and subscribe the necessary oath to enable him to discharge his official duties.

Thereupon, the Chair appointed Mr. Peakes of Milo, to conduct the gentleman from Dover-Foxcroft, Mr. Snow, to His Excellency, the Governor.

On motion by Mr. Ellis of Rangeley, out of order and under suspension of the rules, that gentleman was granted permission to introduce a bill.

Mr. ELLIS: Mr. Speaker, just a word of explanation of this bill. It is an act relating to old age assistance. As the old members know, we had practically this same bill in the last special session, passed by both branches and vetoed by the Governor. At the present time the understanding is that there are no funds with which to pay old age assistance which comes due this month or in the months to follow. This is a serious emergency and we hope that you will all favor this bill. It is just a stop-gap for six months, when I hope we will have something set up permanently so that we can take care of it in the future.

The bill calls for a ten per cent tax on the sales price of liquors, to be administered, as in the past, by the Governor and Council to pay pensions to the aged. I think that is all it is necessary for me to say now. I move that the bill be temporarily tabled and that five hundred copies be printed.

The motion prevailed and the bill was temporarily tabled and five hundred copies ordered printed.

From the Senate: Resolve in favor of a memorial to the Maine Volunteer Signal Corps (S. P. No. 39)

Comes from the Senate, referred to the committee on Appropriations and Financial Affairs.

In the House:

Mr. PHILBRICK of Cape Elizabeth: Mr. Speaker, I move that this resolve be referred to the committee on Military Affairs in nonconcurrence. Eith er committee might properly consider the resolve but it seems in some ways better practice to let the committee on Military Affairs consider it first, then, if that committee approves the resolve, it can be examined by the committee on Appropriations and Financial Affairs.

The motion prevailed and the resolve was referred to the committee on Military Affairs in non-concurrence.

At this point Mr. Peakes of Milo, reported to the House that the gentleman from Dover-Foxcroft, Mr. Snow, had taken the necessary oath to qualify him to enter upon his official duties.

The SPEAKER: The House thanks the gentleman from Milo, Mr. Peakes, and welcomes to the House the gentleman from Dover-Foxcroft, Mr. Snow. The Chair will assign to that gentleman Seat No. 5 and the gentleman from Milo, Mr. Peakes, will kindly escort the gen-tleman from Dover-Foxcroft, Mr. Snow, to his seat.

Thereupon, Mr. Snow was escorted to his seat amid the applause of the House.

From the Senate: Report of the committee on Appropriations and Financial Affairs on bonds of the State Treasurer, reporting that the same are found to be in proper order and suggesting that they be accepted and placed on file with the Secretary of State.

Mrs. Latno of Old Town, presented the following proclamation:

PROCLAMATION

On Thursday, January 21, 1937, the Third General Assembly of the Council of State Governments will convene for a four-day session in Washington, D. C. The official delegates to the Assembly will deliberate and take action upon important problems involving co-operative action by the states with each other and with the federal government. Specific recommendations, some in the form of proposed model legislative measures, model compacts, or model administrative agreements, will be presented to the Assembly by the following official affiliates of the Council of State Governments:

Interstate Commission on Conflicting Taxation

ing Taxation Tax Revision Council

Interstate Commission on Crime Interstate Commission on Social

Security Interstate Commission on the

Delaware River Basin

Interstate Commission on Council Development

Interstate Commission on Conservation

The Assembly will also consider and debate other problems necessitating interstate co-operation in new fields, and will make recommendations to specialized Interstate Commissions and National Associations for further action.

This call is issued to Speaker of House, Maine, for official action.

Each of the forty-eight states is entitled to send three voting delegates, one to represent the Senate, one to represent the House of Representatives, and one to represent the Governor. The Governor of each state is an honorary member of the Assembly. In states having Commissions on Interstate Co-operation, the official delegates representative of the three official departments named above, shall be appointed by that Commission. In all other states the delegates shall be chosen by the Senate, the House of Representatives, and the Governor, separately. Prompt response to this call is earnestly requested.

The communication was received and ordered placed on file and resignation of Mr. Davis from the two committees named in the above letter was accepted.

The SPEAKER: The Chair will now appoint to the joint standing committee on Public Buildings and Grounds Mr. Snow of Dover-Fox-croft, and to the standing committee of the House on Bills in the Third Reading, the same gentleman.

The SPEAKER: The Chair at this time will appoint as Monitors: For the first division, Mr. Richardson of South Portland; second di-vision, Mr. Poulin of Biddeford; third division, Mr. Ryder of Orrington; and fourth division, Mr. Goss of Poland.

On motion by Mr. Ellis of Rangeley, it was voted to take from the table H. P. No. 63, Legislative Document No. 11, an act relating to old age assistance; and on further motion by the same gentleman, under suspension of the rules, the bill had its three several readings.

Mr. MAXIM of Portland: Mr. Speaker, it seems to me that in the paragraph headed "Continuation of Old Age Assistance," at the bottom of the first page, there is some ambiguity as to whether the sales price means liquor sold at retail only or whether it would include liquor sold at wholesale by the State Commission to the hotels. It would seem to me that that ought to be clarified.

The SPEAKER: Does the gentle-

man wish to present an amendment? Mr. MAXIM: Mr. Speaker, I would like to present an amendment.

Thereupon, the bill was tempo-rarily tabled for that purpose and the House was declared at ease.

(House at Ease)

Mr. MAXIM: Mr. Speaker, I withdraw my request that the bill be amended, it having been ex-plained to my satisfaction.

On motion by Mr. Maxim, the bill was taken from the table; and on further motion by the same gentleman the bill was passed to be engrossed.

The SPEAKER: The Chair will explain that this bill, having been passed to be engrossed, must now be engrossed, which may take some The members should little time. remain within sound of the gong in order that they may reassemble when it becomes necessary to take further action on this measure.

On motion by Mr. Ellis of Rangeley, the House recessed to assemble at the sound of the gong.

After Recess

On motion by Mr. Ellis of Rangeley, it was oted to take from the table the joint order relative to time of adjournment; and on further motion by the same gentleman the order was passed in concurrence.

On motion by Mr. Flanders of Auburn, it was voted to take from the table ordered tabled by that gentleman earlier in today's session in regard to the appointment of a delegate to the Third General Assembly of the Council of State Gov-ernments at Washington; and on further motion by the same gentleman the order was indefinitely postponed.

Out of order, bill on its passage to be enacted.

H. P. 63, L. D. 11: An act relating to old age assistance. The SPEAKER:

This being an emergency measure, it is necessary that it have the affirmative vote of two-thirds of the entire elected membership of the House. Mr. ELLIS of Rangeley: Mr. Speaker, when the vote is taken, I

move that it be taken by the yeas and nays.

The SPEAKER: The gentleman from Rangeley, Mr. Ellis, has moved that when the vote is taken, it be taken by the yeas and nays. Before the yea and nay vote can be ordered, it is required that one-fifth of the members present shall signify their desire that the vote be taken by roll call. Those in favor of the roll call will rise and stand until counted, and the monitors will make and return the count.

A division of the House was had.

The SPEAKER: More than a sufficient number obviously having arisen, the yea and nay vote is ordered. Is the House ready for the question?

Mr. POULIN of Biddeford: Mr. Speaker, at the last special session of the 87th Legislature a bill similar to this one presented here today was introduced in the House. Some objectionable features at that time made it disagreeable for some members to vote in its favor, but this bill today appears in my opinion to have eliminated those disagreeable features. Therefore I earnestly hope that this bill has unanimous passage.

The SPEAKER: Is the House ready for the question? The pending question is on the passage of H. P. 63, L. D. 11, bill an act relating to old age assistance, on its passage to be enacted. All those in favor of the passage of this bill to be enacted will answer yes to the roll call and those opposed will answer no. The Chair will remind the members of the House that under the Rules they must remain in their seats until the roll call has been completed and the result announced. The Clerk will call the roll.
