#### In Convention

The President of the Senate, Senator Burns. in the Chair.

On motion by Senator Hussey of

Kennebec, it was Ordered, that a committee be appointed to wait upon His Excellency, Governor Lewis O. Barrows, and inform him that the two branches of the Legislature are in Convention assembled, ready to receive such communication as he may be pleased to make.

The Chairman thereupon appointed as members of that committee, on the part of the Senate: Senators, Hussey of Kennebec, Fernald of Waldo, and Marden of Kennebec. On the part of the House: Repre-Sentatives Flanders of Auburn, Mrs. Currier of Bangor, Hammend of Strong, Palmer of Island Falls, Cole of Kittery, Bruce of Belfast Donahue of Biddeford. and

Subsequently, Senator Hussey for the committee reported that the committee had discharged the duty assigned it, and that the Governor was pleased to say that he would attend forthwith.

The report was accepted and the committee discharged.

Thereupon, Governor Lewis 0 Barrows, attended by the Executive entered the Convention Council. Hall, the members of the Convention rising and applauding; and the Governor addressed the Convention as follows:

Mr. President and Members of the Eighty-Eighth Legislature:

In accordance with the provisions of Chapter 216 of the Public Laws of 1931, I respectfully submit herewith the Biennial State Budget for the fiscal years 1937-1938 and 1938-1939.

By direction of the Code it contains:

Part I The financial policy of the ensuing biennium and general budget summary, showing the relation between total proposed expenditures and the total anticipated receipts, with the means of financing the budget for each year; showing also contrasting figures for the last completed year and the present fiscal year.

Part II. The detailed budget es-timates of revenues and recommended appropriations for expenditures.

- Part III. The appropriation act. The bonded indebtedness of state government.
  - The debt redemption requirements.
  - The debt authorized and unissued and the condition of trust and sinking funds.
  - The titles of budget bills, together with recommended changes in statute to make effective proposed budget savings and economies.

The careful and at times tedious work on the part of the Budget Officer and the Legislative Advisory Committee on the Budget, composed of Senator Hussey and Representatives Flanders and Donahue, has been of great assistance and their work should be commended by each of you.

The problem of constant and pyramiding overdrafts in departmental operations without authorization by the legislature is a policy that this administration does not desire to pursue.

In the Weifare Department such a course has been followed to the extent that at the present time there is an actual cash overdraft of \$997.655.16. Of this amount the sum of \$842,992.41 represents an overdraft for the last fiscal year ending June 30, 1936. This amount was actually charged against the sinking fund reserve and should be replaced. In this respect the State is exactly like an individual. With the borrowing capacity of the State exhausted by those who preceded you, we are now actually in the position where we must have reve-nue to pay our bills.

With a knowledge of this fact, the Governor and Council are instructing the Commissioner of Health and Welfare to notify all cities and towns that on and after February 20, 1937, there will be no funds to reimburse municipalities for any kind of pauper support unless in the meantime funds and appropriations are provided. To meet this situation the sum of \$700,000 appears to be necessary. Included in this fig-ure would be such an amount as you determine to be necessary for continuation of so-called "Emergency Aid." Although the amount of \$50,000 was authorized by the last legislature, the sum of \$648,000 has already been expended for this purpose. This has been an actual cash overdraft and disbursements were made very largely in only one section of the State. While reports and investigations have convinced me that this function can be very greatly reduced, I doubt if it can be entirely eliminated in every one of these towns without actual starvation resulting. Naturally, we are all determined that this shall not happen, but the Legislature will be forced to provide the authority and the funds.

In addition to this, I feel that your investigation will probably indicate the advisability of making it possible for the State to assist the towns to some extent in the management of their affairs. M'smanagement in the past over a period of years has been a decided factor in leading up to the present situation and should be corrected, if possible.

The policy of making inadequate appropriations for certain departments for the discharge of the duties specifically provided for by law and thereby creating operating overdrafts should not be continued.

In some instances you will observe that increases in appropriations have been recommended in this budget so that such overdrafts would be eliminated, if possible. Consideration has likew'se been given to the increased needs of institutions, caused by the advance in commodity prices, as well as an increase in inmate population resulting from the building program now nearing completion. At the same time the estimates of expenditures for departments and institutions will require the exercise of every possible economy in administration.

As stated in the inaugural address, the distinction between the functions of the executive branch and the legislative branch are fully appreciated and the recommendations presented in the Budget are confined strictly to those activities and duties already established by law. No recommendations have been made for the requirements of any new activity.

The past administration established state participation in old age assistance without a proper legislative authority or means of financing. The amount of money necessary for continuing such assistance depends upon the conditions that may be enacted in an old age assistance law. Consideration of certain requirements of the Federal government will probably be necessary in your deliberations on this question, but until such a law is enacted, definite estimates as to the financial requirements are very difficult.

To provide more equitable educational opportunities for all the children in Maine should be the desire of every member of this legislature. The authorization of a means of equalization of educational burdens would appear to be as far as the State could be expected to go at this time. Again the Budget can recommend no definite amount until such a law has been enacted.

The State Contingent Fund was essentially exhausted on January 1st, 1937 and should be replenished to the amount of \$150,000 so that unforeseen emergencies and contingent expenditures may be met.

Unless additional funds are provided, new institutional buildings must remain vacant, because of lack of funds for maintenance and necessary additional employees, until the next fiscal year begins. It will be necessary to provide approximately \$47,000 for this purpose. The overdraft in the Depart-

The overdraft in the Department of Agriculture, resulting from the effort to eradicate Bang's Disease in cattle, amounts to \$39,700. Many of these claims have been outstanding for over a year and should be paid without further delay.

The deficiency appropriation bill amounting to \$1,969,386.16, will The shortly be presented to you. The variance of this figure with the amount stated in the inaugural message is accounted for by a revision of expenditures for pauper support. One-half of this represents a definite deficiency from the pre-ceding administration. Inasmuch as there are no surplus funds in the treasury, from which such a deficiency can be taken, this will re-quire new taxation commitments and should in no way be confused or mixed with any additional legislation which requires new expenditures.

The amortization of this obliga-tion over a period of years would cause serious cash embarrassment to the treasury. This obligation should be met in the shortest possible time, as the limited temporary borrowing capacity of the State only cares for necessary tax anticipation borrow-ings and should not be obligated for past expenditures and deficits.

Increases in appropriation recommendations have been made only after a most thorough study by the legislative budget committee, but it is well to point out in passing that many increases actually represent a very decided decrease in actual expenditures from the last administration.

In providing for the needs of existing departments and institutions, increases in recommended appro-priations of approximately \$750,000 each year have been made. These increases are represented principally in the requirements for institutions and the Department of Health and Welfare, amounting to \$579,000 for the first year and \$568,000 for the second year. With existing tax laws, even with the increases recommended, it has been possible to present to you a balanced budget, with a small overlay as a measure of safety, and at the same time maintain the tax rate in real estate that has prevailed for the past four years -seven and one-fourth mills.

In order to maintain a balanced budget, changes are recommended in certain mandatory provisions of law and these changes will be submitted to you very shortly in the form of a definite bill.

In recommending appropriations for the support of paupers and pensions for soldiers, sailors, etc, re-ductions in request have been made in the anticipation of the enactment of an old age assistance law. It is believed that this form of assistance would remove many such persons from their present kind of support.

In making appropriations for new activities of state government, it is well to again call to your attention that receipts from present sources of revenues are entirely exhausted in present departmental and institutional recommendations and in any new measures that you may en-act, it is essential at the same time to enact new revenue-producing laws.

In making these recommendations I have in mind the various administrations that are to follow. They should not be handicapped by any such legacy as we have inherited.

You may depend on every possible cooperation that the Executive De-partment is able to render you in your attempt to put the State of Maine on a sound financial basis. Establishing and maintaining the credit of the State largely depends upon the ability of meeting our obligations on time and in full. This can be done only by the adoption and the maintenance of a strong financial policy. With a cooperative spirit, I am confident that this

can be accomplished. (Applause) At the conclusion of the address the Governor and Council withdrew amid the applause of the Convention, the audience rising.
