Friday, March 5, 1937.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Webber of Hallowell.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

ulating and defining games of skill, S. P. 402, L. D. 812. Comes from the Senate, referred to the committee on Legal Affairs. In the House, on motion by Mr. Hinckley of South Portland, tabled pending reference to a committee in concurrence.

Mrs. LATNO of Old Town: Mr. Speaker, I move that the rules be suspended and that the gentlemen be allowed to smoke.

Mr. WEBBER of Auburn: Mr. Speaker—

The SPEAKER: For what purpose does the gentleman rise?

Mr. WEBBER: To make an amendment to the motion already made, Mr. Speaker. As I understood that motion, it was that the gentlemen be allowed to smoke. I would make an amendment that the members of the House be allowed to smoke. (Laughter)

The SPEAKER: The Chair would state that it is not possible to suspend the rules in part and keep them in force in part, but if the rules are suspended, the suspension applies to all members of the House.
