To the Honorable Senate and House of Representatives of the United States of America, in Congress assembled:

We, your memorialists, the thirty-ninth legislative assembly of the state of Oregon, convened in regular session, respectfully represent that:

Whereas under the federal farm loan act and the farm credit act of 1935 deficiency judgments are taken on mortgage securities on loans, and

Whereas there is now pending in the seventy-fifth Congress Senate Bill No. 816 by Senator Pope, a bill introduced on January 14. 1937 which amends the federal farm loan act and farm credit act of 1935, adding a new section, No. 13, to provide as follows: "No deficiency judgment shall be taken in the foreclosure of any first mortgage obtained as security for any loan; now therefore

Be It Resolved by the House of Representatives of the State of Oregon, the Senate jointly concurring

therein:

That the legislative assembly of the state of Oregon hereby does petition the congress of the United States to enact this proposed

States to enact this proposed amendment into law, and Be it further resolved that the secretary of state of Oregon, is hereby directed to send a copy of this memorial to the speaker of the house of representatives and the president of the senate, Washington, D. C., a copy to Senator Pope of Idaho, a copy to each senator and representative from the state of Oregon, and also a copy hereof to the speaker of the house and the president of the senate of each state legislature in the United States which shall convene during the year 1937.

carriers are contract carriers and their contracts are based upon competitive bidding, which, during the past four years, has been excep-tionally low and such carriers are underpaid, and

Whereas, the said star route mail carriers should be compensated for their faithful service during the past four years under exceptionally adverse conditions: now therefore

Be It Resolved by the House of Representatives of the State of Oregon, the Senate jointly con-curring therein:

That this thirty-ninth legislative assembly of the state of Oregon does hereby petition and memorialstates to pass the bill now pending before the congress of the United States to pass the bill now pending before the congress of the United States providing for the extension of the contracts of such carriers for the period of four years, and, be it further it further

Resolved that this thirty-ninth legislative assembly of the state of Oregon does hereby memorialize the congress of the United States to so amend such bill as to increase the compensation now paid to such car-

Mr. WEATHERBEE: Mr Speaker and Members of the House: This bill is a revenue measure, and a number of the members of the House have stated that they would like to consider it in connection with other revenue measures not yet reported out of committee. For that reason, they have asked me to retable this matter; and in deference to their wishes I move this bill be laid upon the table and specially assigned for a week from today, Tuesday, March 30th.

The SPEAKER: Are there any other matters that can be taken from the table and disposed of this morning?

Mr. HINMAN of Skowhegan: Mr. Speaker, I move you that the twenty-third unassigned matter be taken from the table, an act for the protection of Rhododendron Maximum Linnaeus and Kalmia Latifolia Linnaeus, S. P. 305, L. D. 516, tabled by myself on March 19th, pending passage to be enacted (Applause).

The motion prevailed, and the bill was taken from the table.

Mr. HINMAN: Mr. Speaker, it is my understanding that the word "rhododendron" was originally misspelled. It has now been corrected and I move that this bill be passed to be enacted.
