The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Hughes of Augusta.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

gress Assembled:

We, your Memorialists, the Senate and House of Representatives of this State of Maine in 88th legislative session assembled, most respectfully petition your honorable body as follows:

Whereas, one of the major menaces confronting the American farmer today is the "Noxious Weed";

Whereas, the 88th Legislature of the State of Maine is desirous of assisting the farmer in any way pos-

sible; now, therefore, be it Resolved: That the Senate and House of Representatives of the State of Maine respectfully urge the present Congress now in session to promptly enact H. R. 4009; and be it further

Resolved: That this Memorial be immediately transmitted by the Secretary of State to the proper officers and committees of the United States Senate and House of Repsent to resentatives, and a copy each of the Representatives and Senators representing the State of Maine in the United States Congress.

Mr. BROWN of Eagle Lake: Mr. Speaker. I have taken this matter up with our Commissioner of Agriculture and he agrees with me that it would be a good thing to do. At any time in the future, if we wanted to furnish any amount of money, Congress would give us three dollars for one.

The report was accepted, the rules were suspended and the bill given its two several readings and the next legislative day assigned.

Mr. WILKES of Portland: Mr. Speaker, I move to take from the table the second unassigned matter, majority report ought not to pass and minority report ought to pass of the committee on Military Affairs on resolve to provide for the completion of the payment of a bonus to Maine soldiers and sailors in the war with Spain, S. P. 52, L. D. 15, tabled on March 23rd, pend-

ing acceptance of either report.
Mr. FLANDERS of Auburn: Mr.
Speaker, I move that the resolve

and reports be tabled.
The SPEAKER: The gentleman's motion is not in order, no action or debate having taken place since the matter was taken from the table.
The Chair recognizes the gentleman from Portland, Mr. Wilkes.
Mr. WILKES: Mr. Speaker, I

was going to move that the majority report be acepted. I understood that it would take \$75,000 to make payments to the Spanish War Veterans. This certainly is a very worthy cause. I was informed by one of the members of the committee that there was not that amount on hand at the present time without a further tax or raising additional funds. Therefore I move that the majority report, ought not

to pass, be accepted.

Mr. FLANDERS: Mr. Speaker, as the gentleman from Portland (Mr. Wilkes) has said, this would necessitate the expenditure of some \$75,000, and I move that the matter lie on the table pending the motion of the gentleman from Portland, Mr. Wilkes, that the majority report be accepted.

The motion prevailed, and the bill

Mr. HIGGINS of Ellsworth: Mr. Speaker, I move to take from the table H. P. 1106, L. D. 416, bill an act relative to the Presque Isle Sewer District, tabled by me earlier in today's session.

The SPEAKER: The gentleman from Presque Isle, Mr. McGaughy, withdraws his motion that the bill be recommitted to the committee on

Bills in the Third Reading.

Thereupon, the report of the committee on Bills in the Third Reading, that no further verbal amendments are necessary, wa accepted, and on motion by Mr. McGaughy of Presque Isle, the bill was referred to the committee on Legal Affairs.

The SPEAKER: Are there any further matters that can be taken from the table and disposed of this

morning?

Mr. HINMAN of Skowhegan: Mr. Speaker, it is my understanding that there are some measures from the Senate to come over here at any moment, and, if in order, I move that we recess for a few moments.

#### After Recess

Papers from the Senate, out of order and under suspension of the rules.

From the Senate: The majority report and reports A and B of the committee of fifteen, created under Joint Order, S. P. 430, as amended, which was discreted to make the committee. which was directed to make a surwith reference to possible vev economy in administration of the affairs of State.

Augusta, Maine, March 24, 1937. "To the Senate and House of Representatives of the 88th Legisla-

fure:

By a Joint Order passed on the

11th day of March, 1937, which was clarified and amended by a second Joint Order passed on the 17th day of March, 1937, a Special Committee of 15 members, consisting of two on the part of the Senate and three on the part of the House, together with the ten members of the Joint Standing Committee on Appropriations and Financial Affairs, was appointed for the purpose of making a survey of the State Departments, and to promptly report to the Legislature such recommendations as it should deem necessary for the purpose of effecting economies in the management of state affairs, and to file with the Legislature such bills as it should recommend to effect such economy. Several meetings of this Commit-

Several meetings of this Committee of 15, so constituted, have been held, at which meetings a large number of more or less radical changes in the management of various State activities were suggested. Many of these proposals were radical in the extreme and without merit. The others, while possessing some merit, were such that they should not be recommended to this Legislature for adoption without extensive study which would entail an expenditure of time and money not available to the Committee at this time. The time already devoted to this survey has prevented the proper functioning of the Committee on Appropriations and Financial Affairs and, if continued at this time, will undoubtedly delay adjournment of the Legislature and interfere further with the work of the Committee which should now engage intensively in reporting on the large number of bills awaiting consideration.

For these reasons the undersigned members of the Committee feel that no further time should be devoted to the purposes of the Orders by the Committee, and that the Committee should be discharged from its duties.

In making this recommendation the Committee is not insensible to the need for effecting all possible economies in the management of our State Departments. It realizes that over he past decade the expense of government in this State has greatly increased. It believes that there are economies that possibly could be effected in our State departments. It feels, moreover, that if any department is overmanned, or is costing more to oper-

ate than it should, this condition is not due to any irregularities or illegal acts on the part of the heads of such departments, and that to pick out any one department for reduction of personnel or expense without a complete survey of the whole system of government would be unfair and destructive to proper government. The various heads of departments are not personally responsible for the increase of State expenditures. Every extension of State activity that has become effective within recent years has been due to demands made upon the State by some group of citizens and all of it has been authorized and made necessary by various legislative enactments.

The undersigned, therefore, recommend, (1) that the Committee be discha!ged from further consideration of economy measures at this time, and, (2) that a Joint Order be adopted which would place upon the Governor and Council the duty to investigate, or cause to be investigated, all the various departments of the State prior to the convening of the 89th Legislature and report the results of their survey together with such recommendations as they might deem proper regarding the financial affairs of the State."

Whereas the expenditures of the State have been substantially increased in recent years as the result of legislative enactment, and

Whereas expenditures in previous administrations have created large and oppressive financial problems that have increased the burdens of the taxpayers, and

Whereas it is realized that the economic condition confronting the State and its people is so serious that it must be alleviated in so far as may be possible, and it is recognized that additional time is necessary to make a sane and systematic survey of all State activities, and

Whereas it is the expressed desire of this Legislature to sponsor such effective and practicable re-trenchments as may be possible and not to rest with half-way measures, but to institute improvements that not only will decrease the expenses of state government, but also will result in improved public service and efficiency

Now, therefore, be it ordered, the House concurring, that the Governor and Council be requested to investigate, or cause to be investigated, all legislative enactments or State activities relating to the expenditure of money by the various depart-ments of State, and that the Governor and Council forthwith put in effect such of the recommended economies as in their opinion may seem wise and expedient, and report further to the Eighty-ninth Legislature, and that the Governor be requested to communicate to the Eighty-ninth Legislature the results of such a survey, together with such recommendations as he may deem proper regarding the financial affairs of the State. All essential and necessary expenses pertaining to such investigation shall be paid by the Governor and Council out of the State Contingent Fund.

Comes from the Senate, read and passed.

In the House, read and passed in concurrence.

From the Senate: Bill an act to incorporate the Calais Safety Deposit Company, S. P. 474.
