#### HOUSE

Monday, March 29, 1937.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Bradford of Hallowell.

Journal of the previous session read and approved.

At this point Mr. Philbrick of Cape Elizabeth, assumed the Chair amid the applause of the House.

Papers from the Senate disposed of in concurrence.

#### Senate Bills in First Reading

S. P. 454, L. D. 849: An act relating to uniforms for deputy sheriffs.

S. P. 455, L. D. 851: An act relating to pensions for members of the police force in the town of Houlton.

S. P. 457, L. D. 850: An act relating to terms and salaries of city of Lewiston officials.

From the Senate: Joint Order recalling H. P. 882, L. D. 308, bill an act amending the city charter of the city of Portland, to the House, from the committee on Legal Affairs, H. P. 1731, which was passed in the House on March 17th.

Comes from the Senate, indefinitely postponed in non-concurrence.

In the House, on motion by Mr. Higgins of Ellsworth, that body voted to recede and concur with the Senate in the indefinite postponement of the order.

#### Orders of the Day

On motion by Mr. Dow of Norway, the House voted to reconsider its action taken at last Friday's session whereby H. P. 1748, L. D. 855, bill an act to provide for the surrender by the town of Somerville of its organization, was passed to be engrossed; and on further motion by the same gentleman the bill was tabled, pending its passage to be engrossed.

On motion by Mr. Gyger of Cumberland, it was voted to take from the table the twenty-eighth unassigned matter, bill an act regarding penalty for depositing poisons with intent to kill animals, H. P. 1548, L. D. 683, tabled by that gentleman on March 25th, pending its\_assignment for third reading.

The same gentleman presented House Amendment A and moved its

adoption as follows:

House Amendment A to H. P. No. 1548, L. D. No. 683, bill, an act regarding penalty for depositing poisons with intent to kill animals.

Amend said bill by adding at the end thereof the following: Providhowever, that mice may be killed in orchards by the use of any poison or poisonous substance that is recommended by the U.S. Bureau of Biological Survey and used according to the recommendations of the Agricultural Extension vice.

Thereupon House Amendment A was adopted.

Mr. Pike of Bridgton presented House Amendment B and moved its adoption as follows:

House Amendment B to H. P. No. 1548, L. D. No. 683, entitled an act regarding penalty for depositing regarding penalty for depositing poisons with intent to kill animals.

Amend said bill by striking out in the 8th line thereof the figure "\$100" and inserting in place thereof the figure '\$50.'

Thereupon House Amendment B was adopted, and tomorrow was assigned for the third reading of the bill as amended by House Amendment A and House Amendment B.

On motion by Mr. Ellis of Rangeley, it was voted to take from the table the thirtieth unassigned matter, bill an act relating to payment of damages done by dogs or wild animals and to the registration and licensing of dogs, H. P. 1750, L. D. 861, tabled by that gentleman on Mayer, 25th pending second road March 26th, pending second reading; and on further motion by the same gentleman, the bill was given its second reading and tomorrow assigned.

On motion by Mr. Demers of Sanford, it was voted to take from the table the seventh unassigned matter, House report ought not to pass of the committee on Legal Affairs on bill an act relating to duties of municipal officers, H. P. 1296, L. D. 472, tabled by that gentleman on March 24th, pending acceptance of the 'eport; and on further motion by the same gentleman the ought not to pass report committee was accepted.
