HOUSE

Friday, April 23, 1937.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Dunn of Gardiner.

Journal of the previous session read and approved.

From the Senate: Bill an act relating to reports to towns of excise tax payments, S. P. 480, L. D. 901, which was indefinitely postponed in the House on April 21st in nonconcurrence.

Comes from the Senate, that body insisting on its former action whereby the bill was passed to be en-grossed and asking for a commit-tee of Conference, with the following Conferees appointed on its part: Messrs. Fernald of Waldo, Willey of Cumberland and Fortin of Androscoggin.

In the House, on motion by Mr. Donahue of Biddeford, that body voted to insist upon its former action and join in the committee of

Conference.

The SPEAKER: The Chair will name the Conferees on the part of the House later.

Reports of Committees

Report read and accepted and sent up for concurrence.

Mr. SLEEPER of Rockland: I move, Mr. Speaker, that this bill be indefinitely postponed. As a signer of the minority report, ought not to pass, we signed it for the rea-

son that we felt that the beer industry had been sufficiently penalized by a sixteen-cent tax, and in addition to that we recently passed a measure increasing the license fees which would automatically cut down the holders of these licenses. A day or two ago, I understand, an amendment was offered to another bill which had the same clause, and which was killed in this House. Therefore I move you, Mr. Speaker, that this bill be indefinitely postponed.

The motion prevailed and the bill was indefinitely postponed, and sent

up for concurrence.

Mr. THORNE: Mr. Speaker, I now offer House Amendment to House Amendment B and move its adoption.

The SPEAKER: The Chair understands that there is now pending one amendment to House Amendment B which must first be disposed of and which the Clerk will read.

A viva voce vote being taken, House Amendment B as amended by House Amendment B to House Amendment B was adopted and the bill as amended was passed to be engrossed and sent up for concur-

rence.

On motion by Mr. Ellis of Rangeley, it was voted to take from the table the first unassigned matter, House Amendment A to bill an act to establish organized highway accident prevention work as a function of the Maine State Police, S. P. 522, L. D. 1057, tabled on April 22nd by Mr. Ellis of Rangeley, pending adoption. The Chair recognizes the gentleman from Skowhegan, Mr. Hinman.

Mr. HINMAN: Mr. Speaker and Members of the House: First of all I want to express my gratitude to you in allowing this matter to be held over.

Whether or not you accept House Amendment A is of no importance to me. The A. A. A. of Maine and a representative of the garages of the State of Maine protested the amount of 60 cents and took the stand that they should not have forced upon them the expenditure of an extra nine cents without the means of getting it; and I have presented as a part of this amendment a change from 50 to 60 cents, in order to give you a chance to make your decision. It is immaterial to me.

Now I have another amendment. and, with your permission, I am going to discuss what our action may be as the matter now stands. If you adopt House Amendment A in the second clause of the bill in the redraft or the new draft, instead of the head of the Division of Safety being chosen by the Gover-nor and Council and for a definite period he will be chosen by the Chief of the State Highway Police, and in that case the Governor, like any of the rest of us, may express himself as to who that choice may be. But it seems unfair that we should set up a division in an existing department and say that we will put at the head of that division a person in whom the head of that department has no choice. Captain Towle has taken this matter to the Executive, and the change is entirely in accord with the wishes of the State Highway Police.

The other change is simply providing the means of carrying out the provisions of the act, regardless of whether we choose an amendment or whether we go back to the bill in the new draft. May I ask a question, Mr. Speaker?

The SPEAKER: The gentleman may ask his question.

Mr. HINMAN: Mr. Speaker, is it permissible for me to at this time explain what my next amendment would do, in case they choose to turn down the amendment that is now presented?

The SPEAKER: The Chair thinks the gentleman may proceed, if there is no objection. There is no objection, and the gentleman may proceed

Mr. HINMAN: Mr. Speaker, provided Amendment A does not meet with your approval, I would then offer an amendment leaving the matter of issuing of stickers and the designation of official stations and the two dollar fee charged for the same, together with the one cent price for the stickers, right where it is now, making the change in the second amendment as in the previous amendment and allocating or appropriating ten thousand dollars from the general highway fund to take care of the maintenance of this department, if you do not choose the sale of stickers. Now in the first amendment I have raised it from 50 to 60 cents. That is immachose for an and if you amendment the putting back of that to 60 cents, it is all right, I think, with the committee and surely with myself.

Mr. FINDLEN of Fort Fairfield: Mr. Speaker, in the first place I think 50 cents is sufficient for the stickers. I think ten cents to go to this department, or whatever you choose to set up, will do the trick that we want it to do, and 40 cents for wetting a sticker seems to me should be sufficient for garages, because, as we know, they charge just for the time they put in for the inspection of our cars.

Now the last part of this amendment looks a good deal to me like taking the coppers off a dead man's eyes. It is a steal.

I feel as though this problem of safety is a real problem. I do not think we ought to turn this into a revenue measure. This is a large We have a county up north of you that is as large as the state of Massachusetts, in case you do not know it. We have killed five people up there already this year since January 1st. While I was home there was one accident that put twenty in the hospital. I do not think this is anything foolish. I think this is a matter to set aside a decent kind of appropriation for. This ten cents will do the trick, but I do not think you want to make a revenue measure of it. Therefore, I move the indefinite postponement of this amendment.

The SPEAKER: The gentleman from Fort Fairfield, Mr. Findlen,

moves that House Amendment A be indefinitely postponed. Is the House ready for the question?

Mr. GOSS of Poland: Mr. Speaker, and Members of the House: I would just like to say that I am neither favoring nor opposing the amendment which Mr. Hinman is offering, but, should you accept the amendment, I will then present an amendment which would strike out the paragraph that raises the price of the sticker from 50 cents to 60, so that the sticker price would remain the same.

Mr. HINMAN: Mr. Speaker, I think that the gentleman from Poland, Mr. Goss, has not said just what he meant to say. I think his intention was, if this amendment was not adopted, to then offer an amendment covering everything in Amendment A except that he would bring the price from 60 cents back to 50 cents.

Now I just want to give you the amount that this revenue means. According to the registrations of last year, you would receive \$19,-183.70 once in six months, and with the estimated increase in registrations from the Department of the Secretary of State there would be better than \$40,000 available from that arrangement.

The SPEAKER: The Chair thinks from what was said by the gentleman from Poland, Mr. Goss, that the proposed amendment to which the gentleman refers would be in substance an amendment to House Amendment A, which is now pending, and that if House Amendment proposed by the gentleman from Poland would not be in order. Therefore the Chair suggests that if the gentleman from Poland wishes to strike out any part of the pending amendment he offer his proposal as an amendment to House Amendment A

Mr. GOSS: Mr. Speaker, that was my intention.

The SPEAKER: The gentleman may present his amendment.

Mr. Goss thereupon presented House Amendment A to House Amendment A, and moved its adoption, as follows:

House Amendment A to House Amendment "A" to S. P. No. 522, L. D. No. 1057, bill an act to establish organized highway accident prevention work as a function of the Maine State Police. Amend said Amendment by striking out the 3rd paragraph thereof, which amends Section 6 of the bill.

The SPEAKER: The gentleman

The gentleman from Fort Fairfield, Mr. Findlen, has moved that House Amendment A be indefinitely postponed. Under the rules, the motion of the gentleman from Poland, Mr. Goss, takes precedence over the motion of the gentleman from Fort Fairfield, Mr. Findlen. Therefore the pending question is on the adoption of House Amendment A to House Amendment A. The Chair recognizes the gentleman from Skowhegan, Mr. Hinman.

Mr. HINMAN: Mr. Speaker, I would not want the gentleman from Fort Fairfield, Mr. Findlen, or anybody else, to be deceived by this amendment. If you accept the amendment of the gentleman from Poland, Mr. Goss, you will leave the matter as it is in the new draft of the bill, charging fifty cents.

The SPEAKER: The pending question is on the adoption of House Amendment A to House Amendment A As many as are in favor of the adoption of the amendment to the amendment will say aye; those opposed no.

A viva voce vote being taken, House Amendment A to House Amendment A was adopted.

The SPEAKER: The question now recurs on the motion of the gentleman from Fairfield, Mr. Findlen, that House Amendment A be indefinitely postponed. Is the House ready for the question? As many as are in favor of the motion of the gentleman from Fort Fairfield, Mr. Findlen, that House Amendment A as amended be indefinitely postponed will say aye; those opposed no.

A viva voce vote being taken, the motion to indefinitely postpone did not prevail.

The SPEAKER: The pending question now is on the adoption of House Amendment A as amended by House Amendment A to House Amendment A as many as are in favor of the adoption of the amendment as amended will say aye; those opposed no.

A viva voce vote being taken, House Amendment A as amended by House Amendment A to House Amendment A was adopted.

On motion by Mr. Ellis of Rangeley, the rules were suspended and the bill had its third reading and was passed to be engrossed as amended by House Amendment A as amended in non-concurrence.

Acting under the instructions of the Senate, I beg leave to inform you that a disagreement between the two branches of the Legislature has arisen as to Legislative Document 1058, Bill "An Act to Provide for Old Age Assistance, to Guarantee a Minimum Educational Program and to Provide Revenues Therefor by Means of Miscellaneous Taxes," and inasmuch as a disagreement has also arisen as to

House Amendment "A" and House Amendment "B" thereto, and as these disagreements have reached such a phase that it seems likely to be final, the Senate asks for a conference upon the disagreeing actions of the two branches.

The President of the Senate has named on the part of the Senate as members of the Committee of Conference in relation to this bill:

In the House: read, and on motion by Mr. Ellis of Rangeley, tabled temporarily.

From the Senate: Bill an act to correct technical errors in various laws, S. P. 533.

Comes from the Senate, received under the rules, under suspension of rules, given its several readings and passed to be engrossed without reference to a committee.

In the House, on motion by Mr. Ellis of Rangeley, the bill was tabled pending further consideration and 500 copies ordered printed.

(House at Ease)

After Recess-5:40 P. M.

Called to order by the Speaker. On motion by Mr. Ellis of Rangeley, it was voted to take from the table the communication received from the Senate earlier this afternoon, and on further motion by the same gentleman the communication was ordered placed on file.

Mr. ELLIS of Rangeley: Mr. Speaker, I move that the House join in the committee of Conference and that the following message be sent to the Senate: It is the opinion of the House that the procedure Conference as to Document No. 1058, Bill, "An Act to Provide for Old Age Assistance, to Guarantee a Minimum Educational Program and to Provide Revenues therefor by Means of Miscellaneous Taxes" is an unwarranted departure from the well established and long standing parliamentary practice of Maine Legislatures.

While the Senate has given the House no official knowledge of what

the Senate proceedings have been. nevertheless the House reiterates its belief in the necessity of enacting the Old Age Assistance Program and the Minimum Educational Program, together with the necessary revenue provisions.

And, therefore, notwithstanding the irregularity of the procedure, and for the purpose of expediting the transaction of pending business, the House joins the Committee of Conference.

The motion prevailed, and the Chair appointed as conferees on the part of the House: Messrs. Newton of Readfield, Murchie of Calais and Gyger of Cumberland

On motion by Mr. Ellis of Range-ley, it was voted that the message be conveyed to the Senate by the Clerk, informing that body of the appointment of the conferees on the part of the House.

Thereupon, the Clerk conveyed the message to the Senate and sub-sequently reported that he had delivered the message with which he was charged.

The SPEAKER: The Chair recognizes the gentleman from Augus-

ta, Mr. Fellows.

Mr. FELLOWS: Mr. Speaker, it might be well for me to explain to the House what this bill means.

At the present time we have a ten per cent tax on liquor. This represents in a way a fifteen per cent tax on liquor. Because of re-ports that the Attorney-General's office has had from Washington that it is possible that the Federal government may lay a tax upon the income which we are deriving from our liquor revenues, there might be an income tax which the State of Maine would have to pay to the Federal government. Now this bill is designed to eliminate the pos-sibility of any tax being collected through an income tax by the Federal government. Instead of being a profit, the whole thing now will amount to a tax. There will be no difference so far as the cost concerned other than the additional five per cent.
