January 14, 1937.

Senate called to order by President.

Prayer by the Reverend A. Brown of Gardiner.

Journal of yesterday read and approved.

Orders of the Day

On motion by Mr. Hussey of Kennebec the Senate voted to take from the table Senate Order relative to delegation to the Third General Assembly, tabled on January 13th by that Senator pending passage. Mr. HUSSEY of Kennebec: Mr.

President, on the first tabled matter relating to a delegation to the Third General Assembly I present an amendment and move its adoption. In explanation I will say that where the first order called for three delegates to the convention of the Third Assembly in Washington this one is calling for one. In explana-tion of why I believe the number should be cut down, I have here a letter from that Assembly, or authorized delegate, whereby they have only requested one member from the Senate, one from the House and one from the executive department. Furthermore, I understand that the Maine delegation has only one vote in that Assembly. Therefore, more than one delegate would be superfluous. I move the adoption of the amendment.

The Secretary read the amend-ment: "Senate Amendment 'A' to Senate Order relative to delegation to the Third General Assembly. Amend said order to read in the first, second, third and fourth lines 'Ordered, that the President of the Senate or a Senator designated by the President be appointed as a delegate to the Third General Assembly which convenes in Washington, D. C., on January 21, 1937. Such delegate shall be, and is hereby, instructed to return to this Body and report definite recommendations of the Third General Assembly and."

Amendment "A" Senate was adopted.

Mr. ASHBY of Aroostook: President, I move that the Mr. order with the amendment lie upon the table.

Mr. GOUDY of Cumberland: Mr. President, inasmuch as I am well aware of the fact that a motion to table is not debatable I would like to ask the privilege of the Senate at this time to speak out of order and to say to the Senate that if any delegate or delegation is going to attend this Assembly they must know it this morning. Mr. ASHBY: Mr. President, should like to know a little more about this but I have unlimited faith in the Senator from Cumber-land, Senator Goudy, and if it is absolutely necessary—of course we could take no action tomorrow because the Senate will not be in session-if it is absolutely imperative that the order be passed this morning I withdraw my motion.

Consent to the withdrawal of the motion was granted.

Thereupon, the order as amended

by Senate Amendment "A" received a passage.

The PRESIDENT: The Chair at this time appoints as delegate to the Third General Assembly convening in Washington on January 21, 1937, the Senator from Cumberland, Senator Goudy.

Mr. Act Relating to Old Age Assistance." (H. P. 63) (L. D. 11)
Mr. HUSSEY of Kennebec: In moving that this bill be passed to be enacted I would like to make a statement, Mr. President, of facts in order that there may be no misunderstanding concerning the provisions of this bill. If the members of the Senate will carefully scan the bill they will notice that it is sim-ilar to the one which we had in here at the last special session. It carries an estimated revenue of practically \$250,000 for $_{
m the}$ nextmonths. That \$250,000 is just a temporary assessment in order to carry on the Old Age Pension as set up by our former Council. There are on the pension rolls of Old Age Assistance approximately four sand cases calling for an expenditure of between \$40,000 and \$45,000 a month and this proposed revenue coming in at approximately \$45,000 to \$50,000 a month will take care of the old age assistance names already on the books. It does not take care of any further There are pending for payment now more than 2400 new cases and I feel that we should understand that the measure we are passing today is to take care of the cases already set up and will not take care

of any new cases. Of course, as the legislative session goes on we will have to provide new measures and new revenue to take care of the cases as they are later brought in

and investigated.

Mr. FERNALD of Waldo: President and members of the Senate, we are all familiar with the fact that last month the Legislature of Maine was called into extraordinary session by Governor Brann and one of the recommendations that the Governor presented before the Legislature at that time was the need of an appropriation to continue Old Age Assistance. A bill was submitted to the Governor and to the Legislature through the Appropriations Committee. That bill passed the House by an overwhelming majority and received overwhelming support in the Senate but for certain reasons that no man has yet been able to clearly understand the Governor vetoed that bill, with the result that Old Age Assistance in Maine stopped because of said veto and we read in such papers as the Lewiston Sun of January the 14th on the front page, "No Old Age Pension Checks This Month."

Now, in the interim between the special session and this session we have all had an opportunity to return to our homes and to our firesides and I think it is almost our unanimous opinion that the folks back home are solidly behind the action of this legislature in passing this temporary old age assistance bill which was unfortunately, as we

feel, vetoed by the Governor.

Now, what we are attempting to do today is to carry through our hand and carry on the policies enunciated in the bill that was presented to the last special session and we have before us an almost identical bill. There have been a few changes as to date because several weeks of time have elapsed.

This is a temporary measure. Senator Friend of Somerset has a measure before you for a permanent old age pension which will be the basis of our discussion when we get ready to establish the permanent law, but this bill now before us is the bill to continue the old age assistance which has been vetoed by Governor Brann and which measure was spoken of by our present Gov-ernor. I believe that we will be passing one of the most important measures before this Legislature today when we enact into law measure now before us and I think that we will receive the greatest commendation of the people of the

state of Maine on our action today.
The PRESIDENT: The question before the Senate is on the motion of the Senator from Kennebec. Senator Hussey, that An Act Relating to Old Age Assistance be passed to be enacted. This is an emergency measure and requires the affirmative vote of two-thirds of the entire membership of the Senate. Is the Senate ready for the question?

A division of the Senate was had. Thirty-one members of the Senate having voted in the affirmative and none opposed, the bill was passed to be enacted.

The PRESIDENT: Is there any further business to come before the Senate?

On motion by Mr. Maliar of Androscoggin
