President, having learned that the Federal Highway Commission approves of neither the bill in its present form nor as amended by the proposed amendment, I ask leave to withdraw Senate Amendment "A" which I offered when this bill was tabled.

Mr. FRIEND of Somerset: Mr. President, Senate Amendment "B" which I wish to offer has been drawn to take care of the situation and causes the bill to meet with the approval of the Federal Bureau. I offer Senate Amendment "B" and move its adoption.

The Secretary read: "Senate Amendment 'B' to House Paper 378, Legislative Document 103. Amend said bill by striking out all of the words after the word 'forthcoming' in the 29th line on the second page of said bill except the emergency clause thereon, and inserting after the word 'forthcoming' the following words 'forthcoming' the following words 'ford the state Treasurer is hereby directed and authorized to reimburse the general highway fund by a deposit of the funds received from such aforesaid appropriations the receipt of which has been anticipated to the extent of the amounts temporarily diverted therefrom; such deposits to be made as soon as such revenues are collected."

Mr. FERNALD of Waldo: Mr. President, I would like to have the Secretary read the various steps which the bill has been through. The SECRETARY: The Com-

mittee on Reference of Bills suggested first that the bill be referred to the Committee on Sea and Shore Fisheries and that five hundred copies be ordered printed. In the House the bill was referred to the Committee on Sea and Shore Fisheries. In the Senate it was referred in concurrence and on January 26th in the Senate the reference was reconsidered and the bill was laid upon the table pending reference to the committees on Inland Fisheries and Game and Sea and Shore Fisheries jointly. On January 27th the bill was taken from the table in the Senate and referred to the committees on Inland Fisheries and Game and Sea and Shore Fisheries jointly in non-concurrence with the House. In the House, on January 28th, on motion by Mr. Emery of Bucksport, the House receded and on further motion by the same gentleman leave withdraw was unanimously granted in non-concurrence and the bill was sent up for concurrence.

Mr. FERNALD: Mr. President, in order to keep the record straight on this bill and to protect the in-terests of the commercial fishermen I might state that since this bill was introduced in behalf of the men who derive a living from the catching of salmon on the river known as the Penobscot River which divides Hancock and Waldo counties, for some reason there has been a change of feeling in the sponsor of the bill, and rather than to complicate the matter and have an extended debate as to whether or not the privilege of withdrawing the bill should be extended, I am this afternoon introducing under my own name the same bill, the purpose being to afford to these commercial fishermen a right to be heard. Regardless of whether or not the Committee may agree with them, I feel that these men who derive a livelihood and most of their existence in this humble and worthy occupation should be given an opportunity to be heard and I want to state definitely here that none of the former playboy friends of our former governor will come down to Augusta and tell me to withdraw this bill.

The merits of the bill have been

discussed by Representative Emery of Bucksport in the Lewiston Evening Journal of Sunday, January 20th, 1937 on Page 5; and I move you, sir, that we concur with the House in permitting the withdrawal of the bill.

The PRESIDENT: The Senator from Waldo, Senator Fernald moves that the Senate recede and concur with the House in permitting this bill to be withdrawn. Is the Senate ready for the question?

Mr. WORTHEN of Penobscot: Mr. President, I now move that this Resolve be referred to the Committee on Sea and Shore Fisheries and the Committee on Inland Fisheries and Game jointly in non-concurrence.

Thereupon, on motion by Mr. Fernald of Waldo, the bill was laid upon the table pending the motion to refer to the Committee on Sea and Shore Fisheries and the Committee on Inland Fisheries and Game jointly in non-concurrence.

(Emergency Measure) (Out of Order)

"An Act to Amend Section 1 of An Initiated Act Approved by the People at the General Election Held September 14, 1936, Relating to the General Highway Fund, and to Authorize Certain Temporary Use of Said Fund" (H. P. 378) (L. D. 103)
