Communication STATE OF MAINE

Office of the Secretary of State March 9th, 1937.

To the Honorable Senate of the Eighty-eighth Legislature of the State of Maine:

I have the honor to herewith transmit a petition of William T. Mayberry of Dexter and others to initiate a bill to amend an act entitled "An Act Appropriating Moneys for Overdrafts Already Incurred Due to Insufficient Appropriations and Anticipated Overdrafts and Other Obligations for Which no Legislative Appropriations Have Been Made" and to substitute another in Lieu thereof.

This measure is in accordance with the provisions of section 18 of Article XXXI of the Constitution of the State of Maine. The measure is proposed by what is purported to be not less than twelve thousand electors, namely; fourteen thousand seven hundred twenty-one as shown by the signatures, the sufficiency of which have not been checked in the office of the Secretary of State.

legislature.

Miss LAUGHLIN of Cumberland: Miss LAUGHLIN of Cumberland: Mr. President, of course every member of this Senate is now aware that this proposed or supposed initiated bill erroneously refers to Public Laws, Chapter 15, which is a law connected with optometry. Well, in the body of this bill it makes some reference to beer. I suppose every lawyer here has his or her opinion as to whether this initiated bill has any legal standing whatsoever but it seems to me that whatsoever but it seems to me that we should not take the opinion of any one lawyer or of all the lawyers who are members but rather that we should receive the official opinion of the Attorney General of the State in order that the Senate, having that official opinion, may then be well advised how to act on this matter.
