SENATE

Friday, October 29, 1937.

Senate called to order by the President.

Prayer by the Rev. Cymbrid Hughes of Augusta.

Journal of yesterday read and approved.

The PRESIDENT: The Chair has been informed that Governor Barrows desires to present a communication or message to the Senate in person at this time and if there is no objection the Chair will name as a committee of one to escort the Governor to the Senate at this time, the Senator from Penobscot, Sen-If there is no objecator Martin. tion that Senator will attend to her duties forthwith.

Miss Martin of Penobscot retired from the Senate Chamber to attend to the duty assigned her

Subsequently, Miss Martin re-turned to the Senate Chamber escorting the Governor, the Honor-able Lewis O. Barrows, amid the ap-plause of the Senate, the Senators rising.

 the Governor ad-Thereupon

dressed the Senate as follows: "Mr. President and members of the Senate, I recall that during the last regular session an order was passed and submitted to me to provide a certain piece of furniture. At that time the only reason that the order was not fulfilled was that we were uncertain as to whether or not the piece of furniture was solid and substantial, but having been seasoned all summer I am now convinced that it is perfectly in order and I would like at this time to present the chair. The tag bears the name of Senator Fernald. (Presenting chair) Very glad to do it, Senator."

Mr. FERNALD: Thank you, sir.

Thereupon, the Governor retired amid the applause of the Senate, the Senators rising.

From the House, out of order: "Resolve on the Pay Roll of the House of Representatives." (H. P. 1931)

In the House, the resolve was received by unanimous consent and under suspension of the rules was passed to be engrossed without reference to a committee.

In the Senate, the resolve was received by unanimous consent and under suspension of the rules was given its two several readings and passed to be engrossed in concurrence.

From the House, out of order:

The Committee on Banks and Banking on bill "An Act Relating to Investments for Savings Banks (H. P. 1907) (L. D. 1091) reported that Committee Amendment "A" be adopted and the bill as amended be passed.

In the House, the report of the committee was accepted, and the Amendment "A" and House Amendment "A" and House engrossed under the suspension of the rules.

In the Senate, the report of the committee was accepted in concurrence, and the bill given its first reading. "Committee Amendment A to Legislative Document 1091. Amend said bill by adding thereto the following clause: 'Emergency clause. In view of the emergency set forth in the preamble, this act shall take effect when approved.' " Committee Amendment "A" was

adopted in concurrence and House Amendment "A" was read and adopted in concurrence.

Thereupon, under suspension of the rules, the bill was given its second reading and passed to be engrossed in concurrence.

From the House, out of order:

(In the Senate on October 28th passed to be engrossed.)

In the Senate:

Mr. BLANCHARD of Franklin; Mr. President, I move that the Senate recede and concur with the House.

Mr. POTTER of Penobscot: Mr. President, I have no serious objection to the committee being ap-pointed. I might say that the Grange and a few other organizations had made definite arrangements to have an initiative refer-endum to be voted on at the next September election, which would come before this committee might report. We shall proceed with that and that was one of the reasons why I objected to it, and then again, I feel the expense would not be necessary under those conditions. So while I have no serious objec-tion to a committee being appointed, I do feel it is money wasted in making that appointment.

Mr. CORRIGAN of Washington; Mr. President, I feel as Senator Potter does in this matter and I have been talking with labor leaders in the state and representative of the American Federation of Labor here at this session and I un-derstand that he and the labor people are not in favor of a recess commission and they feel they would rather go along as the Sen-ator from Penobscot, Senator Potter, has explained, on a referendum and initiative rather than having a recess committee appointed by this body.

Mr. SEWALL of Sagadahoc: Mr. President, as a member of the Committee on Taxation, having gone over it last winter, it seems to me this is a very worth while study. At least, I felt last winter that we really did not have enough real in-

formation to go on to justify taking definite legislation on this mat-I also felt and I still feel that ter. the bills that were put in had not really been refined sufficiently to act on them, and as I understand this recess committee to be appointed would really determine and definitely establish better figures and statistical data to base the decision on and to define the law. I think it is a desirable piece of leg-islation. I hope the motion to re-cede and concur will prevail.

WALSH Androscoggin: Mr. of Mr. President, the Senator from Sagadahoc, Senator Sewall, has ably defined the purpose of the recess committee, to so refine the proposition that when it comes in here it will be so innocuous it will amount to nothing at all.

Mr. SEWALL: Mr. President, I think the Senator from Androscoggin, Senator Walsh, is out of order. Mr. WALSH: My mistake, Senator Sewall.

The PRESIDENT: Is the Senate ready for the question? The question is on the motion of the sen-ator from Franklin, Senator Blanchard, that the Senate recede and concur with the House.

Mr. CORRIGAN: Mr. President, I ask for a division.

division of the Senate was had. Seventeen having voted in the affirmative and nine opposed, the motion to recede and concur prevailed. Thereupon, under suspension of the rules the resolve was given its two several readings and passed to be engrossed in concurrence.
