Wednesday, January 11, 1939.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Pressey of Augusta.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Ordered, the House concurring, that the Clerk of the House prepare each week for the use of the Legislature, a cumulative index of all bills and resolves introduced during the session showing precisely the important steps in the history of each and its final disposition or present status, and that 500 copies thereof be printed, and 1 copy thereof be placed on the desk of each member of the Legislature (S. P. 49)

Comes from the Senate, read and passed.

In the House, on motion by Mr. Varney of Berwick, tabled pending passage in concurrence.

From the Senate: Bill an act creating a Department of Taxation (S. P. 23)

Comes from the Senate, referred to the committees on Appropriations and Financial Affairs and Taxation jointly.

In the House, referred to the committees on Appropriations and Financial Affairs and Taxation jointly in concurrence, and on motion by Mr. Varney of Berwick, 500 copies ordered printed.

From the Senate: Bill an act relative to hunting and fishing licenses; revocation of (S. P. 25)

Comes from the Senate, referred to the committee on Inland Fisheries and Game.

This is to certify that at the general election of the Penobscot Tribe of Indians, held in accordance with Section 282, Chapter 1 of the Laws Section 282, Chapter I of the Laws of Maine, 1933, on the first Tuesday of November, 1938, Leo Shay was duly elected as Representative to the State Legislature for the term of two years, beginning with the first Wednesday of January, 1939, and ending with the first Tuesday of November, 1940.

Orders

Mr. VARNEY of Berwick: Mr. Speaker, I present an order which has to do with the changing of the Rules of the House, and I therefore move that it be read and referred to the committee on Rules and Business of the House, and I hereby give notice that it will be acted upon at the next legislative day.

Ordered, that Section 26 of the Rules of the House be amended so that the sixth order of business shall read as follows:

"6th. First reading of bills and resolves that have been printed."

Thereupon, the order was referred to the committee on Rules and Business of the House.

Mr. Whitney of Bangor was granted unanimous consent to address the House.

Mr. WHITNEY: Mr. Speaker and members of the House: I have a bill which refers directly to the city of Bangor, and perhaps I can best explain it by reading part of the emergency preamble.

"Whereas the city of Bangor has undertaken the construction and equipment of two new junior high schools and a combined police station and a municipal garage, in conjunction with the Federal government under the provisions of the P. W. A. act; and

"Whereas contracts have already been entered into by the said city with certain individuals and firms for the construction of the foundations for the several buildings and for the erection of the combined police station and municipal garage with equipment, and the work has already begun; and

"Whereas the contracts for the erection of the junior high school buildings with equipment have not yet been given out, and therefore, the cost of same is undetermined; and

"Whereas under the terms of the charter of the city of Bangor a bond issue is authorized under certain conditions as therein specified; and

"Whereas until the entire cost of the construction is determined it is not possible to legally authorize a bond issue; and

"Whereas under the Federal regulations covering P. W. A. work, monthly payments for work done under the contracts already let, must be met by the fifteenth day of each month, for labor performed for the preceding month; and

"Whereas even after the balance of the contracts are let it will take a considerable time to prepare and complete a bond issue and in the meantime there are no municipal funds available to meet payrolls as provided in the agreement which the city has with the government agencies, and unless such payments can be met and paid according to agreement all work already started shall cease, and all contemplated work will be postponed, thus depriving a great many persons of employment and working untold hardships to those deprived of such employment and also their families..."

In other words, the city of Bangor has already started the construction of two junior high schools and a combined police station and municipal garage. The cost of the same will be borne by bond issue, but the city cannot legally issue bonds in contemplation of payment until the total cost has been determined, which naturally we will not know until the work has finally been completed. Under the terms of the charter of the city of Bangor, the city is not entitled legally to issue notes in contemplation of a bond issue. The total amount in this enabling act is specified as not exceeding \$450,000, which, for your information, is well under the constitutional debt limit of the city of Bangor. This proposed bill is simply an mabling act, authorizing the city of Bangor to issue its notes in payment of the work and expense of the construction of these projects until such time as they are completed and the final cost determined, when they will issue a bond

issue to take up the notes and complete the payment of all expenses incurred therein.

Mr. Speaker, I now ask unanimous consent to introduce out of order and under suspension of the rules, this bill, which I now present.

The SPEAKER: The gentleman from Bangor, Mr. Whitney, asks unanim us consent of the House to introduce a bill out of order and under suspension of the Rules. Is there any objection? The Chair hears none, and the gentleman is given unanimous consent to introduce the bill.

On further motion by Mr. Whitney, the bill was given its two several readings, 500 copies ordered printed, and tomorrow assigned.

On motion by Mr. Stacy of Porter,

Adjourned until ten o'clock tomorrow morning.
