**Orders Of The Day**

Mr. SLEEPER of Rockland: Mr. Speaker, I move that the House reconsider its action taken earlier in today's session whereby it tabled an order by me to have printed 1000 additional copies of House Paper 914, Legislative Document 305, "An Act Extending the Workmen's Compensation Act to Cover Occupational Diseases." This is a very important bill, and I understand that copies have been given out—

The SPEAKER: The gentleman is not in order.

Mr. SLEEPER: Mr. Speaker, I move that the House reconsider its action whereby the bill was tabled.

The SPEAKER: Does the gentleman desire to move that the House take from the table the order that was tabled?

The SPEAKER. All those in favor of the motion of the gentleman from Rockland, (Mr. Sleeper) that the House take from the table the order presented by him, which was tabled by the gentleman from Berwick, Mr. Varney, will say aye; those opposed no.

A viva voce vote being taken, the motion did not prevail.

On motion by Mr. Varney of Berwick, the House voted to take from the table the eighth unassigned matter, Resolve naming Perley's Pond, (H. P. 898) tabled on February 2nd by that gentleman pending reference; and on further motion by the same gentleman the Resolve was referred to the Committee on Interior Waters, 500 copies ordered printed, and sent up for concurrence.

On motion of Mr. Churchill of Brewer, the House voted to take from the table the sixth unassigned matter, Resolve to Reimburse the City of Brewer for Support of Frank Damon and Family (S. P. 165) tabled on February 2nd by that gentleman pending reference in concurrence.

Mr. CHURCHILL: Mr. Speaker, I move that the Resolve be withdrawn as it is taken care of in another Resolve.

The SPEAKER: The Chair will inform the gentleman that the Resolve was presented by a member of the Senate. A motion to withdraw would not be in order. Does the gentleman desire to move that the Resolve be indefinitely postponed?

Mr. CHURCHILL: Yes, Mr. Speaker.

Thereupon, on motion by Mr. Churchill of Brewer, the Resolve was indefinitely postponed in non-concurrence, and sent up for concurrence.
