**HOUSE**

Tuesday, February 14, 1939.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Staples of Gardiner.

Journal of the previous session read and approved.

Mr. McGillicuddy of Houlton, was granted unanimous consent to address the House.

Mr. MCGILLICUDDY: Mr. Speaker and members of the House: I wish to speak very briefly on House Paper 10, Legislative Document 16, "An Act to Provide a Town Manager Form of Government for the town of Houlton."

The date of the annual town meeting is rapidly approaching, and, as this act will have to be voted upon by the town voters, it is necessary that we gain all the time possible. I understand that this bill has been returned from the Engineering Department and has been engrossed. I move, Mr. Speaker, out of order and under suspension of the rules, that the bill be passed to be enacted at this time.

The SPEAKER: The gentleman from Houlton, Mr. McGillicuddy, moves that the rules be suspended and that the House take up out of order bill on its passage to be enacted.

**Passed To Be Enacted  
(Emergency Measure)**

An Act to Provide a Town Manager Form of Government for the town of Houlton (H. P. 10) (L. D. 16)

The SPEAKER: This being an emergency measure, it requires for its passage the affirmative vote of two-thirds of the entire elected membership of the House. As many as are in favor of the passage of this bill to be enacted will rise and remain standing until counted and the Monitors will make and return the count.

A division being had,

One hundred and thirty-five voting in the affirmative, and none in the negative, 135 being more than two-thirds of the entire elected membership of the House, the bill was passed to be enacted.

On motion by Mr. McGillicuddy,

the bill was ordered sent forthwith to the Senate.
