#### HOUSE

Wednesday, February 15, 1939. The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Dr. McWhor-

ter of Augusta.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

#### Senate Bills in First Reading

Bill "An Act relating to Carrying Concealed Weapons" (S. P. 72) (L. D. 43) in new draft (S. P. 282) (L. D. 430) under same title

Bill "An Act to Grant a New Charter to the Alumni Association of Bates College" (S. P. 50)

Bills were read twice and tomor-

row assigned.

From the Senate: Report of the Committee on Legal Affairs reporting "Ought to pass" on Bill "An Act to Grant a New Charter to the city of Lewiston" (S. P. 55) (L. D. 27)

Comes from the Senate, report

read and accepted and the bill passed to be engrossed as amended by Senate Amendments "A" and "B".

In the House, report read and accepted in concurrence. Senate Amendments "A" and "B" were read and adopted in concurrence and the bill as amended was given its two several readings.

Mr. Lambert of Lewiston, then offered House Amendment "A" and

moved its adoption:

House Amendment "A" to S. P. 55, L. D. 27, Bill, "An Act to Grant a New Charter to the City of Lew-

Amend said bill by adding at the end of section 3 of Article XII thereof the following:

'After one year of service all those qualified as permanent members shall be entitled to 2 weeks vacation each year with pay. At the end of the third year of service all per-manent members of the department shall be paid no less than \$1,600 per vear.

Thereupon, House Amendment A was adopted, and, on motion by Mr. Lambert, under suspension of the rules, the bill as amended was given its third reading and passed to be engrossed, as amended by Senate Amendments "A" and "B," and amended by House as further "A," in non-concur-Amendment rence, and sent up for concurrence.

On further motion by Mr. Lambert the bill was sent forthwith to the Senate.

From the Senate: The following Order:

ORDERED, the House concurring, that a joint select committee to consist of two on the part of the Senate with such as the House may join, be appointed to examine into the inspection and investigation services of the several departments of the state government, to ascertain wherein the same or any part thereof may be consolidated and unnecessary overlapping eliminated or curtailed in such manner as to increase efficiency and economy in the administration of state affairs.

Said committee shall also examine into the expense of travel and operation of motor vehicles by employees of the several departments and agencies of the state to ascertain whether and by what means the same may be diminished or reduced.

Said committee shall enter upon the performance of its duties forthwith and shall report its findings and recommendations to the present session of the legislature as soon as possible, together with any bills or resolves it may recommend for consideration, and the same shall be received and considered in each branch of the legislature notwithstanding the provisions of the joint closing orders relative to the introduction of bills and resolves (S. P. 412)

Came from the Senate read and as amended by Senate Amendment "A" as follows:

"Amend said order by striking out in the second line thereof the word 'two' and inserting in lieu thereof the word 'three'." and with the following members appointed on its part:

Messrs. HILL of Cumberland WENTWORTH of York TOMPKINS of Aroostook

Mr. VARNEY of Berwick: Speaker, I move that Senate Amendment "A" be adopted in concurrence, and that the order as amended have passage in concurrence, and that the Chair appoint a committee of seven, said committee to consist of the House Chairman of the Standing Committee on Appropriations and Financial Affairs ex-officio, and six other members to be named by the Speaker of the House.

The SPEAKER: The gentleman from Berwick, Mr. Varney, moves that Senate Amendment "A" be adopted in concurrence, and that the order as amended have passage in concurrence, and that the Chair appoint a committee of seven, said committee to consist of the House Chairman of the Standing Committee on Appropriations and Financial Affairs ex-officio, and six other members to be named by the Chair. Is this the pleasure of the House?

Thereupon, Senate Amendment "A" was adopted in concurrence, and the order as amended received

passage in concurrence.

The SPEAKER: The Chair will name on that committee the gentleman from Franklin, Mr. Noyes, the gentleman from Greenville, Mr. Dean, the gentleman from Portland, Mr. Paul, the gentleman from Vassalboro, Mr. Hawes, the gentleman from Eliot, Mr. Dow, the gentleman from Thomaston, Mr. Smith and the gentleman from Skowhegan, Mr. Hinman, ex officio.

From the Senate: The following Order:

ORDERED, the House concurring, that the Maine Delegation of the United States Congress at Washington, District of Columbia, be requested to determine what amount, if any, is charged against the State of Maine as a debt subject to repayment, by any agency or department of the Federal Government, and to report their findings to the Eighty-ninth Legislature of the State of Maine now in session; and

FURTHER that said Delegation be requested to seek to have enacted by the Congress laws adequately safeguarding the expenditure of public funds and requiring that specific detailed reports of the expenditure of Federal funds within the various States, whether matched by State funds or not, be filed with some specifically designated State Authority and be open to public inspection; and

FURTHER that the said Delegation in Congress from Maine be urged to do all in their power to oppose Federal encroachments on the proper functions and powers of the States; and it is

FURTHER ORDERED that a copy of this said order be transmitted by the Secretary of the Senate to the Honorable Frederick Hale, United States Senator from the State of Maine, Chairman of said Delegation (S. P. 341)

#### Passed To Be Enacted (Emergency Measure)

An Act relating to Taxation of Insurance Companies (H. P. 1445)

Mr. YOUNG of Old Orchard Beach: Mr. Speaker, I now move that this bill be passed to be enacted.

Mr. Speaker and members of the House: I respectfully caution you again this morning. Should any again this morning. Should any motion to table this bill be made, I trust it will not prevail. This is an emergency measure and I spoke on it at length the other day. I respectfully ask the members to sustain my motion.

The SPEAKER: The gentleman

from Old Orchard Beach, Mr. Young, moves that Bill "An Act re-lating to Taxation of Insurance Companies" (H. P. 1445) be passed

to be enacted.

This being an emergency measure, it requires for its passage the affirmative vote of two-thirds of the entire elected membership of the House. As many as are in favor of the passage of this bill to be enacted will rise and remain standing until counted and the Monitors will make and return the count.

A division being had. One hundred and forty-four voting in the affirmative, and none in the negative, 144 being more than two-thirds of the entire elected membership of the House, the bill

was passed to be enacted.

#### Passed To Be Enacted

An Act relating to Investigation

of Fires by the Insurance Commissioner (H. P. 1444)
Mr. YOUNG of Old Orchard Beach: Mr. Speaker, I now move this bill be passed to be enacted. The same remarks, Mr. Speaker and members of the House, that applied to the other bill apply to this bill.

The SPEAKER: The gentleman

from Old Orchard Beach, Mr. Young, moves that Bill "An Act relating to Investigation of Fires by the Insurance Commissioner (H. P. 1444) be passed to be enacted.

This being an emergency measure, it requires for its passage the affirmative vote of two-thirds of the entire elected membership of the House. As many as are in favor of the passage of this bill to be enacted will rise and remain standing until counted and the Monitors will make and return the count.

A division being had,

#### Orders Of The Day

On motion by Mr. Dwinal of Camden, the House voted to take from the table the third unassigned matter, Senate report "Ought to pass" of the Committee on Towns on Bill "An Act to Provide for the Surrender by Town of Marion of its Organization (S. P. 80) (L. D. 44) which came from the Senate, report accepted and bill passed to be engrossed, and which was tabled on February 1st by Mr. Dwinal pending acceptance in concurrence; and on motion by Mr. Dwinal the committee report was accepted in concurrence and under suspension of the rules the bill was given its two several readings.

Mr. Dwinal then offered House mendment "A" and moved its Amendment adoption:

House Amendment "A" to S. P. 80, L. D. 44, Bill, "An Act to Provide for the Surrender by Town of Marion of Its Organization."

Amend said bill by inserting after the enacting clause thereof the following:

'Emergency preamble. Whereas, the town of Marion is not able to function under its present organization; and

Whereas, immediate steps should be taken to take care of the present financial emergency; and

Whereas, in the judgment of the legislature, these facts create an emergency within the meaning of section 16 of Article XXXI of the constitution of Maine and require the following legislation as immediately necessary for the preservation of the puplic peace, health and safety; now, therefore,

Further amend said bill by striking out section 3 thereof and inserting in place thereof the following:

'Sec. 3. Ratification. shall take effect on approval by the governor for the purpose of permitting its acceptance or rejection by the legal voters of the town of Marion at any annual or special town meeting legally called to consider the acceptance of this act; an appropriate article being inserted in the call for said meeting.

If a majority of the qualified voters of the town, present and voting, vote in favor of the acceptance of this act, it shall become operative on April 1, 1939. A certificate of such vote shall be filed by the

town clerk with the secretary of state.'

Further amend said bill by adding thereto, after section 3 thereof, the following:

'Emergency clause. In view of the emergency cited in the preamble, this act shall take effect when approved.'

Thereupon, House Amendment "A" was adopted, and the bill as amended was tomorrow assigned for its third reading.

On motion by Mr. Varney of Berwick, the House voted to take from the table the second unassigned matter, Joint Order relative to printing 500 copies "Indian Treaties of the State of Maine" (S. P. 121) tabled on January 25th by that gentleman pending passage in concurrence.

Mr. VARNEY: Mr. Speaker, since this order was tabled it has been discovered that there are sufficient copies of the Indian Treaties already printed and in the hands of the State Librarian for distribution. I therefore understand that there is no further demand for this order and I move its indefinite postponement in non-concurrence.

The SPEAKER: The gentleman from Berwick, Mr. Varney, moves that Joint Order relative to printing 500 copies "Indian Treaties of the State of Maine" (S. P. 121) be indefinitely postponed in non-concurrence. Is this the pleasure of the House?

The motion prevailed, and the order was indefinitely postponed in non-concurrence, and sent up for concurrence.

On motion by Mr. Willams of Bethel, the House voted to take from the table the seventeenth unassigned matter, Resolve Regulating Fishing in Howard Lake in the Town of Hanover, Oxford County (S. P. 316) which came from the Senate, referred to the Committee on Inland Fisheries and Game and which was tabled on February 14th by Mr. Williams pending reference in concurrence; and on further motion by the same gentleman the Resolve was referred to the Committee on Inland Fisheries and Game in concurrence.

On motion by Mr. Ellis of Fairfield, the House voted to take from the table the twentieth unassigned matter, Bill "An Act to Create a Board of Electric Examiners" (H. P. 1646) tabled on February 14th by that gentleman pending reference.

Mr. ELLIS: Mr. Speaker, I now ask leave to withdraw this bill as the subject matter is already taken care of in another bill.

The SPEAKER: The gentleman from Fairfield, Mr. Ellis, now asks leave to withdraw Bill "An Act to Create a Board of Electric Examiners" (H. P. 1646). Is this pleasure of the House?

The motion prevailed, and the bill was withdrawn.

On motion by Mr. Varney of Berwick, the House voted to take from the table the twenty-third unassigned matter, Bill "An Act Relating to Taxation of Motor Vehicles" (H. P. 1712) (L. D. 648) tabled on February 14th by that gentleman pending reference; and on further motion by the same gentleman the bill was referred to the Committee on Salaries and Fees.
