Reading was accepted.

Mr. Snow then offered House Amendment "A" and moved its adoption.

House Amendment "A" to H. P. 283, L. D. 90, Bill, "An Act Relating to the Town Manager Form of Government for the Town of Dover-Foxcroft.

Amend said Bill by striking out the word "inhabitants" in the fifth line of Section 1 and inserting in place thereof the words 'legal voters'

Further amend said Bill by inserting at the end of the fourteenth line after the word "month" the word 'during'.

Further amend said Bill by adding thereto the following section, to numbered Section 3.

'Sec. 3. Referendum. This act shall take effect 90 days after the adjournment of this legislature only for the purpose of permitting its acceptance or rejection by the legal voters of the town of Dover-Foxcroft at any annual or special town meeting legally called and held before the 1st day in April, 1940, an appropriate article being inserted in the call for such meeting

If a majority of the qualified voters of the town, present and voting, vote in favor of the acceptance of this act, it shall become operative. The town clerk shall forthwith file with the secretary of state a certi-ficate of the action of the town thereon.

Thereupon, House Amendment "A" was adopted, and the bill was given its third reading, passed to be engrossed, as amended by House Amendment "A" and sent up for concurrence.

Amend said Bill by striking out the comma at the end of the new matter in the ninth line from the end of said Bill and inserting in place thereof a period.

Further amend said Bill by indicating the striking out of the words in the ninth and eighth lines from the end of said Bill "at the same time" and inserting in lieu thereof the words 'The county commissioners at the time the taxes provided by this section are assessed shall.'

Amend said Bill by striking out the following words at the end thereof: "and they shall publish a list of townships and tracts of land so assessed, with the sums so assessed on each, and the roads on which it is to be expended, in some paper printed in the county where the lands lie, 3 weeks successively, the last publication to be within three months from the date of the assessment."
