#### HOUSE

Friday, February 24, 1939.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Gesner of Augusta.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

#### Senate Bill in First Reading

Bill "An Act to Permit Charles Hayden Foundation to be and become a Limited Partner in Hayden, Stone & Co. and to Authorize said Firm to Conduct Business under Said Name" (S. P. 62) (L. D. 35)

Bill read twice and tomorrow assigned.

From the Senate: Bill "An Act to Grant a New Charter to the City of Gardiner" (H. P. 632) (L. D. 266) which was passed to be engrossed in the House on February 22nd as amended by House Amendment "A".

Mr. MILLS of Farmington: Mr. Speaker, I would hesitate to oppose the acceptance of this report were it not for the fact this is a matter up in my own neck of the woods.

You have this morning considered legislation inexpedient on three salary increases in Franklin County. This particular one, which comes from the committee in a new draft with the report that it ought to pass, has some merit, but I think that there are others upon which legislation has been reported inexpedient in Franklin County which are just as meritorious.

A good deal of attention was given to this particular bill by one of our political guns in Franklin County. He is a good fellow, but this morning I am not on his firing line.

Up in Franklin County our peo-ple are making less than they were several years ago, and I feel that ninety-five per cent of the people up there do not want to raise the salaries. That has come to my at-tention walking down the street when I go home, because people speak of it repeatedly. I would feel I was shirking my duty if I sat here in my chair and saw this go by without raising my voice against it.

A matter like this, of course, concerns the County Commissioners; it is their business to look out for the money of the county and what is being spent. I expected all along at these hearings for salary in-creases in Franklin County that they would be coming down here and saying something about it, but they did not appear in any of the hearings, either in opposition or in favor of these salary increase prop-ositions. So last week I sent to them posthaste letters with restamped, and I thought that would surely get some answer out of them. I did not do it with any intention of putting them on the spot, but I thought it was their business and they ought to say something about it. I got two letters back, and the third I have not heard from.

If I am not trespassing on the time of the members, I would like to read a little from these two letters which I got. One of them says:

"Our Board is not unmindful of the fact that salaries paid County Officers in Franklin County is rather less than that paid in the other small Counties of the State, still we do not feel that conditions at the present time, warrant any general increase, and we do not think it would be fair for us to favor an increase for one or two, and not the others.

"I think that Mr. (Blank), our Chairman, will advise you of the stand we have decided to take in the matter, and I will say that we have made this decision unani-

Now from that I thought the Chairman was going to send me a statement one way or the other on these salary raises. This is what he said:

"I am in receipt of your letter of

February 17 and in reply to same will say that at the last regular meeting of the County Commissioners of Franklin County, due to the fact every official in the Court House was anxious for a raise in salary, the Commissioners decided they would not sign any papers for or against any raise of salaries.

#### Sincerely,

From the Chairman there is nothing on record one way or another, and the others say they are not in favor of any salary raises at this time. So I make the motion, Mr. Speaker, that this committee re-port be indefinitely postponed. The SPEAKER: The gentleman

from Farmington, Mr. Mills, moves the indefinite postponement of the report of the Committee on Salaries and Fees on H. P. 578, on Bill "An Act relating to Clerk Hire in the Office of Register of Deeds of Franklin County.'

The Chair recognizes the gentle-

man from Saco, Mr. Ford. Mr. FORD: Mr. Speaker, when this bill first came into the Committee, it seemed to have a rough voyage all the way through. At the hearing there were six members of the committee present. When we voted, three voted in the negative and two in the affirmative, one not voting.

It is not the attitude of your Committee on Salaries and Fees to be unfair with anybody. We have no desire to decrease the salary of anybody up in Franklin County.

The evidence that was presented to us was very limited. We did not receive a report from the Franklin County delegation, neither did we have any report from the County Commissioners, so it was on our own judgment that we voted as we did. Not wishing to see a divided report come into the House. I was one of the two who were instru-mental in getting that bill back to the committee, which we did, and suggested, after further it was deliberations—by the way, the let-ters that the member from Farmington, Mr. Mills, has read to you, we did not see those letters. We could only judge the merits of the bill from what evidence was pro-duced, and I think we voted fairly. However, after the bill came back, we thought we would be fair to we thought we would be fair to both parties and we gave them a raise of three dollars each, which meant a fifty-fifty proposition. I think that every man and woman in the Legislature would agree that was a very fair proposition.

It came to my attention yesterday that there were some politics back of this bill. That may be so or it may not be so, it matters not to me. But I think your Committee acted very wisely, and, on these grounds, I move the acceptance of the report.

Mr. RICHARDSON of Strong: Mr. Speaker, I rise to support the motion of the member from Farmington, Mr. Mills, for indefinite postponement.

I do not believe that this body should lose sight of the fact that two members of that Board of County Commissioners were present and in this building but on the wrong side of the door when this particular measure was heard by this Committee, not possessing, for some reason, the necessary intestinal fortitude to go on record.

I believe when we take this action we are merely saying that the people of Franklin County are to pay a certain amount for a certain service. The people of Franklin County are not in accord with any such move. I believe that we are here to represent them and not the chosen few who have assumed the right to speak.

Mr. FORD: Mr. Speaker, I still want to impress upon the minds of this House that we can only vote on the evidence that is given us. If the men were on the wrong side of the door, that was not our fault. Perhaps there are other members of the committee who would like to speak in behalf of the report.

Mr. DOWNS of Rome: Mr. Speaker, I am one of the committee who heard the evidence on this particular matter. That evidence was more or less conflicting, and it consisted more or less in whispered innuendos in the lobby rather than concrete evidence presented to the committee. For the purpose of harmony, as stated by the gentleman of the committee that matter came out of the committee as it did.

the committee, that matter came out of the committee as it did. I feel that it would be only fair to say at this time that this is a matter which concerns Franklin County alone, it concerns the taxpayers of Franklin County alone, and I do not believe that it matters very much to us as a whole, and I do not believe that the dignity of the Committee on Salaries and Fees

would be very badly affected if the motion of the gentleman from Farmington (Mr. Mills) prevailed.

The SPEAKER: The question before the House is on the motion of the gentleman from Farmington, Mr. Mills, that the report of the Committee on Salaries and Fees on H. P. 578 on Bill "An Act relating to Clerk Hire in the Office of Register of Deeds of Franklin County" be indefinitely postponed.

Mr. LAFLEUR of Portland: Mr. Speaker, I am not speaking by request and perhaps I will make myself disliked in this body this morning if I favor the motion of the gentleman from Farmington (Mr. Mills).

I am very much concerned at the present time that there are pending in this body at least ten or fifteen bills which would increase the salaries of certain officials in our counties and would increase the salaries of our judges and recorders.

This may be a county matter, but in my own county there is a bill pending before this body which would increase the salary of the recorder in one of our courts, and I find that the reason for the increase is apparently that the duties of the recorder have increased. I find upon investigation that the Judge of that court is here, lobbying in this present body. He is lobbying here for pay, and he turned the duties of his court over to his recorder, and the recorder wishes an increase in salary.

In the County of Sagadahoc, I understand that there is a bill to increase the compensation of the present judge. I ascertain on good authority that there are at least four hundred farmers in that county that cannot presently pay their taxes. Now there is a bill in this present Legislature which would send back to the towns a proportionate part of the cost of the oldage relief investigation and part payment thereof, and I hear from the towns and the counties that they are opposed to that measure on the ground that they cannot pay, and yet they come in here for an increase in pay.

There is a bill before this Legislature which would reduce the salaries of the State officials five percent, I believe. There is also a bill here that would reduce the working days from six to five days a week. There is also a bill which would

increase the compensation of the State Police. I would like to give to every man an increase in salary, but before we do that, gentlemen, we have got to pay our taxes at home. I stand upon this floor as an attorney-at-law opposing any increase to any judge or any recorder under the present conditions in this State. I hope that the motion of the gentleman from Farmington, Mr. Mills. prevails. (Applause)

The spectrum from Farmington, Mr. Mills, prevails. (Applause) The SPEAKER: The question before the House is on the motion of the gentleman from Farmington, Mr. Mills, that the report of the Committee on Salaries and Fees, "Ought to pass in new draft" and accompanying bill, H. P. 578, be indefinitely postponed.

Mr. LaFLEUR: Mr. Speaker, I would ask for a division of this House upon this very important question.

#### **Orders Of The Day**

Mr. PAYSON of Portland: Mr. Speaker, I move that the House take from the table the first unassigned matter, Memorial Memorializing the Postmaster General of the United States Relative to a Special Post-age Stamp in Honor of Captain Jeremiah O'Brien (H. P. 868) tabled on February 21st by accident in my name, without my knowledge and consent.

The SPEAKER: The gentleman from Portland, Mr. Payson, moves that the House take from the table the first unassigned matter. Memorial Memorializing the Postmaster General of the United States Relative to a Special Postage Stamp in Honor of Captain Jeremiah O'Brien (H. P. 868) tabled by that gentle-man on February 21st pending man adoption.

Mr. PAYSON: Mr. Speaker, I now offer House Amendment "A" with a brief explanation.

When this matter was considered by the Committee on Federal Relations, we were in an economy mood, and we decided to let the Post-master General read about our action in the newspaper, thinking that might be sufficient; but, on further consideration of the matter, we decided that perhaps it would be proper to mail him a copy. It is with some trepidation that I make this proposal now, because of the economy attitude this Legislature has shown, but I will say that one member of the House has already offered to pay the postage, if there is serious objection.

The SPEAKER: The Clerk will read House Amendment "A".

House Amendment "A" to H. P. 868 Memorial Memorializing the Postmaster General of the United States Relative to a Special Postage Stamp in Honor of Captain Jeremiah O'Brien.

Amend said Memorial by striking out all of the last paragraph, and inserting in lieu thereof the following

**RESOLVED**, That a certified copy of this Memorial be transmitted by the Secretary of State to the Postmaster General of the United States, and to each of the Repre-sentatives and Senators representing the State of Maine in Congress.

Thereupon, House Amendment "A" was adopted and the Memorial as amended was adopted.

Mr. RICHARDSON of Strong: Mr. Speaker, could I ask a question through the Chair?

Mr. SPEAKER: The gentleman may proceed.

Mr. RICHARDSON: Mr. Speaker. we did not understand from the Memorial whether that was to be transmitted by mail or taken in person.

The SPEAKER: The Chair will inform the gentleman that he has a printed copy of the amendment on his desk which he may consult and draw his own conclusions.

On motion by Mr. Brown of Eagle Lake, the House voted to take from the table the tenth unassigned matter, House Report, "Ought to pass in new draft under same title" of the Committee on Claims on Re-solve in Favor of Sylvia A. Martin of Eagle Lake (H. P. 1805) tabled on February 23rd by that gentleman pending acceptance; and on further motion by the same gen-tleman the report of the Committee was accepted.

On motion by Mr. Brown of Eagle way, the House voted to take from the table the eleventh unassigned matter, Bill "An Act to Incorporate the Town of Princeton Lighting District" (S. P. 184) (L. D. 235) tabled on February 23rd by that gentleman pending third reading.

Mr. Dow then offered House Amendment A and moved its adopoffered House tion.

House Amendment "A" to S. P. 184, L. D. 235, Bill, "An Act to In-corporate the Town of Princeton Lighting District"

Amend said Bill by adding thereto before the enacting clause thereof the following:

**'Emergency preamble.** Whereas, the present facilities for lighting the town of Princeton are liable to  $\operatorname{cease}$  to be available because of financial difficulties, and

Whereas, it is necessary that electric power be available for the town of Princeton, and

Whereas, a delay of 3 or 4 months might leave the said town without electric service, and

Whereas, in the judgment of the legislature these facts create an emergency within the meaning of section 16 of Article XXXI of the constitution of Maine and require the following legislation as immediately necessary for the preserva-tion of the public peace, health and safety; now, therefore

Further amend said bill by striking out the 1st sentence of section 8 thereof, and inserting in place thereof the following:

'This act shall take effect on approval by the governor for the purpose of permitting its accept-

ance or rejection by the legal voters of the town of Princeton at any annual or special town meeting legally called to consider the acceptance of this act; an appropriate article being inserted in the call for said meeting.'

Further amend said bill by adding at the end thereof the following:

'Emergency clause. In view of the emergency cited in the preamble, this act shall take effect when approved.'

Thereupon, House Amendment "A" was adopted, and the bill had its third reading, was passed to be engrossed as amended by House Amendment "A" in non-concurrence, and sent up for concurrence.

On motion by Mr. Fellows of Augusta, the House voted to take from the table the seventh unassigned matter, House Report, "Ought not to pass" of the Committee on Judiciary on Bill "An Act Relating to Pauper Settlements" (H. P. 503) (L. D. 157) tabled on February 23rd by that gentleman pending acceptance; and on further motion by the same gentleman the House voted to accept the "Ought not to pass" report of the committee and sent up for concurrence.

The SPEAKER: Are there any further matters that can be taken from the table?

Is there any other business to come before the House under Orders of the Day? If not, the Clerk will read the notices.
