#### HOUSE

Tuesday, March 7, 1939.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Wolsten-holme of Bath. Journal of the previous session

read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Bill "An Act to Provide Compensation for Indian Representatives to the Legislature" (S. P. 417) (L. D. 879) which was indefinitely postponed in the House on March 2nd in non-concurrence.

Comes from the Senate with that body voting to adhere to its former action whereby the bill was recommitted to the Committee on Salaries and Fees.

In the House:

Mr. HINMAN of Skowhegan: Mr. Speaker, I move the House adhere to its former action whereby it voted to indefinitely postpone this bill in non-concurrence.

The SPEAKER: The gentleman Mr. from Skowhegan, moves that the House adhere.

The Chair recognizes the member from Portland, Mr. McGlauffin.
Mr. McGLAUFLIN: Mr. Speaker,
I have no expectation of being able to change the vote of this House after you have so thoroughly beaten the proposition that I stood for a day or two ago, but I have been licked many times and then come

up again to fight. I want to tell a

When I was about seventeen years old, I engaged to work for a farmer during the haying season for the sum of twenty dollars per month. We happened to have exceedingly good weather, and we got our haying all done in seventeen days. During that time I pitched on every load of hay that went into that barn, and I pitched off the greater part of it. I will say to those of you who are not farmers that we consider pitching on and pitching off about the hardest part of the This farmer then informed me that he did not need my services any more, that I had worked seventeen days then and therefore he figured that he owed me thirteen dollars.

It so happened that I belonged to the local baseball team, and this club had engaged a place to play ball in this man's pasture; so this gentleman proceeded to take five dollars out of my thirteen to re-compense him for the baseball field, with which I had nothing to do ex-

cept being a member of the club.
And in the town in which I then lived they used to have what they called "store-pay," that is, if you could not get money they paid you at the store, and usually you would get about as much from the store for a dollar as seventy-five cents would buy in money.

So the settlement was made; I paid the five dollars for the baseball field, I got four dollars' worth of truck at the store I didn't want, and I got four dollars in money for my seventeen days' work. I thought then and I think now that that farmer was a mean man, and from that day to this I have hated a piker.

Now I come to this Indian proposition. I do not know why we arranged to have any Indians come here at all, but we did, and when they are here they should be entitled to some consideration.

The remark was made a day or two ago that they do nothing, they are mere figureheads. Well, what is the King of Italy but a mere figure-head? But he does not work for nothing.

I understand that the reason that the Indians do not come here is because they cannot afford to come here. I can well believe that. I have never been able to save a cent by coming to this Legislature myself, and up to date I have been out of pocket every time.

Now I think from the very fact that we allow those Indians to come here, that we should pay them enough so that they can afford to come here if we do not any more than look at them. I think that they should be given some consideration. I have said in this House before, and I am saying it again: I do not like this matter of throwing things out of the window without any consideration of their merits.

I am informed by Senator Kennedy this morning that he wants to put in an amendment cutting down the amount that will be paid the Indians but paying them something. Therefore, I do not like to see this matter killed in the way that it will be done if the motion of the gentleman from Skowhegan (Mr. Hinman) prevails, because it kills the bill right there. I am against killing this bill until we have given it further consideration. And one of the things that surprises me is that the gentleman from Skowhegan, Mr. Hinman, one of the most generous men you can find anywhere, a splendid fellow, has got his teeth in the bone of economy so far that he even cannot do justice to anything. I hope the motion of the gentleman from Skowhegan (Mr. Hinman) does not prevail.

Mr. MILLS of Farmington: Mr. Speaker, I hove that we recede and concur.

The SPEAKER: The Chair recognizes the gentleman from Skowhegan, Mr. Hinman.

Mr. HINMAN: Mr. Speaker, if orderly, straightforward, sound business procedure constitutes to any degree being somewhat of a piker, I

submit to being guilty.
You must remember that the Committee on Appropriations and Financial Affairs has given this matter consideration not only this year but in every session of the Legislature, and it is very much of a question whether or not, instead of recommending \$200 for the Indians, when we compare their service with that which the rest of us are expected to render, we should not cut them to \$125. But that committee has wanted to be charitable, it has felt that it was an established custom; they have not felt that the Indians were necessarily entitled to \$200, but they have felt that it was a

nice gesture and that the State was going as far as it should go. I submit to the members of this House: If there is any soundness in allowing this bill to go along and pay the Indians as much as we members who are rendering continuous service, then I agree I do not know what soundness is.

I will simply say this as to my false economy: It is the first time in my lifetime that I have ever been accused of trying to proceed on any such basis. However, I think perhaps it is all right to have that attached to you in these days. Although I do not look upon my move as false, I think it is sound, and I think before we go home this Legislature is going to agree that perhaps it is sound to cut our expenses as much as we reasonably can. I submit it is entirely reasonable, and that if we allow the amount that the Committee on Appropriations passed in the early days of this Legislature we have done everything we should be expected to do, and it would be decidedly unsound if we took any other course.

I move the previous question, Mr. Speaker.

The SPEAKER: The gentleman from Skowhegan, Mr. Hinman, moves the previous question. In order for the Chair to entertain the motion for the previous question it requires the assent of one-third of the members present. As many as are in favor of the motion will rise and stand until counted and the Monitors will make and return the count.

A division of the House was had. The SPEAKER: Obviously more than one-third of the members having arisen, the previous question is ordered. The question is, shall the main question be put now? Only the question of putting the main question now is debatable. All those who are in favor of putting the main question now will say aye; those opposed no.

A viva voce vote being taken, the motion that the main question be now put prevailed.

The SPEAKER: The motion of the gentleman from Farmington, Mr. Mills, that the House recede from its former action and concur with the action of the Senate takes precedence over the motion of the gentleman from Skowhegan, Mr. Hinman, that the House adhere. The question now before the House is on the motion of the gentleman

from Farmington, Mr. Mills, that the House recede from its former action whereby it indefinitely postponed Bill "An Act to Provide Compensation for Indian Representatives to the Legislature" (S. P. 417) (L. D. 879) and concur in the action of the Senate whereby the bill was referred to the Committee on Salaries and Fees.

Mc McGLAUFLIN: Mr. Speaker,

Mc McGiriot I ask for a division. The gentleman The SPEAKER: The gentleman from Portland, Mr. McGlauflin, asks for a division. All those in favor of the motion to recede and concur will rise and stand in their places until counted and the Monitors will make and return the count.

A division of the House was had. Twenty-nine having voted in the affirmative and 93 in the negative,

the motion did not prevail.

The SPEAKER: The question now before the House is on the motion of the gentleman from Skowhegan, Mr. Hinman, that the House adhere to its former action. All those in favor of the motion will say aye; those opposed no.

A viva voce vote being taken, the

motion prevailed.

The SPEAKER: The Clerk has in his possession a communication from the Legislature of another State, which, if there is no objection, he will read.
