Friday, March 10, 1939.

The House met according to adjournment and was called to order by the Speaker.

by the Speaker. Prayer by the Rev. Mr. Hughes of Augusta.

Journal of the previous session read and approved.

• Papers from the Senate disposed of in concurrence.

Senate Bill in First Reading

Bill "An Act relative to Enforcing the Collection of Real Estate Taxes by the Alternative Method" (S. P. 219) (L. D. 288)

(S. P. 219) (L. D. 288) Bill had its first two readings. Senate Amendment "A" was read by the Clerk and adopted in concurrence, and the bill as amended was assigned for third reading the next legislative day.

From the Senate: Resolve in favor of Samuel J. Dana, Representative of the Passamaquoddy Tribe of Indians (H. P. 452) (L. D. 390) which was passed to be engrossed in the House on February 9th.

Comes from the Senate, passed to be engrossed as amended by Senate Amendment "A" in non-concurrence.

In the House: Senate Amendment "A" was read by the Clerk.

Mr. HINMAN of Skowhegan: Mr. Speaker and members of the House: In order that there may be ne misunderstanding about just what is intended here, I want to mention the fact that the \$200 referred to is the original bill, which the Committee on Appropriations and Financial Affairs very early in this session passed for acceptance by the two branches and which now is in the stage of engrossment, as I understand it, and is the regular amount which they have had.

This amendment is an attempt to change that original amount on which they have already drawn part of their pay, at least, to four hundred dollars. In order that we may handle this fairly, I would make the motion that we insist on our former action and ask for a Committee of Conference.

The SPEAKER: The gentleman from Skowhegan, Mr. Hinman, moves that the House insist on its former action and ask for a Committee of Conference. The Chair recognizes the gentleman from Portland, Mr. McGlauffin. Mr. McGLAUFLIN: Mr. Speaker,

Mr. McGLAUFLIN: Mr. Speaker, I once heard a story of a boy reading his lesson in school from the Book of Daniel and he came across the words Shadrach, Meshach and Abednego and he could not pronounce the words, so the teacher helped him over the situation. The next day they had a review lesson, and this boy was called upon to read that same paragraph, and when he got to those three words, in holy horror he put up his hand and said: "Teacher, there is them three fellows again." (Laughter)

Mr. Speaker, I thought this Indian question was settled, but I find that here are these Indians again. I have on two occasions defended their position and I am now obliged to do so once more.

Mr. Speaker, I ask permission to face the House.

The SPEAKER: The gentleman has permission.

Mr. McGLAUFLIN: Mr. Speaker, I want to speak in a somewhat lighter vein than I am accustomed to speak in this House.

Some of the newer members talking with me early in the session—I wanted to give them good advice and I told them that a little later there would be discussions on the floor of this House and that they should watch out to see whether the remarks that were made seemed to be in accordance with reason and with logic, and if they were not, if they were mere eloquence or hot air, to disregard them. I find that those men have followed my advice somewhat in voting on this question, because I must admit that I am strong on sentiment but exceedingly weak on argument. That being the case, I find it is necessary, in order for me to win out for these Indians, to get the gentleman from Skowhegan, Mr. Hinman, on my side, and now I propose to try to do it.

When I was a boy about fifteen years old, I started up to the little country school-house in the town of Mapleton one day and I passed a schoolmate of mine by the name of Charlie, and Charlie was walking along with two young girls. I passed him and as I did so, I said: "Hello, Charlie," and he answered: "Hello, Chif." When I got by about seven or eight feet, Charlie sud-denly left the two girls, stepped up and struck me right between the shoulders with his fist. And, being redheaded and quick-tempered, I immediately attacked Charlie and I got him down and held him on the sidewalk so that he could scarcely move, and he looked up and said: "What is this, a fight or a wrestle?", and I said: "You say," and he very wisely said: "Let's call it a wrestle."

Now, Bill has me down and has got the House on top of me so that I can't move. (Laughter) Under those circumstances where I can't do anything better, I am proposing that we make a compromise. and the compromise is this: If you will vote for this \$400 provision, I will agree to call it a wrestle. (Laughter)

Now if you recall the remarks that I made the other day on this question when I roasted you as much as I dared to, I also said that you were one of the most generous men in this House. Now let us prove it this morning by your coming in with me.

It is necessary for me to get an-other member of this House on my side, and that is my friend, the gen-tleman from South Portland, Mr. Mr Hinckley. If you noticed in the remarks made yesterday, I think, by the gentleman from South Portland, Mr. Hinckley, he had this matter of the tomahawks and the scalpingknives on his mind. It showed to me that he has been having a night-mare, that his conscience is troubling him, and if he wants to have a clear conscience he should come in and vote with the gentleman from Skowhegan, Mr. Hinman, and he will have a clear conscience when we vote for this \$400.

Now I noticed that there were cuite a number of men here, and some women, who voted against my position the other day, and to those I want to say that as Chairman of the Committée on Leave of Absence, when we take this vote I will readily excuse you until after this vote is taken. (Laughter)

Now that we have got everything harmonious, I propose that the gen-tleman from Berwick, Mr. Varney, shall tell this House just how the Indians got here anyway. He knows all about it. And then, to make it still more interesting, we might have a few remarks from the gentleman from Rockland, Mr. Sleeper,

who will tell us about the recent "Battle of Clam Chowder," and then we can close the session most harmoniously by all uniting in the song, "Bringing in the Sheaves." (Laughter)

By the way, I leave this matter of putting the motion in the hands of the gentleman from Skowhegan, who of course is going along with me. (Laughter)

Mr. SLEEPER of Rockland: Mr. Speaker, I hesitate to rise, because we all have been feeling pretty good about it. But the question at hand is more serious than that. The House has in a very definite manner three times shown how we felt on this bill, and it is getting to be. Mr. Speaker and members, almost of an insult, the way this bill keeps pop-ping up. We are all over twenty-one and we all know our own minds, and just because somebody wishes to make a football of this thing, Mr. Speaker, if I could mention another body-

The SPEAKER: The Chair will remind the gentleman of the rule.

Mr. SLEEPER (Continuing): I cannot mention it. (Laughter) But I will say that all is not gold

that glitters, and perhaps every-thing is not as sincere as it might be. I trust that the motion of the gentleman from Skowhegan (Mr. Hinman) will prevail, and that this House will insist upon its former action, and, if necessary, ask for a Committee of Conference.

The SPEAKER: The question before the House is on the motion of the gentleman from Skowhegan, Mr. Hinman, that the House insist on its former action and ask for a Committee of Conference. Is this the pleasure of the House?

The motion prevailed. The SPEAKER: The Chair will name on the Committee: The gen-tleman from Bangor, Mr. Whitney, the gentleman from Skowhegan, Mr. Hinman, and the gentleman from Rockland, Mr. Sleeper.

The gentleman from Rockland, Mr. Sleeper, now moves that the Resolve be sent forthwith to the Senate. Is this the pleasure of the House?

The motion prevailed.
