#### Wednesday, March 15, 1939.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Webber of Hallowell.

Journal of the previous session read and approved.

Papers from the Senate disposed of in concurrence.

On motion by Mr. Noyes of Franklin, out of order and under suspension of the rules, the House voted to reconsider its vote of yesterday on Bill "An Act relating to Taxation of Radios" (H. P. 1835) (L. D. 1001).

The SPEAKER: This bill having had its three several readings in the House and having been passed to be engrossed and having had its two several readings in the Senate and having been passed to be engrossed and having been reported by the Committee on Engrossed Bills as truly and strictly engrossed, is it now the pleasure of the House that the bill be passed to be enacted? Mr. COWAN of Portland: Mr.

Mr. COWAN of Portland: Mr. Speaker, I move that Bill "An Act relating to the Taxation of Radios" lie on the table pending its passage to be enacted.

Mr. NOYES: Mr. Speaker, I ask for a division.

The SPEAKER: The gentleman from Franklin, Mr. Noyes, asks for a division. All those in favor of the motion of the gentleman from Portland, Mr. Cowan, that the bill lie on the table pending passage to be enacted will rise and stand in their places until counted and the Monitors will make and return the count.

A division being had,

Twenty having voted in the affirmative and 64 in the negative the motion to table did not prevail.

The SPEAKER: The question now before the House is on the passage of the bill to be enacted. This is an emergency measure and requires for its passage the affirmative vote of two-thirds of the entire elected membership of the House. All those in favor of the passage of the bill to be enacted will rise and stand in their places until counted and the Monitors will make and return the count.

A division of the House was had. Ninety-two voting in the affirmative and 3 in the negative, 92 being less than two-thirds of the entire elected membership of the House, the bill failed of passage.

Mr. MacNICHOL: Mr. Speaker, on this bill relating to the School Board of the City of Eastport, I did not have a chance to take care of the objection that was brought up in committee. However, since that time I have taken care of the objection with an amendment which meets all the objections to the bill and, as the bill is purely local in character, and provides that the City of Eastport shall grant a referendum on the question of whether there shall be a change in the charter to provide for the appointment of the School Board, I move to substitute the bill for the report.

The SPEAKER: The gentleman from Eastport, Mr. MacNichol, moves that Bill "An Act Relating to the School Board of the City of Eastport" (H. P. 563) (L. D. 196) be substituted for the "Ought not to pass" report of the committee. Is this the pleasure of the House?

Mr. DWINAL of Camden: Mr. Speaker, I think I can speak for the committee when I say that I believe this proposed amendment, if adopted, provided the bill is substituted for the report would remove most of our objections. As you will see, if you read this amendment, this election for the ratification of this proposed bill will be held on a regular state election day so that it will remove any expense connected with the ratification thereof. In the second place, we felt since the State of Maine has had to take over the City of Eastport temporarily that they should have complete control of the schools. If this amendment were adopted, it would not take effect until after the State had returned the management of the City to the citizens thereof. For those reasons, I think I am speaking for the committee as well as myself in saying that it does remove our objections.

The SPEAKER: The question before the House is on the motion of the gentleman from Eastport, Mr. MacNichol, that the bill be substituted for the report. Is this the pleasure of the House?

The motion prevailed and the bill was substituted for the "Ought not to pass" report.

On motion by Mr. MacNichol, under suspension of the rules, the bill was given its two several readings.

Mr. MacNichol then offered House Amendment A and moved its adoption.

The SPEAKER: The gentleman will recall that the pending question is on the motion to table. Mr. COWAN: Mr. Speaker, I wish
