Orders of the Day

The Chair lays before the House and unassigned matter, Bill "An Act Relating to Advertising Liquor, Malt Liquor, Wines and Spirits" (H. P. 2166) (L. D. 1135), tabled on April 14th, by Mr. Mills of Farmington, pending passage to be engrossed in concur-rence; and the Chair recognizes that gentleman.

Thereupon, Mr. Mills offered House Amendment "A" and moved its adoption.

House Amendment "A" to H. P. 2166, L. D. 1135) Bill, "An Act Re-lating to Advertising Liquor, Malt Liquor, Wines and Spirits." Amend said Bill by inserting in the eleventh line after the word "any" the word 'other.'

Thereupon, House Amendment "A" was adopted, and the bill as amended by House Amendment "A" was passed to be engrossed in nonconcurrence and sent up for concurrence.

The SPEAKER: The Chair is expecting an additional communi-cation from the Senate, and the House may be at ease.

House at Ease

The House was called to order by the Speaker.

At this point a message was received from the Senate, through its Secretary, proposing a Joint Con-vention of both branches of the Legislature to be held forthwith in the hall of the House of Representatives for the purpose of extending to His Excellency, Governor Barrows, an invitation to attend the Convention and make such communication as he may be pleased to make.

On motion by Mr. Varney of Berwick, it was voted to concur with the Senate in the proposal for a Joint Convention, and the Clerk was charged with and conveyed a message to the Senate informing that body that the House concurred in the above proposition for a Joint Convention.

At this point the Senate came in and a Joint Convention was formed.

In Convention

The President of the Senate in the Chair.

On motion by Senator Laughlin of Cumberland, it was

ORDERED, that a committee be appointed to wait upon His Excellency, the Governor, and inform him that the two branches of the Legislature are in Convention assembled, ready to receive such communication as he may be pleased to make.

The Chairman appointed as members of such committee: Senators Laughlin of Cumberland, Hill of Cumberland, Burns of Aroostook; Representatives Weatherbee of Lincoln, Varney of Berwick, Bird of Rockland, Dorsey of Fort Fairfield, Thorne of Madison, Hinckley of South Portland, Payson of Portland.

Senator Laughlin subsequently reported that the committee had discharged the duty assigned it, and that the Governor was pleased to say that he would attend the Convention forthwith.

Thereupon, Governor Barrows, attended by the Executive Council, entered the hall of the House, the audience rising and applauding.

The CHAIRMAN: I present His Excellency, Governor Barrows.

It would seem appropriate to mention that we assembled here January 4th last, each determined to consider only such measures as were designed to promote the public peace, health, and safety of our people.

Realizing now, as then, that it is only the duty of the Executive to recommend for your consideration such measures as seem expedient under prevailing conditions, my appearance here at this time is only for that purpose.

Before proceeding further, however, I wish to commend most emphatically the efforts of the members of this Legislature.

Each one of us was elected to our respective positions by the citizens of this State last September, on the promise to the people that new taxes would not be enacted to add to the already overburdened taxpayer. Apparently that declaration met with favor and it is further apparent that you have now progressed to a point in your deliberations where every citizen must admit you have adhered to your pre-election promise. On the other hand, we have been

On the other hand, we have been confronted with emphatic, but undoubtedly sincere, demand to expand activities already established and which we are likewise committed to within the limitations of our resources.

To maintain our existence, keeping expenditures within our income, has been an individual problem, to many of us at least, that is not at all new. But to find the acceptable solution this year as far as the State is concerned has seemed for a long time insurmountable without substantial new revenue—another way of saying new taxes.

I believe you think as I do—that our people will not subscribe to new taxes.

Referring to my first message to you on January 5, 1939, the receding revenue situation was alluded to and the statement made: "That it is increasingly necessary to adhere to the provisions of our respective Party platforms—render all possible service to our people within the limit of our present resources." Each succeeding day of this session appears to bear out that prediction.

Last week the Committee on Appropriations and Financial Affairs rendered to you their initial report which followed various reports of your Economy Committee, so-called. I trust you have not failed to analyze the report filed last week by the Appropriations and Financial Affairs Committee to better appreciate how painstakingly it was prepared and how effective it is. It may not be amiss to point out that total appropriations approved the by the Committee for the biennium. exclusive of Old Age Assistance and Highways was \$20,930,280. This Highways, amount represents a figure of \$880,-000 under the current appropria-tions for the years 1938-1939. It represents a reduction from the amount requested by the various departments and institutions of \$2,-175,000, and lastly, it represents a reduction from the original budget estimates of over \$400,000.

Undoubtedly this achievement will be met with acclaim by the citizens of this State and may I not be the first to compliment you and say: "Thank you for your untiring efforts!"

In passing, it will interest you to know that for the second year in succession this administration has not found it necessary to negotiate any part of our temporary borrowing capacity in anticipation of taxes.

Faced, as we are, with almost certain increased direct taxation from the Federal Government during the present session of Congress or the transfer of activities to the states which will result in the same thing, our course, as I see it, is to con-tinue to practice the strictest economv.

Notwithstanding our work thus far we recognize our "jot" is not yet completed.

t completed. We of the majority party are pledged to this declaration: "We subscribe to Old Age Assistance as now lawfully established and pledge its further development as rapidly as circumstances warrant." I interpret that to mean our citizens desire to continue this worthy activity on a "pay-as-you-go" basis—expand it if possible but not by imposing new taxes. I further believe the efforts to date of this Legislature truly reflect this impression.

Referring again to the report of the Appropriations Committee, you will note that after sufficiently providing for all our departments and institutions there is available the sum of \$962,762 the first year and \$780,862 the second year, or \$1,743,-624 for the biennium that you may allot exclusively for payment of Old Age Assistance. Necessary estimated amounts for administrative costs and burial expense have been included as has additional progress been made in educational equalization.

Our paramount problem then is to devise a plan to carry on the payment of Old Age Assistance that is You should plainly realize that \$1,-743,624, the total estimated available cash in the treasury for the next biennium for that purpose, would merely provide Assistance for 7.000 of our aged and deserving people. I do not feel that such a curtailment would be satisfactory to any one. Hence, some additional funds are necessary to be allotted to en-able adoption of a program that corresponds with our promises, without new taxation. You may call it a compromise program if you will, but it should be a reasonably satisfactory program for the ensuing two years.

As our Old Age Assistance program is expanded there is no reason to believe that it will not substantially decrease the burdens which cities and towns in many instances might otherwise be required to as-sume. Therefore, in view of that fact, I would ask that the cities, towns and plantations be willing to assume a proportionate share, quarter of the Assistance paid. one

Furthermore, it can be accomplished without cities, towns and plantations being assessed any additional taxes because I realize full well the tremendous burden they now carry.

To consummate this plan I sug-

gest the following procedure: Apportion from the General Highway Fund \$800,000 per year for the next two years. The amount is ap-portioned to be expended in the towns for highway purposes under the direction of the State Highway Commission. This money could be used by the towns in matching State funds such as State Aid Construction, maintenance of State and State Aid Highways, bridge con-State and struction and snow removal.

In the event the amount so received by a city, town or plantation, is in excess of their needs for any of the above mentioned activities, the surplus may be used for other local highway purposes under the direction of the State Highway Commission. Such amounts as would be received by a city, town or plantation, and used for highway purposes under the direction of the State High-way Commission, would not be a diversion of highway funds as defined under the Hayden-Cartwright law. And, furthermore, this proposal can be consummated without the necessity of increasing either the State tax or local taxes for the next two years and result in a program that should provide for approximately 14,000 cases, if conservative estimates of receipts are maintained.

To determine under this plan how the allocation is arrived at, it is necessary to divide the amount of \$800,000 by the total valuation of the State, exclusive of wild lands as established by the State Tax Assessor, or \$617,196,246. For quick compilation, to determine that amount for your town multiply the State valuation of your town by .0013 (1 3/10 mills). The result will be the amount your town will be asked to contribute and the same amount will be received for local highway purposes. Thus the various local highway programs will in no way be curtailed and it will not be necessary to disturb our State highway laws.

The charge that bonds are pro-posed to be sold to finance Old Age Assistance cannot be substantiated by this plan. It is not true because bond money can only be used on the State Highway System under existing laws. It does, of course, decrease State Highway construction to the extent of \$800,000, but in my opinion the total program will not be curtailed to any such figure because present highway receipts will apparently run greatly in excess of original estimates. In other words, I do not feel that the net difference of the size or amount of highway construction program of the State will be in any greater ratio than every other department has been asked to assume during this period.

Reduced to its simplest terms it merely seeks to establish for the next two years a joint cooperative effort between municipalities and the State. I believe the plan is worthy of your favorable consideration and adoption because it will not cripple certain State services or necessary functions in any way; it will not curtail local highway work; it will not create local unemployment and will not create any necessity for increased taxes nor require either of us to nullify our promise to the people of Maine.

In conclusion, Mr. President and Mr. Speaker, I recognize the determination of the members of this Legislature to expedite their deliberations. In addition, it is my continued desire to assist education and render Old Age Assistance as far as possible within our present resources without additional taxes. To that end, I have caused to be prepared the necessary bill to consummate the program I have discussed. It will be made available to either of you at once if you request it, or if my plan meets with the response of the members of your respective branches. (Applause)

At the conclusion of the address the Governor and Council withdrew amid the applause of the Convention, the audience rising.

The purpose for which the Convention was assembled having been accomplished, the Convention was dissolved and the Senate retired to its chamber, amid the applause of the House, the members rising.

In the House

The House was called to order by the Speaker.

Mr. Stilphen of Dresden, out of order and under suspension of the rules, presented the following order and moved its passage:

and moved its passage: ORDERED, the Senate concurring, that the Committee on Ways and Bridges be authorized and empowered to originate and report bills and resolves which, in the judgment of that committee, may be necessary or advisable to carry out the recommendation of the Budget Message or effect a reduction in State expenditures.

This Order shall not be interpreted to hinder or impede the authority previously given to the Committee on Appropriations and Financial Affairs by a similar Order.

The Order received passage and on further motion by Mr. Stilphen, was sent to the Senate forthwith.

The SPEAKER: Is there any further business to come before the House under Orders of the Day? If not, the Clerk will read the notices.

The Chair will call the attention of the members to the proposed bill which has been distributed and is on the members' desks, and which the Chair understands will probably be introduced in one branch or the other tomorrow morning.
