**SENATE**

Wednesday, January 11, 1939.

The Senate was called to order by the President.

Prayer by the Reverend William R. Wood of Augusta.

Journal of yesterday read and approved.

Paper from the House disposed of in concurrence.

The following bills were received and on recommendation by the Committee on Reference of bills, were referred to the following committees:

**Judiciary**

Mr. Sanborn of Cumberland presented bill "An Act to Grant a New Charter to the Alumni Association of Bates College." (S. P. 50)

Mr. SANBORN of Cumberland: Mr. President, I move that this bill be laid on the table pending reference, and that for this reason, that if it did contain an endorsement recommending a reference and printing it was by inadvertence. It is a matter which I can conceive is of no public interest whatever and I can see no occasion for printing. As far as reference is concerned I am perfectly content to accept any reference the Committee may see fit to give it. I therefore move that it be laid upon the table pending reference.

Thereupon, the bill was laid upon the table pending reference to a committee.

The same Senator presented bill, "An Act Relating to the Practice Before Probate Courts." (S. P. 51)

**Public Health**

Mr. Burns of Aroostook presented bill, "An Act Relating to the Qualifications, Residence, and Practice of Dentists." (S. P. 52)

**Orders**

On motion by Mr. Friend of Somerset, it was

Ordered, that the use of the Senate Chamber be granted to the Committee on Ways and Bridges for

public hearings on Wednesday and Thursday afternoons of each week, during the session, beginning Wednesday, January 25th, 1939, and excepting Thursday afternoon, January 26th.

On motion by Mr. Graves of Hancock, it was

Ordered, that the Committee on Claims be granted the use of the Senate Chamber for public hearings each Tuesday during the session starting January the 7th, 1939 and each Friday during the session starting February the 17th, 1939.

**Orders of the Day**

On motion by Mr. Spear of Cumberland the Senate voted to take from the table An Act to Protect the Right of Employees to Organize and Bargain Collectively; and Creating a Labor Relations Board (S. P. 34) tabled by that Senator on January 10, 1939 pending reference; and on further motion by the same Senator the bill was referred to the Committee on Labor.

Sent down for concurrence.

On motion by Mr. Graves of Hancock the Senate voted to take from the table An Act Relating to Damages Done by Beaver (S. P. 27) tabled by that Senator on January 10, 1939 pending reference; and on further motion by the same Senator the bill was referred to the Committee on Inland Fisheries and Game.

Sent down for concurrence.

On motion by Mr. Sanborn of Cumberland the Senate voted to take from the table An Act to Grant a New Charter to the Alumni Association of Bates College (S. P. 50) tabled by that Senator earlier in today's session pending reference; and on further motion by the same Senator the bill was referred to the Committee on Judiciary without printing.

Sent down for concurrence.
