SENATE

Tuesday, January 24, 1939.

The Senate was called to order by the President.

The Secretary delivered the message and subsequently reported that he had performed the duty assigned to him.

Subsequently a message was received from the House by Mr Pease, its Clerk, concurring in the proposition for a joint convention for the purpose of extending an invitation to his Excellency the Governor to attend the Convention and make such communication as he may be pleased to make.

The Senate retired to the Hall of the House of Representatives where a joint convention was formed.
