On motion by Mr. Spear of Cumberland, the Senate voted to take from the table Memorial to the Congress of the United States Rela-

tive to Completion of the Quoddy Project (H. P. 238) tabled by that Senator on January 24 pending reference in concurrence; and on further motion by the same Senator, the Memorial was referred to the Committee on Federal Relations, in concurrence.

On motion by Mr. Kennedy of Hancock, the Senate voted to take from the table Resolve Proposing an Amendment to the Constitution to Provide for the Number of Senators, (H. P. 249) tabled by that Senator on January 24 pending reference in concurrence; and on further motion by the same Senator, the Resolve was referred to the Committee on Judiciary in concurrence.
