Mr. BURNS of Aroostook: Mr. President, in relation to this bill, I received this morning a communication from Judge Nadeau of the Northern Aroostook Municipal Court

and in this letter there was an amendment to this bill establishing the Van Buren Municipal Court. It is a little late at this stage of the proceedings to offer an amendment and I would rather not offer the proposed amendment unless I feel it is absolutely necessary. I have not had time to study it fully as yet, having only just received this communication, and for that reason I would like to have the bill laid upon the table.

Thereupon, the bill was laid upon the table pending passage to be enacted.

#### Orders of the Day

On motion by Mr. Osgood of Oxford the Senate voted to reconsider its former action, taken earlier in today's session, whereby bill, An Act Relating to the Milk Control Board (H. P. 1531) (L. D. 859) was referred to the Committee on Agriculture in concurrence; and on further motion by the same Senator the bill was laid upon the table pending reference in concurrence.

On motion by Miss Laughlin of Cumberland the Senate voted to take from the table bill, An Act Relative to Depositing Slabs, Edgings, Sawdust in Streams (H. P. 1589) (L. D. 864) tabled by that Senator earlier in today's session pending reference in concurrence. Miss LAUGHLIN of Cumberland

Mr. President, I move that this bill be referred to the Committee on Interior Waters. I really don't know what the Judiciary Committee has to do with it.

Thereupon, the bill was referred to the Committee on Interior Waters in non-concurrence.

Sent down for concurrence.

On motion by Mr. Dow of Franklin the Senate voted to take from the table bill, An Act to Require Annual Registration of Osteopathic Physicians (H. P. 708) (L. D. 261) tabled by that Senator on February 7th pending reference in concurrence; and on further motion by the same Senator the bill was referred to the Committee on Public Health in concurrence.

On motion by Mr. Burns of Aroostook the Senate voted to take from the table bill, An Act to Establish the Van Buren Municipal Court (S. P. 91) (L. D. 54) tabled by that Senator earlier in today's session pending passage to be enacted. Mr. BURNS of Aroostook: Mr.

President, on examining the amendment which Judge Nadeau of the Northern Aroostook Municipal Court mailed to me, I find that it has merit. On examining the charter of the Northern Aroostook Municipal Court, which was enacted by the legislature in 1911, I find that at that time the Northern Arocstook Municipal Court held terms at Fort Kent and at Van Buren and that the court alternated between those two towns in the transaction of civil business; and Section 11 reads as follows: "Terms of said court for the transaction of civil business shall be held as follows, to wit: In the town of Van Buren on the second Tuesday of the months of January, March. May, July, September and November at ten o'clock in the forenoon, and in the town of Fort Kent on the second Tuesday of the months of February, April, June, August, October and December at ten o'clock in the forenoon" and so on. And so from that the Senate will understand that every other month the court was held at Van Buren and alternated in the remaining months at Fort Kent, so that in establishing the Van Buren Municipal Court there was no pro-vision whereby the Fort Kent Municipal Court would hold civil terms on the second Tuesday of every month. And inasmuch as that court has considerable business this

amendment would clarify the situation and give the Van Buren Municipal Court the right to hold court every month of the year for the transaction of civil business. And inasmuch as the Van Buren Municipal Court was given that same right, namely, to hold court every month, it seems fitting and proper that this proposed amendment which Judge Nadeau has mailed to me should be added to this bill.

Thereupon, on motion by Mr. Burns of Aroostook, the rules were suspended and the Senate voted to reconsider its former action taken on February 8th whereby the bill as amended by Senate Amendment "A" was passed to be engrossed; and that Senator presented Senate Amendment "B" and moved its adoption:—

"Senate Amendment 'B' to Legislative Document 54, An Act to Establish the Van Buren Municipal Court. Upon this act becoming effective, terms of the Northern Municipal Court for the transaction of civil business shall be held on the second Tuesday of every month in the town of Fort Kent in the County of Aroostook at ten c'clock in the forenoon and said court may adjourn from time to time, and so much of Section 11 of Chapter 178 of the Private and Special Laws of Maine, 1911, creating said Northern Aroostook Municipal Court as gives said court jurisdiction to hold terms of court at Van Buren for the transaction of civil business is hereby repealed."

civil business is hereby repealed." Senate Amendment "B" was adopted; and on further motion by the same Senator, the bill was passed to be engrossed as amended by Senate Amendment "A" and Senate Amendment "B" in non-concurrence. Sent down for concurrence.
