# SENATE

Thursday, February 23, 1939. The Senate was called to order by

the President. Prayer by the Reverend Wm. R. Wood of Augusta.

Journal of yesterday, read and approved.

From the House:

Comes from the House, report accepted and the bill given its three several readings, and subsequently recommitted to the Committee on Motor Vehicles.

In the Senate, the bill was recom-mitted to the Committee on Motor Vehicles in concurrence.

The Committee on Judiciary on bill "An Act Relating to Raising Money to Maintain a Hospital in Washington County," (H. P. 910) (L. D. 315) reported the same in a new draft (H. P. 1776) (L. D. 944) under the same title and that it ought to pass.

The Committee on Legal Affairs on bill "An Act Relating to the Methodist Church," (H. P. 1175) (L. D. 492) reported that the same ought to pass.

The Committee on Motor Vehi-

cles on bill "An Act Permitting Revocation of Operator's License after Conviction for Manslaughter," (H. P. 935) (L. D. 325) reported that the same ought to pass.

The Committee on Public Health on bill "An Act Relating to Distribution of Patent Medicines," (H. P. 15) (L. D. 6) reported that the same ought to pass.

Which reports were severally read and accepted in concurrence, the bills read once and tomorrow assigned for second reading.

The Committee on Mercantile Affairs and Insurance on bill "An Act to Incorporate the Associated Hospital Service of Maine," (H. P. 931) (L. D. 322) reported that the same ought to pass.

Comes from the House, report read and accepted, and bill passed to be engrossed as amended by House Amendment "A".

In the Senate, the report of the committee was accepted in concurrence and the bill was given its first reading. House Amendment A was read and adopted in concurrence, and the bill as amended by House Amendment "A" was tomorrow assigned for second reading.

The Committee on Legal Affairs on bill "An Act Relating to Medical Examiners and Their Duties," (H. P. 29) (L. D. 22) reported that the same ought to pass.

Comes from the House, report read and accepted, and the bill passed to be engrossed as amended by House Amendments "A" and "B".

In the Senate, the report was accepted in concurrence and the bill was given its first reading. House Amendment B was read and on motion by Mr. Marden of Kennebec was indefinitely postponed in nonconcurrence. House Amendment "A" was read and adopted in concurrence and the bill as amended by House Amendment "A" was tomorrow assigned for second reading.

The same Committee on bill "An Act to Grant a New Charter to the City of Gardiner," (H. P. 682) (L. D. 266) reported that the same ought to pass as amended by House Amendment "A."

Comes from the House, report accepted and bill passed to be engrossed as amended by House Amendment "A."

In the Senate:

Mr. MARDEN of Kennebec: Mr. President, it has been brought to the attention of the Legal Affairs Committee that the form in which that measure was reported out should be corrected and for that reason may we ask, and I so move, that the matter be recommitted to the Legal Affairs Committee.

The motion prevailed and the bill was recommitted to the Committee on Legal Affairs in non-concurrence. Sent down for concurrence.

The same Committee on bill "An Act Relating to Assessment and Collection of Taxes," (H. P. 483) (L. D. 178) reported that the same ought to pass as amended by House Amendment "A."

Comes from the House, report accepted and bill passed to be engrossed as amended by House Amendment "A."

In the Senate, on motion by Mr. Chamberlain of Penobscot, tabled pending acceptance of the report in concurrence.
