SENATE

Monday, April 17, 1939.

The Senate was called to order by the President.

Prayer by the Reverend Wm. R. Wood of Augusta.

Journal of Friday, April 14, 1939, read and approved.

From the House:

Orders of the Day

Mr. CHASE of Washington: Mr. President, I have just discovered that there has been an error in the printing of Legislative Document 1099, An Act Relating to Clerk Hire in Certain Counties. I therefore move we reconsider our action whereby this bill was passed to be engrossed.

The motion prevailed and the Senate reconsidered its action taken earlier in today's session whereby An Act Relating to Clerk Hire in Certain Counties (H. P. 2072) (L. D. 1099) was passed to be engrossed.

Thereupon, on further motion by the same Senator, the bill was laid upon the table pending passage to be engrossed, and especially assigned for tomorrow.

On motion by Mr. Findlen of Aroostook, the Senate voted to reconsider its action taken earlier in today's session whereby An Act Relating to Salaries in Certain Counties (H. P. 2073) (L. D. 1100) was passed to be engrossed; and on further motion by the same Senator, the bill was laid upon the table pending passage to be engrossed.

On motion by Mr. Burns of Aroostook, the Senate voted to take from the table, House Report from the Committee on Judiciary; Majority Report "Ought to Pass in New Draft, same title"; Minority Report "Ought Not to Pass" on An Act Relating to the Publication of Legal Notices, Legal Advertising and Other Matter Required by Law to be Published in a Newspaper (H. P. 2226) (L. D. 1168) tabled by that Senator on April 13th pending acceptance of the minority "Ought Not to Pass" report in concurrence.

Mr. BURNS: Mr. President, for the purpose of offering an amendment, copy of which has been placed on the desks of the members of the Senate, I move the acceptance of the majority report "ought to pass" at this time, and will move to table it later.

Thereupon, the majority report "ought to pass in new draft" was accepted in non-concurrence.

Mr. Burns presented Senate Amendment "A" and moved its adoption:

Senate Amendment A to H. P. 2226, L. D. 1168, Bill "An Act Relating to the Publication of Legal Notices, Legal Advertising and Other Matter Required by Law to be Published in a Newspaper." Amend said bill by striking out all

Amend said bill by striking out all of said bill after the enacting clause and substituting in place thereof the following:

Publication of legal notices; regulated. To be qualified as a medium for the publication of legal notices, legal advertising and other matter required by law to be published in a newspaper, a newspaper, unless otherwise ordered by the court in the proceedings, must be published and printed in whole or in part in this state, or, where the law so requires, in whole or in part in the county where the notice is required to be published; must be printed in the English language; and must be entered as second class postal matter in the United States mail at the post office in the place of such printing and publication; providing that nothing herein contained shall be construed to alter or in any way affect the existing law governing the foreclosure of real estate mortgages, chattel mortgages, or any conditional sales contract, by publication.⁹

Thereupon, on motion by Mr. Burns, the bill and amendment were laid upon the table pending adoption of Senate Amendment "A" in non-concurrence.

On motion by Mr. Graves of Hancock, the Senate voted to take from the table, An Act Relative to Closed Time on Deer (H. P. 2099) (L. D. 1102), tabled by that Senator on April 13th pending assignment for second reading.

Mr. GRAVES: Mr. President, I now move the bill have its second reading at this time.

Thereupon on motion by Mr. Burns of Aroostook, the bill was laid upon the table pending assignment for second reading.

On motion by Mr. Chamberlain of Penobscot, the Senate voted to take from the table. An Act Relating to Guaranty of Titles of Motor Vehicles and to the Facilitation of the Recovery of Stolen Motor Vehicles (H. P. 2135) (L. D. 1123), tabled by that Senator on April 14th pending passage to be enacted; and upon further motion by the same Senator, the bill was passed to be enacted.

On motion by Mr. Beckett of Washington, the Senate voted to take from the table House Report from the Committee on Motor Vehicles "Ought to Pass in new draft under the same title" (H. P. 2059) (L. D. 1095) on bill An Act Relating to School Busses, tabled by that Senator on April 5th pending acceptance of the report in concurrence.

Mr. BECKETT: Mr. President, I nove acceptance of the committee report for the purpose of offering an amendment and in explanation of the same, I might say that this bill has been indefinitely postponed in the House but there are one or two safety features in the bill which the committee would like to retain at the request of the safety department of the Highway. This bill in the first instance started in to define school busses as equipment, met with objection in the House and those features it is wished to retain are simply the safety measures of the bill.

Thereupon, the report of the committee "Ought to Pass in new draft under the same title" was accepted in concurrence and the bill was given its first reading.

Mr. Beckett presented Senate Amendment A and moved its adoption:

"Senate Amendment A. Amend said bill by striking out all of Sections numbered 1, 2, 3 and 7 thereof. Further amendment said bill by renumbering those sections designated Section 4, 5 and Section 6, to be designated Section 1, Section 2 and Section 3 respectively.

Senate Amendment A was adopted and the bill as so amended was tomorrow assigned for second reading.

On motion by Mr. Sanborn of Cumberland, the Senate voted to take from the table bill, An Act Relating to the Registration and Operation of Motor Vehicles by Non-residents (S. P. 669) (L. D. 1175) tabled by that Senator on April 14th, pending passage to be engrossed; and on further motion by the same Senator, the bill was passed to be engrossed.

Sent down for concurrence.

On motion by Mr. Wentworth of York, the Senate voted to take from the table, Senate Report from the Committee on Appropriations and Financial Affairs, "Ought to Pass in New Draft" (S. P. 679) on bill, An Act to Appropriate Moneys for the Expenditures of State Government and for other Purposes for the Fiscal Years Ending June 30, 1940 and June 30, 1941 (S. P. 122), tabled by that Senator on April 14th pending acceptance of the report; and on further motion by the same Senator, the report of the committee was accepted and the bill was given its first reading and tomorrow assigned for second reading.

On motion by Miss Laughlin of Cumberland, the Senate voted to take from the table, House Report from the Committee on Judiciary, "Ought to Pass in New Draft" (H. P. 2170) under title "An Act Relating to Commitment of Juvenile Delinquents on bill, An Act Relating to Commitment of Female Juvenile Delinquents" (H. P. 1604) (L. D. 668), tabled by that Senator on April 13th pending acceptance of the report in concurrence; and on further motion by the same Senator, the report of the committee was accepted in concurrence and the bill was given its first reading.
