STATE OF MAINE EXECUTIVE DEPARTMENT Augusta

To the President and Members of the Senate

To the Speaker and Members of the House:

I herewith transmit for the consideration of the legislature memorandum received yesterday from the Commissioner of Health and Welfare with reference to the activity known as Aid to Dependent Children.

As the memorandum indicates, a slight revision in the existing State law apparently is necessary in order for the State of Maine to receive the maximum amount provided under Federal law.

If such a change were made it would appear that the State of Maine would benefit on existing cases to the extent of \$15,528 per year from Federal funds. Of this amount, present State funds would benefit to the extent of \$10,200 per year and municipal payments would benefit to the extent of \$5,300 per vear.

If, in the opinion of the legislature this is sufficient cause to consider an amendment to our existing law I trust the necessary legislation may be prepared and introduced.
