The SPEAKER: The Chair would take this opportunity of reminding the members that up to this point the Chair has had the responsibility relative to committees. Now that these appointments have been made, that responsibility rests upon the members of the House to a great extent. The Chair wishes to remind the members of the House that the door of the Speaker's office is open, and such advice and help as the Speaker can offer will be given the members.

The Chair also reminds the members that there are no short cuts

sound legislative enactment. to to solud legislative enactment. Legislative procedure provides for that. It also provides that the peo-ple of Maine are entitled to have certain notices relative to commit-tee hearings, at which they have a right to speak and be heard. So this morning the Chair would ask the committee about the out the the committee chairmen and the the committee chairmen and the members of all committees to recog-nize that the task of facilitating the work of this Legislature rests upon the members of this House. The Chair trusts that beginning with the second legislative week in February each committee chairman will file, of his own accord, a list of the bills and resolves referred to that committee, the number upon which hearings have been held and the number still to be heard. It is the Chair's desire—and the Chair believes that the members of this House agree that it is highly desir-House agree that it is highly desir-able—that the volume of matters coming out of committees should come out at an early date in order that there may not be the inevita-ble jam in the closing days or weeks of this session. The Chair would remind the members that upon their organization and upon the amount of work that they are real-bly willing to devote to this high rely willing to devote to this high re-sponsibility that is theirs, will that answer finally be determined. The Chair has confidence from the con-Chair has confidence from the con-tacts made with the members of this House individually, that they are inspired, one and all, by the magnitude of the task that is fac-ing them, and the Chair is satis-fied that the members of this House are going to meet the demends of are going to meet the demands of the people of Maine that this be a Legislature that gives sound consideration to every matter coming before it and with all haste that is consistent with sound government.

From the Senate: Communication from the Governor transmitting a communication presenting to the State of Maine additional land to be added to Baxter State Park, Mackworth Island located in Portland Harbor and also a trust fund of \$10,000. (S. P. 27)

munication from former Governor Percival P. Baxter were received out of order and under suspension of the rules, read and ordered placed on file in concurrence.

From the Senate: Bill "An Act Accepting from Percival Proctor Baxter the Conveyance and Deed of Gift of Twelve Thousand (12.000)Acres of Land in Township Five (5) Range Nine (9) W. E. L. S. Piscataquis County and the Conveyance and Deed of Gift of Mackworth Island in the Town of Falmouth, Portland Harbor, Casco Bay, and Estab-lishing the Mackworth Island Trust Fund." (S. P. 29)

Came from the Senate, received under suspension of the rules, given its several readings without reference to a Committee and passed to be engrossed.

In the House:

The SPEAKER: The Chair recognizes the gentlewoman from Ban-gor, Miss Clough.

Miss CLOUGH: Mr. Speaker, with respect to this bill, I propose making a motion to suspend the rules in order that the bill may be given its several readings and passed to be engrossed without reference to a committee. In this way, the bill may receive its two readings now and be assigned for tomorrow, thus giving the members of the House anopportunity to consider the bill in compliance with the request of Hon-orable Percival Proctor Baxter.

Mr. Speaker, I now move that the rules be suspended and that the bill be given its two several read-ings without reference to a committee and be assigned for third reading tomorrow morning.

The SPEAKER: The gentlewoman from Bangor, Miss Clough, moves that the bill be received, and under suspension of the rules be given its two several readings without reference to a committee, and be assigned for third reading tomorrow morning. Is this the pleasure of the House?

Thereupon, the motion prevailed. and the bill was received, and under suspension of the rules was given its two several readings and tomorrow assigned for third reading.

From the Senate:

The following Order:

ORDERED, the House concurring, that in order that the records of the gift by Percival Proctor Baxter to the State of Maine as Trustee in Trust of approximately twelve thousand (12,000) acres in township five (5) range nine (9) W. E. L. S. Piscataquis County (Baxter State Park), and the gift of Mackworth Island together with the ten thousand (\$10,000) Trust Fund given for said Island, be complete and in enduring form, the communication dated January 13, 1943 addressed by the said Baxter to the Honorable Sumner Sewall and the Honorable Senate and House of Representa-tives of the Ninety-first Legislature, together with the message of Governor Sumner Sewall transmitting the said communication to this Legislature, be printed in the laws of Maine for 1943 (S. P. 30)

Came from the Senate, read and passed.

In the House, was taken up out of order under suspension of the rules, read and passed in concurrence.

The SPEAKER: The Chair recognizes the gentleman from Rockland, Mr. Sleeper.

Mr. SLEEPER: Mr. Speaker, I now move that the House take a recess of thirty minutes in order that the chairmen of the various committees will be able to get together and organization and the formation of the committees may be posted, in order to expedite the matter of organizing those committees.

The SPEAKER: The gentleman from Rockland, Mr. Sleeper, moves that the House take a recess of thirty minutes in order that the chairmen of the various committees may confer at this time in order to arrange for the meeting places this afternoon, and post the notices therefor. Is this the pleasure of the House?

The motion prevailed, and the House recessed for thirty minutes.

After Recess 11:40 A. M. Called to order by the Speaker

From the Senate: The following Order

ORDERED, the House concurring, that there be paid to the members of the Senate and House as advances on account of compensation established by statute, the amount of seventy dollars (\$70) fortnightly, according to lists certified to the State Controller by the Secretary of the Senate and Clerk of the House respectively; and that the final pay rolls bear the approval of the Joint Standing Committee on Appropriations and Financial Affairs (S. P. 33)

Came from the Senate, read and passed.

In the House, taken up out of order under suspension of the rules, read and passed in concurrence.

The SPEAKER: The Chair understands that there is a vacancy on the Maine Commission for Interstate Cooperation as set up by the Legislature of 1939, and in accordance with the provisions of Chapter 250 of the Public Laws of 1939, the Chair now appoints the gentleman from Augusta, Mr. Cross, as a member of that Commission to fill the vacancy created by the fact that the former Representative from Dexter, Mr. Otto, is not now a member of this body.
