HOUSE

Thursday, January 14, 1943.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Aldrich of Augusta.

Journal of the previous session read and approved.

The following Communication:

"State of Maine Indian Island Old Town, Maine,

November 27, 1942.

Penobscot, ss.

To Whom It May Concern:

This is to certify that at the General Election of the Penobscot Tribe of Indians, held in accord-ance with Section 282, Chapter 1 of the Laws of Maine 1933, on the James Lewis vas duly elected as Repres ntative at the Maine Legislature for the term of two years, beginning with the first Wednesday of January, 1943, and ending with the first Tuesday of November, 1944.

The communication was received, read and ordered placed on file and ordered sent forthwith to the Senate.

Thereupon, at the request of the Speaker, the Sergeant-at-Arms conducted Mr. Lewis to the center aisle, for presentation, amid the applause of the House.

The SPEAKER: In accordance with the laws of our State, the several Indian Tribes in the State of Maine have authority under the law to be represented at the Legislature, their representatives sit-ting here, not as members of this body but rather to represent their people on questions in which they have a direct interest. Mr. Lewis is here representing the Old Town Indians, as the members of the House have already been advised by the communication just read.

The Chair takes this opportunity of welcoming you here, and trusts

that throughout the legislative days dealing with matters in which you have a direct interest will not only receive but welcome any advice and counsel that you can possibly give them. The members of this House welcome you here, Sir.

Mr. LEWIS: Mr. Speaker, I thank you.

Passed to be Engrossed

Bill "An Act Accepting from Percival Proctor Baxter 12,000 acres in T. 5, Range 9, W. E. L. S., Mackworth Island, Falmouth and Mackworth Island Trust Fund" (S. P. 29)

The Bill was reported by the Committee on Bills in the Third Reading, and was read the third time.

Miss CLOUGH: Mr. Speaker and Members of the House: The vision and generosity of the Honorable Percival Proctor Baxter in presenting to the State of Maine twelve thousand additional acres for the Baxter State Park fully commands the deepest appreciation of the entire citizenry of this State. The further gift of the beautiful and treasured Mackworth Island in Casco Bay, and additional gifts for the maintenance of this island further commands our gratitude. In a world at war these gifts must stand as symbols of that peace and happiness that we are all striving to attain. They are real evidences of the heights of generosity and beneficence to which man can attain.

Now, in behalf of the State of Maine, through its duly elected representatives, it is with sincere and deep thanks that we now acknowledge these gifts, in the spirit in which they are given, assuring our appreciation in this manner for the generosity and enduring friendship of the Honorable Percival Proctor Baxter.

Mr. Speaker, I now move that this bill be passed to be engrossed.
