Tuesday, February 9, 1943.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Fr. Bulkelev of Hallowell.

Journal of the previous session read and approved.

On motion by Mr. Grua of Livermore Falls, the following com-munications were taken up out of order and under suspension of the rules.

#### STATE OF MAINE Department of State

February 5, 1943.

To Harvey R. Pease, Clerk of the House of Representatives of the Ninety-first Legislature:

In compliance with Section 36 of Chapter 2 of the Revised Statutes, I hereby certify that in accordance with the provisions of Section 74 Chapter 8 of the Revised Statutes, a special election was held in the class towns of Van Buren and Grand Isle on February 2, 1943, for the purpose of electing a representative to the Ninety-first Leg-islature to fill the vacancy caused by the resignation of Elmer H. Violette of Van Buren; that at said election Wilfred J. Sirois of Van Buren, having received a plurality of all votes cast in said election according to a canvass of the returns received from the class towns of Van Buren and Grand Isle made by the Governor and Council under date of February 4, 1943, appears to have been elected a representa-tive to the Ninety-first Legislature.

IN WITNESS WHEREOF, I have caused the Seal of the State to be hereto affixed this fifth day of February in the year of our Lord one thousand nine hundred and forty-three and of the Independence of the United States the one hundred and sixty-seventh.
