Amend said bill by striking out in the 4th from the last line there-of the following words:

"who are members of"

and inserting in place thereof the following: 'in active service in.'

Committee Amendment "A" was adopted and the bill was assigned for third reading tomorrow morning.

An Act relating to Sale of Lands of Deceased Persons (H. P. 9) (L. D. 2)
Was reported by the Committee on Engrossed Bills as truly and strictly engrossed, passed to be enacted, signed by the Speaker and sent to the Senate.

The Chair recognizes the gentleman from Portland, Mr. Payson. Mr. FAYSON: Mr. Speaker, many of the members who voted against

this bill yesterday came to me and said they would be very glad to allow it to go along, if it had no application to their towns; but I advised the idea that we could make it applicable to cities and towns of over ten thousand population, thereby removing their objection, and at the same time giving those of us who need it what we seriously need

There is another amendment which I shall probably propose, which I think is unnecessary but which will do no harm in answering another question. I shall probably propose an amendment saying saying specifically that this authority has no power to pledge the credit of the municipality from which it emanates.

In order to give time to prepare these amendments, and perhaps give further consideration to this bill, I shall probably, at a later time move for recommitment, but at the present time I ask that the motion of the gentleman from Livermore Falls, Mr. Grua, lie on the table.

The SPEAKER: The gentleman from Portland, Mr. Payson, moves that the motion made by the gentleman from Livermore Falls, Mr. Grua—taat the House reconsider its action of yesterday whereby it in-definitely postponed Bill "An Act to Aid the Prosecution of the War by Providing for the Creation of the Local Agencies to Cooperate with the Federal Government in Making Housing Available for Persons Engaged in War Industries and by Granting Certain Powers to Public Bodies," (H. P. 23) (L. D. 9)—be tabled. Is this the pleasure of the House?

The motion prevailed, and the motion of the gentleman from Livermore Falls, Mr. Grua, for reconsideration of indefinite postponement together with the bill (L. D. 9), was so tabled.

The SPEAKER: The Chair recognizes the gentleman from Vassalboro, Mr. Hawes.

Mr. HAWES: Mr. Speaker, I move that H. P. 823, Bill "An Act Authorizing the Department of Health and Welfare to Regulate Public and Private Institutions" be taken from the table.

The SPEAKER: The gentleman from Vassalboro, Mr. Hawes, moves that the House take from the table

Bill "An Act Authorizing the Department of Health and Welfare to Regulate Public and Private Institutions" (H. P. 823) (L. D. 377). Is this the pleasure of the House?

The motion prevailed and the bill was taken from the table.

Mr. HAWES: I now yield the floor to the gentlewoman from Bangor, Miss Clough.

The SPEAKER: The Chair recognizes the gentlewoman from Ban-gor, Miss Clough. On motion of Miss Clough, the

bill was referred to the Committee on Welfare and sent up for concurrence.

The SPEAKER: Is there any other matter of business under Orders of the Day? If not, the Clerk will read the notices.
