The SPEAKER: The Chair recognizes the gentleman from Maple-

ton, Mr. Webber.

Mr. WEBBER: Mr. Speaker, may I have permission to address a few remarks to the House?

The SPEAKER: The matter is debatable.

Mr. WEBBER: Mr. Speaker, I come from a town which is dry and which has voted against the sale of liquor. We have tried to vote against it, whenever we have been permitted to do so, and have done so overwhelmingly by a vote of three or four to one in some cases. It happened at one time that after we had registered our vote in favor of temperance that we had a store put into our town. This seemed to me to be contrary to the spirit of the law, and I tried to get the information as to who made the application for it, and I was unable to obtain this information from the department concerned.

I have not had an opportunity to see the new draft of this bill, but I believe it permits the sale of liquor under some conditions in towns which have registered their desire to remain dry. I hope that the report is not going to be accepted, because I wish to go on record as doing all I can to keep liquor out of dry towns. If we keep away from the towns which are wet, and do not interfere too much with their law, the liquor interests ought to keep out of our dry towns.

I, therefore, move, Mr. Speaker, that Item 5 lie on the table pending acceptance of the Committee

Report.

The SPEAKER: Does the gentleman also move that the new draft

be ordered printed?

Mr. WEBBER: Mr. Speaker, yes, I will include the printing in my motion. It is my purpose to have the information in regard to it. It is not my desire to do anything underhanded, because I wish everything to have fair consideration.

The SPEAKER: The gentleman from Mapleton, Mr. Webber, moves that Item 5 be laid on the table pending acceptance of the Committee Report and that the New Draft be ordered printed. Is this the pleasure of the House?

Amend Section 1 thereof by striking out after the word "tolls" in the fourth from the last line thereof the words "in accordance with all acts of the Legislature relating thereto" and inserting in place thereof the words 'as hereinafter

provided'.

Further amend said Section 1 by adding at the end thereof the following: "Upon receiving such conveyances, the right to collect tolls shall thereafter be limited to the right to demand and receive a toll on all logs and lumber passing through Grand Lake Seboeis Dam, so-called, of 25c for each 1000 feet board measure and a toll on all logs and lumber entering the Seboeis River below the Grand Lake Seboeis Dam, and using stored water, of 12 1-2c for each 1000 feet board measure. In computing tolls for lumber cut in short lengths for stave or pulp material or similar

purposes, two cords shall be reckoned to constitute 1000 feet board measure.
